2. Name and address of the data protection officer

3. Purpose of using and processing personal data

- Personal data are being used and processed for administrative purposes (e.g.
 invitation/information to/about scientific meetings, information about the society's belongings,
 debit of the annual membership fee).
- Personal data (i.e. photographs) are being used for public relation purposes (e.g. publication on the STS web page or in scientific journals).
- Personal data (i.e. email addresses) are being used to circulate information/requests of individual members to all STS members.

4. Legal basis to the data processing

- Processing of personal data usually is based on the need to fulfil a contract according to article 6, par. 1b (DSGVO). The contract basically is the membership relation within the society.
- In the case data are collected that are not needed to fulfil the contract, data processing is based on an agreement according to article 6, par. 1b in conjunction with article 7 (DSGVO).
- The publication of personal data in the internet or in other publication organs occurs to ensure eligible interests of the society. The eligible interests of the society consist of informing the public about the societies' activities. In this context, personal data (e.g. photographs) are being published, e.g. attached to reports about the annual STS meetings.

5. Addressees of personal data

Bank account details are transferred to the Deutsche Bank AG, office Hannover, in order to enable the debit of the annual membership fee.

Email addresses are transferred to the distribution service agency Newsletter2Go GmbH, Berlin, in order to distribute the STS newsletter.

6. Duration of the storage of personal data

Personal data are being stored for the duration of the membership. After termination of the

membership the personal data are being stored for another 10 years according to the legal record retention periods and then deleted. In the period between termination of the membership and deletion of the personal data, the use and processing of the personal data is restricted.

 - the right to object a given agreement at any time, without denying the legality of the agreement to data processing until the time of objection
