



OFFER FOR PARTICIPATION IN THE EVENT

Autonomous Non-profit Organization "International and Comparative Law Research Center", represented by General Director Ekaterina Salugina-Sorokovaya, acting based on the Charter, hereinafter referred to as the "Contractor", hereby submits the present offer regarding the participation in the events organized by the Contractor in Moscow.

1. TERMS OF ACCEPTANCE

1.1. The terms of this Offer, if accepted, apply to any event announced on the Contractor's website at <https://iclr.ru/> and presupposed that the participation is confirmed by the respective Customer by registering on the website and making a payment.

This Offer is exclusively addressed to individuals. It is not intended for acceptance by legal entities.

1.2. The acceptance of this Offer shall be made in the form of filling in and sending by the Customer to the Contractor an application for the participation in the advertised event in the registration module on the Contractor's website and making a payment for the participation through the payment systems.

1.3. The acceptance deadline is no later than the day preceding the day of the scientific event. The Offer shall be terminated prematurely if the announcement of the event is removed from the Contractor's website (due to cancellation of the event, depletion of the hall capacity, etc.).

2. TERMS OF OFFER

2.1. The Contractor shall provide the Customer, who accepts this Offer, with the services in the form of an opportunity to participate as a listener in an event for which the Customer applies on the Contractor's website and meets the payment while accepting this Offer.

2.2. The place, time, theme, and program of the event, as well as the participation price, are indicated in the announcement of the event on the Contractor's website, which is regarded as an addition to this Offer concerning the relevant event. The Customer, who has applied for the participation in the relevant event and paid the price, is considered to have agreed both to the terms of this Offer and these additional terms.



2.3. The Contractor has the right to make changes in the published announcement of the event and is not responsible for the fact that not all the issues contained in the announcement will be discussed during the event.

2.4. The list of speakers participating in the event shall be compiled by the Contractor independently and shall be indicated in the announcement of the event published on the Contractor's website. The contractor has the right to replace or reduce the number of speakers.

2.5. The participation in the event involves listening to the speakers and provides the opportunity to ask questions to the speakers. The Contractor does not guarantee that the Customer will receive answers to their questions.

2.6. The Customer shall pay for the participation in the event while applying via the payment system. The acceptance of this Offer shall be deemed to have been made only on condition of payment. In the absence of payment, the Customer shall not be deemed to have entered the event.

2.7. Each of the parties has the right to unilaterally cancel the contract entered as a result of the acceptance of this Offer, before the event. The respective declarations can be made by e-mail. The payment made in this case shall be returned upon the Customer's request.

2.8. The Customer's failure to attend the event either on all the days of the event or on one or several days of the event shall be recognized as the Customer's unilateral rejection of the contract concluded by accepting this Offer and shall lead to the termination of the relevant contract in full (in case of the Customer's failure to attend all the days of the event) or in part (in case of the Customer's failure to attend some days of the event or part-time attendance the event). The payment made will not be refunded to the Customer in this case.

2.9. No Act of Completion of Services shall be issued as a result of the participation in the event. The fact of the Customer's participation in the event shall be confirmed by the Customer's signature on the registration sheet.

2.10. The rights and obligations under this Offer shall come into effect from the date of its acceptance by the Customer.
