SIR:—I return herewith without my approval.

S. F. No. 88. An act to exempt the county of St. Louis from the provisions of section thirteen of chapter one hundred and eighteen of the General Statutes of 1878, relating to judgment in criminal cases and the execution thereof.

I feel constrained to disapprove this bill, because it is too sweeping in its exceptions to a law of general application. It is advisable that criminal laws especially should be uniform in their operation.

I have signed and approved the following Senate Files, and have deposited the same in the office of the Secretary of State, to wit:

S. F. No. 4, An act relating to religious corporations.

S. F. No. 22, An act in relation to plats of additions or subdivisions thereof, to any town or city, now on file in any register of deeds office in this State, or copies thereof so on file; to legalize the same as if properly made, executed, certified to and recorded; to provide for the identification of the real estate covered thereby, and to give effect to the same, together with such identification of the real estate covered thereby, as evidence.

S. F. No. 72, An act to amend sections 2 and 6 of an act to provide for a sinking fund for the payment of the bonded indebtedness of the city of Albert Lea, Minnesota.

S. F. No. 189, An act to appropriate money for the expenses of the present session of the Legislature, and of the Senate sitting as a court of impeachment.

S. F. No. 91, An act relating to the payment of additional counsel employed by the Attorney General of the State of Minnesota, to assist him in the performance of his duties, under chapter 102, General Statutes of 1881, providing for the payment of the Minnesota State railroad bonds.

S. F. No. 47, An act to authorize the board of county commissioners of Scott county to levy a tax for road and bridge purposes.

S. F. No. 90, An act relating to locating, establishing and vacating highways and cartways in Goodhue county, and to amend section 49, chapter 13, General Statutes.

S. F. No. 71, An act to provide funds and means to repair and improve the roads and highways leading into the city of Albert Lea, from the township of Albert Lea, Minnesota.

S. F. No. 80, An act to amend an act entitled "An act granting swamp lands to aid the Minneapolis & St. Cloud Railroad Company in building branches to connect with the Lake Superior & Mississippi Railroad, and the Winona & St. Peter Railroad, or any other railroad in southern Minnesota," approved February 11, A. D. 1865.

S. F. No. 55, An act to amend section 35 of chapter 36 of General Laws A. D. 1878.

S. F. No. 98, An act to cure defective organizations of corporations, and for the protection of rights acquired thereunder.

S. F. No. 23, An act to appropriate money for the use of the State Board of Immigration.

S. F. No. 67, An act fixing the time for holding general terms of the district court, in the county of Kittson.

S. F. No. 2, An act to amend section 33 of chapter 5 of the General Laws of A. D. 1873, relating to roads, cartways and bridges.

S. F. No. 125, An act to fix the salary of the Attorney General's clerk

S. F. No. 89, An act to amend chapter 7 of an act entitled "An act to define the boundaries of, and establish a municipal government for the village of Duluth," approved March 8, 1881.
