Whereas, From a report made by a special committee appointed by the Speaker of this House it appears that for trivial offenses inhuman punishment is meted out to convicts confined in the penitentiary at Stillwater; and whereas, such punishment is a blot on the progressive ideas which at this age should characterize the management of penal and reformatory institutions, therefore be it

Resolved, By the House, the Senate concurring, that the present warden of the penitentiary is hereby directed to institute a different and more humane system of punishment to the end that the convicts may reform and not be driven to desperation by mental and physical

torture.

The joint resolution was read the first, second and third times, and The question being taken on the adoption of the resolution,

EXECUTIVE COMMUNICATION.

The following communication was received from the Governor:

STATE OF MINNESOTA, EXECUTIVE DEPARTMENT, St. Paul, April 18, 1891.

Hon. E. T. Champlin, Speaker of the House:

SIR,—I beg to return herewith without my approval, House File No. 1218 entitled, "an act to amend the articles of incorporations of the Flom Mutual Fire Insurance Company of Norman county, Minnesota."

This bill contravenes the seventh (7th) sub-division of section thirty-three (33) of article four (4) of the State Constitution. The constitution expressly prohibits the granting of corporate powers

except to cities.

Besides, the purposes sought to be accomplished by the bill, may be secured by virtue of the existing general law.

For these reasons I am constrained to withhold my official signature.
