STATE OF MINNESOTA. EXECUTIVE DEPARTMENT. St. Paul, April 17, 1935.

Hon. G. W. Johnson, Speaker of the House of Representatives: Dear Sir:

I am returning to you without my approval H. F. No. 1732. I object to the bill on the same grounds as I presented in my veto of the so-called North Hibbing bills.

This bill is designed to lower the taxes, over a period of years, of the mining companies doing business within the Chisholm School District. In addition, the matter has never been submitted to the electorate of the district for a referendum vote.

It purports to find a means for the payment and retirement of bonds issued for the erection of a school in the district. The school district, because of its ample security, can now legally obtain loans from the State Investment Board of Minnesota, with which to refinance outstanding bonds as they become due. It can thereafter pay its obligations to the state out of its present per capita tax levy.

I see no reason why the reduction of the taxes of the mining companies must accompany any process of refinancing.
