YOUR LEGISLATORS' VOTING RECORD ON SMALL BUSINESS ISSUES 2016 EDITION

Floor votes by your state legislators on key small business issues are listed inside. The Voting Record does not reflect all elements considered by a lawmaker when voting, nor does it represent a complete profile of a legislator, but it can be a guide in evaluating a legislator's attitude toward small business. Many issues affecting small business are decided in committees and never make it to the floor of the House or Senate. Please thank those legislators who supported small business, and continue to work with those who have fallen short.

2015

1. **2 Year Budget Appropriation (HB 1):** Make appropriations for the expenses of certain departments of the state for fiscal years ending June 30, 2016, and June 30, 2017, and includes tax cuts for New Hampshire businesses. **A “YES” vote supports the NFIB position.** Passed the House 196–161 (6/24/15). Passed the Senate 14–10 (6/24/15). Governor vetoed the bill, veto was overridden in the fall of 2015.
2. **Legislative Directive on How to Spend Appropriations (HB 2):** Relative to state fees, funds, revenues and expenditures. Includes cuts to both the Business Enterprise Tax and the Business Profits Tax. **A “YES” vote supports the NFIB position.** Passed the House 196–164 (6/24/15). Passed the Senate 14–10 (6/24/15). Governor vetoed the bill, veto was overridden in the fall of 2015.
3. **Credit History for Employment Purposes (HB 365):** Prohibits an employer from using credit history in employment decisions. **A “YES” vote on the motion to defeat the bill supports the NFIB position.** Defeated in the House 200–142 (3/12/15).
4. **Minimum Wage (HB 684):** Establishes a state minimum hourly rate. **A “YES” vote on the motion to defeat the bill supports the NFIB position.** Defeated in the House 198–145 (3/12/15).
5. **Paid Sick Leave (HB 600):** Requires employers to provide paid sick leave for employees. **A “YES” vote on the motion to defeat the bill supports the NFIB position.** Defeated 219–122 (3/12/15).
6. **Retail Sales and Use Tax (HB 673):** Imposes a 2.25 percent retail sales tax. The bill also imposes a 2.25 percent use tax on the use or storage of property in New Hampshire when no sales tax has been paid. **A “YES” vote on the motion to defeat the bill supports the NFIB position.** Defeated in House 355–13 (3/11/15).
7. **Right to Work (HB 658):** Prohibits collective bargaining agreements that require employees to join a labor union. **A “YES” vote supports the NFIB position.** Passed the House 149–146 (3/11/15).
8. **Minimum Wage (SB 261):** Establishes a state minimum wage. **A “YES” vote on the motion to defeat the bill supports the NFIB position.** Defeated in Senate 14–10 (3/12/15).
9. **Right to Work (SB 107):** Prohibits collective bargaining agreements that require employees to join or contribute to a labor union. **A “YES” vote supports the NFIB position.** Defeated in Senate 12–12 (3/5/15).
10. **R&D Tax Credit (SB 6):** Increases the research and development tax credit against the business profits tax. **A “YES” vote supports the NFIB position.** Passed the Senate 24–0 (2/19/15) and then was laid on the table where it died.
11. **Risk Associated with Outdoor Recreation Activities (HB 290):** Provides that persons who engage in outdoor recreational activities accept the dangers inherent in such activities and shall not maintain a legal action against an owner for resulting injuries. **A “YES” vote supports the NFIB position.** Passed the Senate 18–4 (5/28/15).

12. **Minimum Wage (HB 1346):** Relative to minimum wage for tipped employees. **A “YES” vote on the motion to defeat the bill supports the NFIB position.** Defeated in the House 190–137 (3/10/15).

- 13. Reasonable Compensation Deduction (HB 1443):** Repeals certain provisions relative to burden of proof in determining the reasonable compensation deduction from the gross business profits under the business profits tax and advises the department of revenue administration to use certain averages of compensation when determining reasonableness. **A “YES” vote on the motion to defeat the bill supports the NFIB position.** Defeated in the House 180–131 (3/10/16).
- 14. Minimum Wage (HB 1480):** Establishes a state minimum wage. **A “YES” vote on the motion to defeat the bill supports the NFIB position.** Defeated in the House 185–143 (3/10/16).
- 15. Prevailing Minimum Hourly Wage (HB 1641):** Requires certain workers employed in the construction of public works in the state of New Hampshire to be paid the prevailing minimum hourly wage and benefits. **A “YES” vote on the motion to defeat the bill supports the NFIB position.** The NFIB position prevailed on a vote of 168–134. (2/11/16)
- 16. Internal Revenue Code vs. Business Profits Tax (HB 668):** Updates the effective version of the US IRS Code of 1986 applicable to the business profits tax, subject to certain adjustments. Also requires the commissioner of revenue administration to report biennially on changes to the IRS Code. **A “NO” vote on the motion to defeat the bill supports the NFIB position.** The NFIB position prevailed on a vote of 168–134. (2/11/16).
- 17. Internal Revenue Code vs. Business Profits Tax (SB 239):** Updates the effective version of the US IRS Code of 1986 applicable to the business profits tax, subject to certain adjustments. Also requires the commissioner of revenue administration to report biennially on changes to the IRS Code. **A “YES” vote on the adoption of the Conference of Committee Report supports the NFIB position.** Passed the Senate 22–2 (6/1/16).
- 18. Sale of Interest in a Business (SB 342):** Limits the inclusion in the business profits tax of the net increase due to certain sales or exchanges of an interest or beneficial interest in a business organization. **A “YES” vote on the adoption of the Conference of Committee Report supports the NFIB position.** Passed the Senate 24–0 (6/1/16).
- 19. Minimum Wage (SB 412):** Establishes a minimum wage. **A “YES” vote on the motion to defeat the bill supports the NFIB position.** Defeated by the Senate 14–10 (2/4/16)
- 20. Ban the Box (SB 413):** Prohibits employers from inquiring into a job applicant’s criminal record during the initial employment application process. **A “YES” vote on the motion to refer this bill to interim study supports the NFIB position.** Motion on interim study failed 11–12 (3/17/16), bill was tabled and eventually died on the table.
