YOUR LEGISLATORS' VOTING RECORD ON SMALL BUSINESS ISSUES

2011 SESSION: Listed below are roll-call votes by state legislators on issues where NFIB had an official position. The Voting Record is only one measure of a legislator's performance. A vote tally does not indicate which legislators represented small business interests in committees or behind the scenes. However, the record does indicate their positions when asked to vote on key issues on the floor of the House or Senate. Please thank those legislators who supported legislation important to small business.

Comprehensive Income and Property Tax Relief Package (HB 1047): Provides nearly a half-billion dollars in tax relief, including \$120 million in individual income tax reductions, a \$25 million cut for corporations, and \$342 million in property tax relief.

A "Yes" vote supports the NFIB position. Passed the House 88–3 and the Senate 44–3.

Workforce Safety and Insurance Permanent Partial Impairment (HB 1055): Enacts various changes in the assessment of impairment of workers injured on the job, altering thresholds for benefit qualification as well as changes in benefit amounts. A "Yes" vote supports the NFIB position. Passed the House 85–5 and the Senate 35–11.

3 Sales Tax Collection Vendor Allowance (HB 1424): Increases allowance for merchants collecting

sales tax on behalf of the state from the previous \$85 monthly limit to \$93.75. A "Yes" vote supports the NFIB position. Passed the House 74–19 and the Senate 47–0.

Property Owner Immunity for Injuries to Trespassers (HB

1452): Shields landowners from liability for injuries to trespassers unless they were found to have purposely harmed the trespasser or neglected conditions known to cause injury. **A "Yes" vote supports the NFIB position.** Passed the House 85–5 and the Senate 47–0.

5 Income Tax Credits for Purchases of Manufacturing
Machinery (SB 2055): Enacts a tax
credit for investing in machinery for
process automation and for qualified
expenditures related to lean manufacturing. A "Yes" vote supports the NFIB
position. Passed the Senate 38–8, but
failed to pass the House 35–54.
