Executive summary

This report provides the Committee's proposed redistribution of Western Australia into 16 electoral divisions.

A redistribution is a redrawing of electoral boundaries to ensure, as near as practicable, that each state and territory gains representation in the House of Representatives in proportion to its population, and that there is a similar number of electors in each electoral division for a given state or territory.

The Electoral Act authorises the redistribution process, including the various stages involved in a redistribution, the extent of public involvement and the relevant timelines to be observed.

The current Western Australia redistribution is required by section 59(2)(a) of the Electoral Act in that the number of members of the House of Representatives that is to be chosen for Western Australia at the next general election has altered from 15 to 16.

The redistribution process commenced on 1 December 2014 with an Electoral Commission direction. Public suggestions were invited on Wednesday 11 March 2015 by way of a notice in the Commonwealth Government Notices Gazette (the Gazette) and by way of newspaper advertisements on 14 March 2015. Suggestions were made publicly available on Monday 13 April 2015 and public comments on the suggestions were invited. The Committee received 27 written suggestions and 16 written comments. The Committee noted the wide-ranging and comprehensive nature of some suggestions and the well-argued cases for change.

The Committee has carefully considered all suggestions and comments in detail, at meetings held in May and June 2015. The Committee has developed its redistribution proposal informed by those suggestions and comments.

The redistribution proposal covers two broad areas, naming of electoral divisions and defining the boundaries of electoral divisions.

Naming of electoral divisions

The Committee proposes that the 15 existing division names are retained. In proposing a name for the 16th division, the Committee took account of the Australian Electoral Commission's (AEC's) 'Guidelines for naming federal electoral divisions' (the guidelines), which are reproduced as Appendix F to this report. Various suggestions and comments put forward the names of a number of prominent Western Australian individuals and families, all of whom have contributed to public and/or political life to varying degrees and many of whom met the guidelines. Ultimately the Committee determined to propose that the 16th division is named Burt for the reasons set out in the body of the report.

Boundaries of electoral divisions

In making its proposed redistribution the Committee must ensure that enrolment numbers for each proposed division remain within both current and projected enrolment parameters.

At the commencement of the redistribution on 1 December 2014, current enrolment for Western Australia was 1 504 413 across the existing 15 divisions, with an average enrolment for 16 divisions of 94 026. The 10 per cent tolerance available to the Committee requires that the 16 new divisions are constructed with a minimum current enrolment of 84 623 and a maximum current enrolment of 103 428.

At the projection time of 8 February 2017, projected enrolment for Western Australia is 1 594 973 with a projected average enrolment for each of the 16 divisions of 99 686. The 3.5 per cent tolerance available to the Committee requires that divisions are constructed with a minimum projected enrolment of 96 197 and a maximum projected enrolment of 103 175.

In addition to meeting the numerical requirements of the Electoral Act, the Committee has applied the following principles when considering the placement of new boundaries:

- a. to the extent possible, community of interests such as local government areas (LGAs) and localities are kept together; strong and readily identifiable features, such as major roads and railways, are used to define divisional boundaries,
- b. to the extent possible, proposed divisional boundaries do not cross the Swan River or other major geographic barriers, and
- c. to the extent possible, the maximum number of electors are retained in their current electoral division.

The majority of written suggestions proposed that the new division is created around the Armadale and Gosnells LGAs and the Committee found this to be the most appropriate placement for the new division.

The Committee's proposal places the new Division of Burt in the south-east corner of the Perth metropolitan area centring on Gosnells and Armadale. The new electoral division takes its elector numbers primarily from the outer-urban growth Divisions of Canning and Hasluck. The Division of Tangney has also provided a substantial number of electors to form the new division, with a small number of electors moved from the existing Division of Swan. The changes made to the Divisions of Canning, Hasluck, Swan and Tangney to form the new division have created flow-on effects, impacting all other divisions, in order to have all divisions remaining within the numerical requirements set out in the Electoral Act.

Elector movements

The Committee noted that in the absence of any other changes some six per cent of electors must be moved in order to create the new division.

The Committee's proposal requires 264 401 current electors to change division, with 93 763 of that number moving to form the new Division of Burt. Discounting the electors that have been moved to create the new division the Committee's proposal involves the movement of 170 638 electors, or 11.34 per cent of all electors across Western Australia.

Chapter 1 Background and context

This chapter outlines the legislative requirements of the redistribution, ranging from the formal commencement of the process to the release of the Committee's proposed redistribution. The chapter explains how these requirements have been met during the redistribution process, and also discusses trends in population and enrolment for Western Australia.

- 1. A redistribution is a redrawing of electoral boundaries to ensure, as near as practicable:
 - each state and territory gains representation in the House of Representatives in proportion to its population, and
 - there is a similar number of electors in each electoral division for a given state or territory.

Compliance with legislative requirements

- 2. The Electoral Act specifies that a redistribution is required when:
 - the number of members of the House of Representatives to which a state or territory is entitled has changed (relative population change),
 - the number of electors in more than one third of the electoral divisions in a state (or one of the
 electoral divisions in the Australian Capital Territory or the Northern Territory) deviates from the
 average divisional enrolment by more than 10 per cent for a period of more than two months, or
 - a period of seven years has elapsed since the last redistribution.
- 3. The processes to be followed in conducting a redistribution are also specified in the Electoral Act. Appendix A summarises the legislative requirements which have been complied with in conducting this redistribution. Each of the requirements is discussed in further detail in this Chapter.

Determination of the number of members of the House of Representatives to be chosen in states and territories

4. On 13 November 2014, the then acting Electoral Commissioner made a determination under section 48(1) of the Electoral Act of the number of members of the House of Representatives to which each state and territory is entitled at the next general election. As a result of this determination, Western Australia's entitlement has increased from 15 to 16 members of the House of Representatives.

Direction for a redistribution of Western Australian electoral divisions

 In accordance with sub-section 59(1) of the Electoral Act, the Electoral Commission published a notice in the Gazette on 1 December 2014, directing that a federal redistribution commence for Western Australia.

Determination altering the projection time for equality of enrolments

- 6. Section 63A of the Electoral Act establishes that the projection time in relation to a redistribution is the end of the period of three years and six months after the 'starting time'. The starting time from which the projection time is calculated, as defined by sub-section 63A(5), is the date on which the augmented Electoral Commission determines the boundaries and names of divisions via publication of a notice in the Gazette.
- 7. The starting time for the redistribution of Western Australia is 19 January 2016 as this is the date on which the augmented Electoral Commission will cause the boundaries and names of electoral divisions in Western Australia to be published in the Gazette.
- 8. Sub-section 63A(3) further provides that if the Electoral Commission is of the opinion that a further redistribution will be required as a result of a change to a state or territory's entitlement to representation in the House of Representatives, sooner than seven years after the starting time, it may determine that the projection time will be a time that is half way between the starting time for the projection and the time when, in the opinion of the Electoral Commission, the further redistribution will or may be required.
- The Electoral Commission determined that the projection time for Western Australia would be altered and published a notice in the Gazette on 1 December 2014 determining that the projection time is 8 February 2017.

Current enrolment quota

10. Section 65 of the Electoral Act requires the Electoral Commissioner, as soon as practicable after the redistribution commences, to determine the current enrolment quota using the following formula:

Number of electors enrolled in Western Australia as at the end of the day on which the redistribution commenced (1 December 2014)

Number of members of the House of Representatives to which Western Australia is entitled

- 11. In calculating this quota, sub-section 65(2) of the Electoral Act provides that:
 - where the result contains a fraction that is less than 0.5, the number is rounded down to the nearest whole number, or
 - where the result contains a fraction that is equal to or greater than 0.5, the number is rounded up to the nearest whole number.

12. Table A shows the numbers used to calculate the current enrolment quota and the resultant range of the permissible maximum and minimum number of electors in a division (discussed further in 'Statutory requirements for the making of a proposed redistribution').

- The then acting Electoral Commissioner signed a written instrument on 8 December 2014, as required by sub-section 65(1) of the Electoral Act, determining the quota of electors for the purposes of the redistribution to be 94 026.
- 14. As discussed in Appendix B, when making a proposed redistribution, the Committee is required to ensure that the number of electors in a proposed division does not vary by more than 10 per cent above or more than 10 per cent below the current enrolment quota.

Enrolment projections and projected average enrolment

15. As discussed in Appendix B, when making a proposed redistribution, the Committee is required by sub-section 66(3)(a) of the Electoral Act to ensure, as far as practicable, that the number of electors enrolled in the proposed division at the projection time will not vary by more than 3.5 per cent above or more than 3.5 per cent below the projected average enrolment. The projected average enrolment is calculated using the following formula:

Projected total number of electors enrolled in Western Australia at the projection time (8 February 2017)

Number of members of the House of Representatives to which Western Australia is entitled

16. Table B shows the figures used to calculate the projected average enrolment and the resultant range of the permissible maximum and minimum number of electors in a division at the projection time (discussed further in 'Statutory requirements for the making of a proposed redistribution').

Appointment of the Redistribution Committee for Western Australia

- 17. Sub-section 60(1) of the Electoral Act specifies that a Redistribution Committee for Western Australia is required to be appointed by the Electoral Commission, via a written instrument, as soon as practicable after the commencement of the redistribution. Section 60 specifies the membership of the Committee.
- 18. The membership of the Redistribution Committee for Western Australia is provided at Table C.

- 19. The Committee met on:

 - 29 June 2015.

Invitation for interested parties to submit suggestions and comments on suggestions

- 20. The Electoral Commissioner is required by sub-sections 64(1) and 64(2) of the Electoral Act to invite written suggestions relating to the redistribution and written comments on the suggestions received, by:
 - publishing a notice in the Gazette on a Wednesday, and
 - publishing a notice in two newspapers circulating throughout Western Australia.

- 21. The notice in the Gazette was published on Wednesday 11 March 2015 and notices were published in *The Weekend West* and *The Weekend Australian* newspapers on 14 March 2015.¹
- 22. The notices included information about the processes involved in conducting a redistribution, how to participate in the process and where to find further information. Table D indicates the avenues submitters could utilise to make a suggestion or comment on suggestions, and the extent to which they were used.

- Interested parties were able to submit written suggestions from Wednesday 11 March 2015 until 6pm (AWST) on Friday 10 April 2015, the 5th Friday after publication of the Gazette notice. During this time, 27 suggestions were received by the Committee (see Appendix C).
- 24. As required by section 64(3)(a) of the Electoral Act, copies of the suggestions were made available to members of the public for perusal at the office of the Australian Electoral Officer for Western Australia in Perth from Monday 13 April 2015. The suggestions were also made available on the AEC website.
- 25. Interested parties were able to submit written comments on suggestions from Monday 13 April 2015 until 6pm (AWST) on Friday 24 April 2015, the 7th Friday after publication of the Gazette notice. During this time, 16 comments on suggestions were received by the Committee (see Appendix D).
- 26. From 28 April 2015, interested parties were able to peruse the comments on suggestions on the AEC website.

Redistribution Committee's consideration of suggestions and comments on suggestions

- 27. The Committee is required by sub-section 64(4) of the Electoral Act to consider all suggestions and comments on suggestions that were received by the specified lodgement times.
- 28. At its meeting on 22 May 2015, the Committee considered each of the 27 suggestions and 16 comments in detail. While no suggestion or comment was adopted in its entirety, the Committee noted common elements that emerged from the suggestions and comments and a number of the points raised are reflected in the proposed redistribution.
- 29. Suggestions and comments are available in full on the AEC website and reproduced on the DVD included with the hard copy version of this report.

1 Sub-section 64(2) of the Electoral Act notes that the newspaper notices need not be published on the same day as the Gazette notice.

- 30. The Committee noted that a range of methods could be applied to achieve a redistribution outcome for Western Australia. Submissions addressing the state as a whole adopted varying approaches and proposed moving between, approximately, 14 per cent and 26 per cent of electors into a different division. The Committee noted that in the absence of any other changes some six per cent of electors must move in order to create the new division.
- 31. Submissions dealing with specific regions generally sought to improve electoral boundaries and to strengthen local community of interests by bringing together neighbouring localities into a single division and/or by suggesting LGA boundaries as divisional boundaries. In its deliberations the Committee noted that those submissions that proposed boundaries for specific regions of the state would need to be considered in the broader context of their effect on the state as a whole.
- 32. A number of submissions proposed the creation of a new division in the growth areas of Perth's south-eastern suburbs, to be constructed primarily of localities from the Armadale and Gosnells LGAs. Other submissions suggested the four divisions that currently fall within numerical tolerances remain in their current composition, recommending no changes to those boundaries. However, the majority of state-wide suggestions significantly altered at least two of the existing 15 divisions in order to accommodate the new division.
- 33. Appendix E summarises the key themes contained in all suggestions and comments on suggestions, and how they relate to the Committee's proposal with regard to the requirements of the Electoral Act.

Statutory requirements for the making of a proposed redistribution

- 34. Section 66 of the Electoral Act requires the Committee to take account of specific criteria in forming the proposed boundaries.
- 35. The Committee has ensured that the number of electors in each proposed electoral division is:
 - not less than 90 per cent or more than 110 per cent of the current enrolment quota (see Table A above for the permissible maximum and minimum number of electors at this time), and
 - not less than 96.5 per cent or more than 103.5 per cent of the average projected divisional enrolment at the projection time of 8 February 2017 (see Table B above for the permissible maximum and minimum number of electors at this time).
- 36. The Committee has also given due consideration to:
 - community of interests within the proposed electoral divisions including economic, social and regional interests,
 - means of communication and travel within the proposed electoral divisions,
 - the physical features and area of the proposed electoral divisions, and
 - the boundaries of existing electoral divisions.
- 37. Further details regarding these requirements are contained in Appendix B.

Population and enrolment in Western Australia

- 38. The periodic redrawing of electoral boundaries is required to:
 - address changes in the population of a state or territory. These changes may result from natural increase, natural decrease, net overseas migration or net interstate migration, and
 - address changes in the distribution of electors within the state or territory.

Western Australia's population

- 39. On 13 November 2014, the then acting Electoral Commissioner ascertained that Western Australia's population was 2 565 588.² This represents growth of 10.73 per cent since the previous ascertainment of the population was made on 29 September 2011.
- 40. Geographically, Western Australia is the largest Australian state, with a population that continues to grow faster than the Australian average.
- 41. At June 2014, Western Australia's estimated resident population (ERP) represented 11 per cent of the total Australian population.³ The state's ERP at June 2014 was 2.57 million,⁴ an increase of 2.16 per cent since June 2013. As shown in Figure A below, from 2008–09 to 2013–14, Western Australia's population growth rate has been higher than any other state or territory.




Figure A: Population increase by state and territory 2008–09 to 2013–14

Where is Western Australia's population located?

- 42. At June 2014, 79 per cent of Western Australia's total population was located in the area of Greater Perth.⁵ Over a number of years, population growth in Western Australia has been concentrated in the outer suburban areas of Greater Perth, specifically in:
 - Forrestdale Harrisdale Piara Waters,
 - Baldivis,
 - North Coogee,
 - Anketell Wandi, and
 - Yanchep.⁶
- 43. Future growth is also anticipated in Wanneroo, in particular Alkimos, Eglinton and Banksia Grove.
- 44. Outside of Greater Perth, the most significant population growth is in Busselton in the south-west of the state and Karratha in the north of the state.⁷ There has been a decline in population in non-metropolitan areas of the state.⁸
- 45. Western Australia has the second lowest population density of all states and territories in Australia, of one person per square kilometre (sq km). There is considerable variation within the state with the population density in Greater Perth of 315 people per sq km compared to 0.2 people per sq km for the rest of Western Australia. In the year to June 2014, the population density of Greater Perth increased by 7.5 people per sq km.⁹

Enrolment in Western Australia

- 46. When the redistribution of Western Australia commenced on 1 December 2014, 1 504 413 electors were enrolled. By the projection time of 8 February 2017, it is projected that the size of the federal electoral roll for Western Australia will have grown by 6.02 per cent to 1 594 973 electors.
- 47. Table E demonstrates that while enrolment across all electoral divisions is projected to increase during the period 1 December 2014 to 8 February 2017, the rate of growth is not projected to be consistent across the state. Projected growth varies considerably, ranging from 3.96 per cent for the Division of Forrest to 7.33 per cent for the Division of Brand. This is not unexpected and underpins the need for substantial boundary adjustment across divisions to cater for the dual challenges of disparate growth rates and the need for boundaries to be adjusted to create the 16th division.

48. Table E also indicates that existing divisions in Western Australia fall into three categories:

- where the current enrolment is more than 10 per cent above the current enrolment quota and must be corrected in this redistribution to meet the numerical requirements of the redistribution process – the Divisions of Brand, Canning, Fremantle and Pearce,
- where the projected enrolment is more than 3.5 per cent above the projected average enrolment and must be corrected to meet the numerical requirements of the redistribution process – the Divisions of Brand, Canning, Cowan, Forrest, Fremantle, Hasluck, Moore, Pearce, Perth, Stirling and Swan, and
- where the numerical requirements of the Electoral Act in relation to both current and projected enrolment is met and technically the existing divisions require no adjustment – the Divisions of Curtin, Durack, O'Connor and Tangney.
- 49. The above highlights the need for the Committee to make significant changes to the current electoral boundaries. This need for boundary modification is caused by the requirement to create a new division which, of itself, generates significant consequential changes to existing divisions, with all divisions potentially affected.

Chapter 2 Proposed redistribution and reasons for proposal

This chapter outlines the Committee's proposed redistribution and the reasons for this proposal. Also included is the Committee's approach to formulating the proposed boundaries and the names of divisions.

Redistribution Committee's proposed redistribution

50. The Committee proposes the 16th electoral division, named the Division of Burt, is located in the Armadale and Gosnells area of the south-eastern Perth metropolitan region. Further the Committee proposes that the majority of electors comprising the new division are transferred from the existing Divisions of Canning, Hasluck and Tangney. Consequential changes are made to all other divisions in order to meet the numerical requirements for a redistribution that are contained in the Electoral Act and to accommodate, to the extent possible, community of interests considerations. Additionally, the Committee has, to the extent possible, addressed community of interests considerations by locating LGAs and localities within a single division. A small number of changes are proposed in order to provide stronger and more readily identifiable electoral boundaries.

Redistribution Committee's approach to formulating proposed electoral boundaries

- 51. The Committee's general strategy for formulating proposed electoral boundaries is based on, and conforms to, the requirements of the Electoral Act.
- 52. The Committee acknowledges the overarching requirement to maintain relative equality of the number of electors in each electoral division. The Committee also noted the flexibility provided by the numerical tolerances contained in the Electoral Act. The Committee has made use of the available tolerances to construct divisions that address all other criteria to the extent possible.
- 53. Within the limits imposed by the numerical criteria and the other considerations, the Committee is mindful that strong, readily identifiable electoral boundaries are preferred. Local government authority boundaries, locality/suburb boundaries, main roads, railways, waterways and other strong geographic or constructed features able to be used as boundaries, have further guided the Committee's deliberations.
- 54. Detailed descriptions of the Committee's deliberations in determining its proposed boundaries are contained in this chapter, under the section titled 'Proposed redistribution of Western Australia – by division'.
- 55. In formulating the redistribution proposal, the Committee noted that the construction of a new electoral division projected to contain some 100 000 electors will, of necessity, result in significant elector movement into the new division and will also require consequential boundary changes and

elector movements across the state in order to maintain equality of enrolments state-wide. In this context the Committee has sought to minimise the movement of electors between divisions to the extent possible. Table F outlines the extent of elector movements resulting from the proposed redistribution.

Redistribution Committee's approach to naming divisions

56. The naming of federal electoral divisions has been the subject of a number of recommendations from parliamentary committees. Guidelines were developed by the AEC from recommendations made by the Joint Standing Committee on Electoral Matters (JSCEM) in its 1995 Report on the Effectiveness and Appropriateness of the Redistribution Provisions of Parts III and IV of the Commonwealth Electoral Act 1918. The guidelines were offered to interested persons when this redistribution was advertised, are publicly available on the AEC website and are provided as Appendix F to this report.

Name of the new electoral division

- 57. A number of suggestions and comments on suggestions were received proposing names for the new electoral division. Details of the suggestions received are included as Appendix E to this report.
- Two suggestions proposed that the 16th division be named Armadale. The Committee does not favour this suggestion because it does not meet the current guidelines.
- 59. One suggestion proposed the 16th division be named Dampier for the early explorer William Dampier. This is the name of a previous division that was created in 1912, however the division name was retired in 1922 and the name does not meet the current guidelines.
- 60. 14 suggestions, including one petition-style suggestion containing 537 signatures, and one comment, suggested the 16th division be named Vallentine to honour Jo Vallentine who was a Senator for Western Australia from 1985 until 1992. The Committee acknowledges former Senator Vallentine's significant contribution, however it does not favour this suggestion because the suggestion does not meet the current guidelines.
- 61. Two suggested names Beazley and Court were each considered to be strong nominations, however they were not favoured by the Committee at this point in time. The Committee considers that there is some potential for confusion with other living family members who are prominent public figures. The Committee noted that the option to consider the two names remains open to future redistribution committees.
- 62. The remaining suggested names all met the guidelines in that the nominees had all made strong contributions in various fields, either within Western Australia or nationally.

- 63. Ultimately, after much deliberation, the Committee has chosen to propose the name Burt for the 16th division. The name honours succeeding generations of the Burt family for their significant contributions to the justice system and for their wider contributions to public service, specifically:
 - Sir Archibald Burt (1810–1879), first Chief Justice of the Supreme Court of Western Australia,
 - Septimus Burt (1847–1919), whose public roles included that of Attorney-General of Western Australia at the time of colonial self-government, and
 - Sir Francis Burt (1918–2004), who served as a judge of the Supreme Court of Western Australia, Chief Justice of Western Australia, and Governor of Western Australia from 1990 until 1993.

Proposed redistribution of Western Australia by division

- 64. The Committee has examined each proposed electoral division, giving due consideration to the requirements of the Electoral Act. For each of the proposed divisions in Western Australia, Table G presents:
 - current enrolment at 1 December 2014,
 - percentage variation from the current enrolment quota,
 - projected enrolment as at 8 February 2017,
 - percentage variation from the projected average enrolment, and
 - the approximate area of each proposed division.



67. The proposed Division of Brand is surrounded by the Divisions of Burt, Canning and Fremantle – Figure B refers.





- 68. Projected enrolment in the existing Division of Brand is 114 105. This division requires a net reduction of between 10 930 and 17 908 electors in order to fit within the required numerical parameters.
- 69. The Committee proposes that the following electors are transferred out of the existing division:





- 71. A number of public suggestions and comments on suggestions recommended that the Mandurah LGA be reunited within one division with the majority of these suggestions proposing the LGA be located in the Division of Canning.
- 72. The only modification to the Division of Brand is to transfer that portion of the Mandurah LGA that previously formed part of the Division of Brand into the Division of Canning.
- 73. The proposed Division of Brand is now contained wholly within the boundaries of the Kwinana and Rockingham LGAs and includes Garden Island.
- 74. The proposed Division of Brand has a projected enrolment of 96 631 which is a variation from the average projected enrolment of minus 3.06 per cent.

Burt

 The proposed Division of Burt is located either side of the South Western Hwy surrounded by the Divisions of Brand, Canning, Fremantle, Hasluck, Swan and Tangney – Figure C refers.

- 77. A number of public suggestions and comments on suggestions recommended that the new division be placed in the Armadale and Gosnells LGA being in the south-eastern region of metropolitan Perth.
- 78. The proposed Division of Burt is constructed from localities within the Armadale, Canning and Gosnells LGAs. The Canning River is utilised as a strong north eastern boundary with the remainder of the borders composed of locality boundaries that are readily identifiable.
- 79. Utilising the Canning River as a strong boundary the locality of Langford is transferred from the Division of Swan whilst the localities of Gosnells, Huntingdale, Southern River and Thornlie are transferred from the Division of Hasluck. Canning Vale locality is moved from the Division of Tangney. A third of the Armadale LGA is moved from the Division of Canning with the localities of Armadale, Brookdale, Camillo, Champion Lakes, Forrestdale, Harrisdale, Haynes, Hilbert, Kelmscott, Mount Nasura, Piara Waters and Seville Grove with Wungong split by the South Western Hwy.
- 80. The proposed Division of Burt has a projected enrolment of 100 530 which is a variation from the average projected enrolment of plus 0.85 per cent.

Canning

81. The proposed Division of Canning is surrounded by the Divisions of Brand, Burt, Forrest, Fremantle, Hasluck, O'Connor and Pearce – Figure D refers.




Figure D: Proposed Division of Canning

- 85. Substantial movement of electors is required in the Division of Canning after contributing to the creation of the new division with approximately one third of electors transferring to the Division of Burt from the Armadale LGA. The division has retained some of its urban sections and has gained additional rural areas.
- 86. The Committee received a number of public suggestions and comments on suggestions recommending that the Mandurah LGA be reunited within one division with the majority of these suggestions proposing the LGA be located in the Division of Canning.
- 87. The Committee has adopted this suggestion and transferred the Mandurah LGA portion from the Division of Brand, thereby reuniting the Mandurah LGA within one division.
- 88. To ensure the Division of Canning meets numerical parameters the rural LGA of Wandering is transferred from the Division of O'Connor, the outer suburban localities of Orange Grove and Martin are transferred from the Division of Hasluck and the outer suburban localities of Carmel, Canning Mills and Pickering Brook are transferred from the Division of Pearce.
- 89. The Division of Canning's new boundaries are primarily constructed from LGA and locality boundaries with whole LGAs and localities located within the one division where possible.
- 90. The proposed Division of Canning has a projected enrolment of 96 717 which is a variation from the average projected enrolment of minus 2.98 per cent.

Cowan

91. The proposed Division of Cowan is surrounded by the Divisions of Hasluck, Moore, Pearce, Perth and Stirling – Figure E refers.




Figure E: Proposed Division of Cowan

- 95. The Division of Cowan is impacted by consequential changes flowing from the creation of the new division.
- The localities of Whiteman and Bennett Springs are moved from the Division of Pearce whilst Beechboro, Kiara and Lockridge are moved from the Division of Perth.
- 97. The localities of Banksia Grove and Mariginiup are transferred to the Division of Pearce, thereby reuniting the previously split suburb of Banksia Grove into the one division. The localities of Woodvale and the western portion of Kingsley are transferred to the Division of Moore. The locality of Kingsley is split along Goollelal Dr dividing the suburb at Lake Goollelal.
- 98. The Division of Cowan's proposed boundaries are primarily constructed from locality boundaries with whole localities located within the one division where possible.




Figure F: Proposed Division of Curtin



- 104. The existing Division of Curtin is within numerical parameters and does not technically require any alterations to its boundaries. However, as all of the surrounding divisions are above numerical tolerances, the Division of Curtin has experienced consequential changes in order to accommodate modifications required for other divisions.
- 105. In order to maintain the Swan River as a strong boundary between divisions and recognising a community of interest with its northern neighbours, the locality of North Fremantle is moved from the existing Division of Fremantle. The split localities of Doubleview and Innaloo are moved from the Division of Stirling, thereby reuniting those localities within one division. The localities of Osborne Park and Scarborough remain split between the Divisions of Stirling and Curtin. Osborne Park is divided by the Mitchell Fwy with the portion west of the freeway remaining in the Division of Curtin. The Division of Curtin gains the additional portion of Scarborough locality that is east of Duke St to the Doubleview locality border, to keep the division within numerical parameters.
- 106. The remainder of the Vincent LGA and the greater majority of Perth LGA is transferred to the Division of Perth, reuniting those LGAs in the one division. The localities of West Perth and King's Park are also transferred to the Division of Perth. The small portion of the Perth LGA that lies south of Mounts Bay Rd remains in the Division of Curtin as Mounts Bay Rd forms a stronger and more identifiable electoral boundary.
- 107. The Division of Curtin's proposed boundaries are constructed from the Indian Ocean, the Swan River, LGA and locality boundaries, with whole LGAs and localities located within the one division where possible.
- 108. The proposed Division of Curtin has a projected enrolment of 100 865 which is a variation from the average projected enrolment of plus 1.18 per cent.

Durack

- 113. The existing Division of Durack is within numerical parameters and does not technically require any alterations to its boundaries. However, small adjustments are made in order to accommodate changes made to the neighbouring Divisions of Forrest and O'Connor.
- 114. The LGAs of Bruce Rock, Narembeen, Quairading, Westonia and Yilgarn are transferred from the Division of O'Connor, thereby reuniting community of interests: these LGAs are now joined with the rest of the Wheatbelt sub-region of Central East in the Division of Durack.
- 115. The proposed division is constructed from whole LGAs utilising the Indian Ocean and LGA borders as its boundaries.




Figure H: Proposed Division of Forrest




Figure I: Proposed Division of Fremantle







- 135. The Division of Hasluck has contributed the highest number of electors to the new Division of Burt with substantial consequential elector movements required. More than one third of the Division of Hasluck's existing electors are transferred from the Gosnells LGA into the Division of Burt, utilising the Canning River as a strong border between the two divisions.
- 136. The Roe Hwy is utilised as a strong boundary with the transfer of the locality of High Wycombe, the remainder of Perth Airport and that portion of Forrestfield west of the Roe Hwy to the Division of Swan. The localities of Orange Grove and Martin are transferred to the Division of Canning. 






Figure M: Proposed Division of Pearce





- 162. The existing Division of Pearce has the highest projected growth of all divisions and therefore must contribute the highest number of electors to other divisions. The Division of Pearce is also impacted by its neighbouring Division of Hasluck contributing the highest number of electors to the creation of the new Division of Burt. - 171. The localities of Beechboro, Kiara and Lockridge are transferred to the Division of Cowan. The locality of Dianella is reunited in one division with the Division of Perth portion transferred to the Division of Stirling. 


Figure O: Proposed Division of Stirling




Figure P: Proposed Division of Swan



Chapter 3 What next?

This chapter outlines the legislative requirements that are to be met following the release of the proposed redistribution, through to the final determination of the names and boundaries of electoral divisions in Western Australia.

- 201. This report sets out the Committee's proposed boundaries and names of the federal electoral divisions for Western Australia, together with the Committee's reasons for this proposed redistribution. Interested individuals and organisations are able to consider this proposal and lodge objections prior to the finalisation of electoral boundaries and names by the augmented Electoral Commission.
- 202. The timetable for the remainder of this redistribution process is set out in Appendix H.

Invitation for objections

203. Written objections to any aspect of the proposed redistribution must be lodged with the Electoral Commission by 6pm (AWST) on Friday 18 September 2015. Any objections received after this time cannot be considered.

Invitation to provide comments on objections

- 204. All objections received will be made available for public inspection from Monday 21 September 2015 on the AEC website and at the office of the Australian Electoral Officer for Western Australia.
- 205. Interested individuals and organisations can lodge written comments on the objections with the Electoral Commission up until 6pm (AWST) on Friday 2 October 2015. Comments received after this time cannot be considered.
- 206. All comments received will be made available for public inspection from Monday 5 October 2015 on the AEC website and at the office of the Australian Electoral Officer for Western Australia.

Objections and comments on objections

- 207. Written objections and comments on objections are considered by the augmented Electoral Commission. The augmented Electoral Commission comprises of:
 - the three members of the Electoral Commission the Chairperson, the Electoral Commissioner and a non-judicial member, currently the Australian Statistician, and
 - the three remaining members of the Committee.
- 208. As part of its considerations, the augmented Electoral Commission may hold an inquiry into any objection or comment on an objection.

The second redistribution proposal

209. At the conclusion of its considerations, the augmented Electoral Commission will announce its own proposed redistribution. If the augmented Electoral Commission considers that this proposal is significantly different from the Committee's proposal, the augmented Electoral Commission will invite further objections. Advice will be provided should this prove necessary.

Final determination of boundaries and names of divisions

- 210. The augmented Electoral Commission will make a final determination of boundaries and names of the electoral divisions for Western Australia by way of notice published in the Gazette on 19 January 2016.
- 211. Copies of the augmented Electoral Commission's determination and reasons for that determination, together with the work of the Committee, will be tabled in both Houses of Parliament. Once this has occurred, this material will be made available to the public via the AEC website.

Appendix B: Operation of statutory requirements for the making of a proposed redistribution

Section 66 of the Electoral Act requires the Committee, in making its proposed redistribution of Western Australia, to abide by the following requirements:

- the Committee must ensure that the number of electoral divisions that Western Australia is to be divided into, is equal to the number of members of the House of Representatives to be chosen in Western Australia at the next general election, and
- the Committee must abide by the following requirements contained in section 66 of the Electoral Act:
 - (3) In making the proposed redistribution, the Redistribution Committee:
 - (a) shall, as far as practicable, endeavour to ensure that, if the State or Territory were redistributed in accordance with the proposed redistribution, the number of electors enrolled in each Electoral Division in the State or Territory would not, at the projection time determined under section 63A, be less than 96.5% or more than 103.5% of the average divisional enrolment of that State or Territory at that time; and
 - (b) subject to paragraph (a), shall give due consideration, in relation to each proposed Electoral Division, to:
 - (i) community of interests within the proposed Electoral Division, including economic, social and regional interests;
 - (ii) means of communication and travel within the proposed Electoral Division;
 - (iv) the physical features and area of the proposed Electoral Division; and
 - (v) the boundaries of existing Divisions in the State or Territory;

and subject thereto, the quota of electors for the State or Territory shall be the basis for the proposed redistribution, and the Redistribution Committee may adopt a margin of allowance, to be used whenever necessary, but in no case shall the quota be departed from to a greater extent than one-tenth more or one-tenth less.

(3A) When applying subsection (3), the Redistribution Committee must treat the matter in subparagraph (3)(b)(v) as subordinate to the matters in subparagraphs (3)(b)(i), (ii) and (iv).

These statutory requirements are expressed in a hierarchical order.

The purpose of paragraph 3(a) is suggested by its history. It has undergone some transformation since the *Commonwealth Electoral Legislation Amendment Act 1983* stipulated that boundaries were to be drawn, as far as practicable, to achieve equal numbers of electors in each of a state's divisions three-and-a-half years after a redistribution. By 1984 'it was observed that the three-and-a-half year rule had in some areas forced the adoption, on purely numerical grounds, of boundaries which took little account of perceived community of interest'.¹¹ Therefore, in 1987, the rule was relaxed to permit a measure of tolerance to plus or minus two per cent from average projected enrolment. Subsequently, the JSCEM concluded that:

the numerical criteria do not allow "due consideration", in the words of the Act, to be given to the qualitative factors. Rather, the political parties and others attempting to frame electoral boundaries essentially find themselves engaged in a mathematical modelling exercise. In order to relax the enrolment requirements to that extent necessary to allow a realistic degree of flexibility the Committee recommends ... that subsections 66(3)(a) and 73(4)(a) of the Electoral Act be amended, so as to extend the variation from average divisional enrolment allowed three-and-a-half years after a redistribution from two to 3.5 percent.¹²

The JSCEM also, in the same report, refers to its recommended amendment as one that 'would maintain substantial restrictions on malapportionment [and] would allow other legitimate policy objectives to be more effectively met'.

Paragraph 3(a) follows this recommendation. The terms of the recommendation, and the discussion which preceded it, make clear the purpose of paragraph 3(a), as it now stands, and how it was intended to interact with the other criteria set out in the sub-paragraphs of paragraph (b), to which also 'due consideration' must be given. The Committee has considered the suggestions and comments and made its proposed redistribution on this basis.

In summary, the primary criteria are to:

- endeavour to ensure that the number of electors in the proposed divisions are within a range of 3.5 per cent below or above the average divisional enrolment at the projection time, and
- ensure that current enrolments are within the range between 90 per cent and 110 per cent of the current enrolment quota.

The secondary criteria to be considered by the Committee are community of interests, means of communication and travel, physical features and area of proposed divisions. The Committee also considers the boundaries of existing divisions; however the Electoral Act stipulates that this criterion is subordinate to all other secondary criteria.

Appendix F: Guidelines for naming federal electoral divisions

Determining the names of federal electoral divisions is part of the process of conducting a federal redistribution within a state or territory.

The criteria used by redistribution committees to propose the names of electoral divisions, and used by the augmented Electoral Commission to determine the names of electoral divisions, have previously been the subject of recommendations from the JSCEM. From these recommendations, a set of guidelines were developed as a point of reference only.

It should be noted that redistribution committees and the augmented Electoral Commission are in no way bound by the guidelines.

Naming after persons

In the main, divisions should be named after deceased Australians who have rendered outstanding service to their country.

When new divisions are created, the names of former Prime Ministers should be considered.

Federation division names

Every effort should be made to retain the names of original federation divisions.

Geographical names

Locality or place names should generally be avoided, but in certain areas the use of geographical features may be appropriate (e.g. Perth).

Aboriginal names

Aboriginal names should be used where appropriate and as far as possible existing Aboriginal divisional names should be retained.

Other criteria

The names of federal divisions should not duplicate existing state districts.

Qualifying names may be used where appropriate (e.g. Melbourne Ports, Port Adelaide).

Names of divisions should not be changed or transferred to new areas without very strong reasons.

When two or more divisions are partially combined, as far as possible the name of the new division should be that of the old division which had the greatest number of electors within the new boundaries. However, where the socio-demographic nature of the division in question has changed significantly, this should override the numerical formula.

Appendix G: Description of the method used to calculate the areas of electoral divisions

The AEC maintains the electoral roll on the basis of alignment to Statistical Area 1s (SA1s), and is able to provide statistical data on enrolments and projected enrolments at this level. Accordingly, in formulating its proposals, the Committee utilised Western Australia's 5 599 SA1s as its basic building blocks. The SA1s have defined boundaries and are of differing population, area sizes and shapes. In a small number of cases where the Committee considered that a particular SA1 boundary did not form a strong electoral boundary, the SA1 was split along a stronger boundary.

The indicative area of each proposed electoral division has been calculated by aggregating the area of:

- all land-based SA1s,
- any parts of land-based SA1s, and
- any lakes, ponds, rivers, creeks, wetlands or marshes not already included in land-based SA1s that are contained within the divisional boundary of each electoral division.

Areas are calculated on the Geocentric Datum of Australia (GDA94) spheroid using the AEC's Electoral Boundary Mapping System (EBMS), developed within the 'MapInfo Professional' software package.

The Committee used EBMS to model and assess various boundary options. This system was also made available for public use during the comments period, and will be made available during the objections period at the office of the Australian Electoral Officer for Western Australia in Perth.
