RESOLUTION

Re-Affirming Closure of Blackfeet Tribe in Response to COVID-19 Outbreak on the Blackfeet Reservation

Resolution No. 268 - 2020

- WHEREAS, The Blackfeet Tribal Business Council is the duly constituted governing body within the exterior boundaries of the Blackfeet Indian Nation pursuant to Section 16 of Act of June 18, 1934 and Amendments thereof, and
- WHEREAS, The Blackfeet Tribal Business Council has been organized to represent, develop, protect and advance the views, interests, and resources education and resources of the Blackfeet Indian Reservation, and
- WHEREAS, The Blackfeet Tribal Business Council is empowered, pursuant to Article VI-Powers of the Council, Section 1(e) to manage all economic affairs and enterprises of the Blackfeet Reservation; and, Section 1(g) to manage tribal affairs in an acceptable and businesslike manner and in accordance with the administrative plan called the Plan of Operations; and, Section 1(k) to promulgate ordinances for the purposes of safeguarding the peace and safety of residents of the Blackfeet Indian Reservation, and
- WHEREAS, The Blackfeet Tribal Business Council passed the "Approving the Blackfeet Tribe COVID-19 Ordinance 121" to limit the risk of infection from the global pandemic outbreak of COVID-19 to members and residents of the Blackfeet Reservation, and such risk and community outbreak has occurred as of June 26, 2020 to which no containment has occurred, and

WHEREAS, The Blackfeet Tribal Business Council met on June 27, 2020 to take action to implement protective measures, to which now the Blackfeet Tribal Business Council further affirms such action, now

THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. MANDATORY 14 DAY STAY AT HOME ORDER. That the Blackfeet Tribal Business Council mandates all persons on the Blackfeet Reservation who are non-frontline workers to Stay at Home or are not engaged in essential activities such as to procure medical services and food.
- 2. **PROHIBITION ON ALL SOCIAL GATHERINGS.** That the Blackfeet Tribal Business Council hereby mandates that all social gatherings cease effective immediately. This mandate includes but is not limited to: Restaurant Dine-In, Campgrounds, Group Gatherings, Fishing Derbies, Golf, Weddings, Tribally hosted fireworks displays and Parade, etc. Curbside and Online Fireworks sales shall be permitted until July 4th at midnight; and, individuals may light fireworks without creating social gatherings on July 4th only.
- 3. **IDENTIFY FACILITY FOR OUARANTINE.** The Blackfeet Tribal Business Council hereby directs that a facility for quarantine be identified as soon as possible.
- 4. MASKS REOUIRED IN ALL AREAS OF THE BLACKFEET

 RESERVATION. The Blackfeet Tribal Business Council hereby orders all persons on the Blackfeet Reservation wear masks at all times while in public, and with the exception for children under two (2) years of age.
- 5. **Public Advertisement.** The Public Information Officer is hereby directed to make notice effective immediately of this Resolution to the local media. The Personnel Director shall issue a memo to the workforce immediately.
- 6. The Chairman or the Vice-Chairman in the Chairman's absence and the Secretary of the Blackfeet Tribal Business Council are hereby authorized to sign this Resolution and any other documents to effectuate the purposes of this Resolution.
