SELECTING THE VOTES

The Center for Legislative Accountability (CLA), an initiative of the CPAC Foundation, is the premier organization for holding lawmakers accountable. The CLA produces the longest-running conservative congressional scorecard and our state program is the only one in the nation that scores all 8,000 lawmakers in the 50 states across every policy area.

In 1971, ACUF launched its Ratings of Congress to provide a comprehensive evaluation of the voting records of every Member of Congress. The Ratings quickly became considered the "gold standard" and over the following decades have been utilized by activists, voters, academics and elected officials to determine which lawmakers best adhere to conservative principles.

In 2011, these Ratings were expanded into state legislatures as part of a five-state pilot program. By 2015, Ratings of the States grew to include all 50 states and all 99 legislative chambers. Today, the CLA annually analyzes over 105,000 pieces of legislation to issue scores for all of America's federal and state lawmakers and presents awards to lawmakers who score 80% or better in recognition of their conservative voting records.

In order to depict how closely a lawmaker adheres to conservative principles, the CLA selects from the full spectrum of issues relating to the economy, culture, national security and government integrity. Some key areas include taxation, spending, education, labor, licensure, regulation, environment, life, free speech, Second Amendment rights, foreign aid, defense priorities and global organizations, including the United Nations. All congressional and state analyses are conducted after the adjournment of a legislative session to ensure that no issue is neglected.

To determine legislative rankings, the CLA annually evaluates over 105,000 bills that were introduced in Congress and every convening state legislature running from January 1 to December 31.

Of those bills, the CLA ultimately selects roughly 2,000 pieces of legislation that best illustrate how elected officials view the role of government in an individual's life. The CLA calculates individual scores for a total of nearly 8,000 federal and state lawmakers based on over 157,000 votes cast on the 2,000 bills selected.







HB 2108 Protecting the Unemployment Compensation System Against Fraud.

This bill increases the amount of job search efforts that a person must make in order for them to be eligible to receive unemployment compensation in a given week. For example, individuals must not only make one or two job contacts per day but must also attend interviews and job fairs and submit resumes to employers. The bill also requires compensation claims to be cross-checked against various databases every week before being approved. CPAC supports efforts to crack down on unemployment insurance fraud and supported this bill. The Senate passed this bill on April 4, 2023 by a vote of 16-14 but the bill was vetoed by Governor Hobbs.

HB 2254 Keeping the Bureaucracy in Check.

This bill requires that, if a bureaucratic regulation is expected to incur costs over \$500,000 within 5 years after its implementation, the agency promulgating the regulation first receive permission from the legislature prior to enacting the regulation. CPAC supports efforts to increase legislative oversight over the bureaucracy and supported this bill. The Senate passed this bill on April 4, 2023 by a vote of 16-14 but the bill was vetoed by Governor Hobbs.

HB 2305 Improving Signature Verification Procedures During Elections.

This bill, the likes of which is one of numerous election reform bills that the legislature attempted to pass in 2023, requires that both a Democrat and a Republican be permitted to oversee the signature verification process for early, provisional, and conditional provisional ballots. CPAC supports efforts to shore up election security and supported this bill. The Senate passed this bill on April 11, 2023 by a vote of 16-13 but the bill was vetoed by Governor Hobbs.

HB 2309 Helping Ensure that Federal Immigration Laws are Enforced.

This bill prohibits state entities from interfering in the enforcement of federal immigration laws. CPAC supports efforts to secure the Southern border of the US and supported this bill. The Senate passed this bill on April 4, 2023 by a vote of 16-14 but the bill was vetoed by Governor Hobbs.

HB 2379 Preventing Infringements on the Property Rights of Hotels and Other Similar Establishments.

This bill prohibits the government from requiring hotels and motels to participate in programs that offer housing vouchers to homeless people such that they may occupy "unoccupied" hotel rooms. CPAC opposes government efforts to cram down regulations and programs onto hotels, opposes this form of twisted welfare, and supported this bill. The Senate passed this bill on April 12, 2023 by a vote of 16-13 but the bill was vetoed by Governor Hobbs.





HB 2394 Further Protecting Second Amendment Freedoms from Federal Overreach.

This bill makes it such that the state may not enforce any taxes, levies, or fees imposed by the federal government on the sale of firearms. CPAC supports the founders' belief in the Second Amendment and supported this bill. The Senate passed this bill on April 12, 2023 by a vote of 16-14 but the bill was vetoed by Governor Hobbs.

HB 2472 Removing the Threat of a State-Sponsored Social Credit Score.

This bill states that the government may not require banks or other financial institutions to use a social credit score when deciding whether or not they should lend money to a customer. CPAC opposes government-imposed social credit scores and supported this bill. The Senate passed this bill on March 28, 2023 by a vote of 16-13 but the bill was vetoed by Governor Hobbs.

HB 2505 Extending the Life of Unnecessary Bureaucracies.

This bill extends the sunset date on the Arizona Outdoor Recreation Coordinating Commission to July 1, 2031. This commission, in part, establishes "equitable" criteria for the distribution of funding to outdoor recreation causes. CPAC does not believe that the government should involve itself in this way in outdoor recreation, opposes the use of equity in determining how funding is allocated, and opposed this bill. The Senate passed this bill on April 13, 2023 by a vote of 20-7 and the bill later became law.

HB 2507 Extending the Life of the Grain Research and Promotion Council.

This bill extends the sunset date of the Grain Research and Promotion Council to 2031. CPAC does not believe that the government should possess bureaucracies that favor specific agricultural industries and opposed this bill. The Senate passed this bill on May 9, 2023 by a vote of 23-7 and the bill later became law.

HB 2545 Protecting Arizona's Democracy Against Globalist Influences.

This bill prohibits the state from using its resources to enforce public health orders issued by intergovernmental health organizations. It also limits the ability of the governor to declare and prolong emergencies. CPAC supports measures that diminish the ability of the WHO to influence domestic policy, supports measures that strengthen the influence of the people's will on politics, and supported this bill. The Senate passed this bill on April 12, 2023 by a vote of 16-13 but the bill was vetoed by Governor Hobbs.





HB 2552 Taking Down Unjust Voting Methods in Arizona.

This bill prohibits localities from using ranked choice voting methods when determining the winner of a particular election. Ranked choice voting, in some instances, allows those who receive the second highest number of votes to win the election by apportioning votes from other losing candidates to that person. CPAC believes that those who come in first in an election should win the election and supported this bill. The Senate passed this bill on April 5, 2023 by a vote of 16-14 but the bill was vetoed by Governor Hobbs.

HB 2675 Declaring Drug Cartels to be Terrorist Organizations.

This bill states that drug cartels are now to be considered and treated as terrorist organizations by the state. CPAC recognizes that drug cartels are responsible for the deaths of thousands of Americans, approves of appropriate efforts to subdue them, and supported this bill. The Senate passed this bill on April 5, 2023 by a vote of 16-14 but the bill was vetoed by Governor Hobbs.

SB 1001 Improving Parental Rights in Education.

This bill prohibits the employees or independent contractors of school districts from referring to a student using pronouns that do not align with their sex without the express consent of that student's parent. CPAC supports parental rights in education and supported this bill. The Senate passed this bill on March 1, 2023 by a vote of 16-12 but the bill was vetoed by Governor Hobbs.

SB 1009 Protecting the Nation's Monuments and Statues.

This bill makes it a crime of aggravated criminal damage to deface or tamper with a public or private monument, memorial, or statue. CPAC believes that voters and elected officials should oversee what monuments are put on display (not unruly mobs), opposes the wanton destruction of public and private property, and supported this bill. The Senate passed this bill on March 1, 2023 by a vote of 16-12 but the bill was vetoed by Governor Hobbs.

SB 1026 No Taxpayer Funds for Drag Shows for Minors.

This bill prohibits the government from using taxpayer funds to pay for drag shows targeted at minors. CPAC does not believe that minors should watch drag shows, believes that it is inappropriate to force taxpayers to pay for drag shows for minors, and supported this bill. The Senate passed this bill on June 13, 2023 by a vote of 16-12 but the bill was vetoed by Governor Hobbs.





SB 1040 Protecting the Privacy of Intimate Spaces at Public Schools.

This bill opens schools up to civil actions if they allow people to enter bathrooms that are not designated for members of their sex. CPAC supports efforts to create a safe and private environment within school bathrooms and supported this bill. The Senate passed this bill on February 28, 2023 by a vote of 16-14 but the bill was vetoed by Governor Hobbs.

SB 1074 Protecting the Security of Ballot Tabulating Machines.

This bill requires that electronic equipment used to administer elections meet the standards set by the Department of Defense for cybersecurity. CPAC supports efforts to protect the state's elections against foreign interference and supported this bill. The Senate passed this bill on March 6, 2023 by a vote of 16-13 but the bill was vetoed by Governor Hobbs.

SB 1102 Extending the Life of One of Maricopa County's Taxes.

The final version of this bill extends the life of the Maricopa County transportation excise tax by upwards of 20 years. It then devotes 37% of the proceeds from this tax to the public transit system. CPAC opposes measures that increase the tax burden on citizens and opposed this bill as a step in the wrong direction. The Senate passed the final version of this bill on July 31, 2023 by a vote of 19-7 and the bill later became law.

SB 1109 Removing a Ban on Certain Firearms Accessories.

This bill repeals a provision from public law that banned the possession of gun silencers. CPAC supports the founders' belief in the Second Amendment and supported this bill. The Senate passed this bill on February 21, 2023 by a vote of 16-13 but the bill was vetoed by Governor Hobbs.

SB 1146 Divesting from Companies that Fund Abortionists and Trans Indoctrination.

This bill requires the state to create a process that will help it divest itself from companies that donate to and support abortionists and organizations that attempt to provide young individuals with sexually explicit materials. CPAC believes abortion is always a human tragedy, opposes radical Left-wing gender ideology, believes that taxpayer funds should not help fund either of these causes, and supported this bill. The House passed this bill on March 1, 2023 by a vote of 16-12 but the bill was vetoed by Governor Hobbs.





SB 1234 Exterminating Some Mechanisms of Taxation by Citation.

This bill prohibits municipalities and agencies from using speed cameras in order to issue tickets to drivers for speeding. CPAC opposes the use of automated traffic enforcement systems and supported this bill. The Senate passed this bill on February 15, 2023 by a vote of 16-13 but the bill was vetoed by Governor Hobbs.

SB 1305 Cracking Down on CRT in Schools.

This bill prohibits schools from teaching curricula that supports certain divisive principles. These principles include those that state that one is inherently responsible for the malfeasance of past members of their race, that one is inherently racist because of their race, and that meritocracy is racist. CPAC opposes the teaching of CRT and CRT-adjacent principles in schools and supported this bill. The Senate passed this bill on February 16, 2023 by a vote of 16-12 but the bill was vetoed by Governor Hobbs.

SB 1410 Allowing Parents to File Complaints Against Schools.

This bill permits parents to file complaints against a state educational institution if the parent believes that the state is violating the rights of the parent or the student. CPAC supports parental rights in education and supported this bill. The Senate passed this bill on June 13, 2023 by a vote of 16-12 but the bill was vetoed by Governor Hobbs.

SB 1462 Appropriating Millions to the Welfare State.

This bill apportions \$25,000,000 to the Department of Economic Security for "coordinated homeless services." CPAC opposes measures that inappropriately promote and fund the welfare state and opposed this bill. The Senate passed this bill on March 21, 2023 by a vote of 21-8 but the bill never became law.

SB 1500 Protecting Arizona's State Investments from ESG-Obsessed Public Fiduciaries.

This bill prohibits public fiduciaries from investing funds from the states retirement plans exclusively to further ESG objectives. It also requires the State Treasurer to publish the list of investments that the state has made on a publicly-accessible website. CPAC supports efforts to diminish the influence of ESG standards in the government's decision-making processes and supported this bill. The Senate passed this bill on February 28, 2023 by a vote of 16-14 but the bill was vetoed by Governor Hobbs.





SB 1600 Improving Laws Already Set in Place to Protect Life.

This bill makes it such that babies born following a failed abortion must now be treated as legal people by physicians. It additionally strengthens the responsibility that physicians possess to protect the lives of these born-alive infants. CPAC opposes infanticide, believes that physicians should protect the lives of infants, and supported this bill. The Senate passed this bill on February 22, 2023 by a vote of 16-13 but the bill was vetoed by Governor Hobbs.

SB 1611 Protecting the Procurement Process from the Excesses of ESG Objectives.

This bill prohibits the government from requiring that a company adopt an ESG standards policy in order to enter into a contract with the government. CPAC supports measures to diminish the influence of ESG standards in the government's halls of power and supported this bill. The Senate passed this bill on March 14, 2023 by a vote of 16-14 but the bill was vetoed by Governor Hobbs.

SB 1658 Protecting Critical Infrastructure from Foreign Interference.

This bill prohibits the state government from entering into agreements involving critical infrastructure if that agreement would give the government or citizens of China, North Korea, Russia, or Iran access to or control over critical infrastructure. CPAC supports appropriate efforts to protect the US' critical infrastructure from interference by America's opposition and supported this bill. The Senate passed this bill on June 13, 2023 by a vote of 16-12 but the bill was vetoed by Governor Hobbs.

HB 2108 Protecting the Unemployment Compensation System Against Fraud.

This bill increases the amount of job search efforts that a person must make in order for them to be eligible to receive unemployment compensation in a given week. For example, individuals must not only make one or two job contacts per day but must also attend interviews and job fairs and submit resumes to employers. The bill also requires compensation claims to be cross-checked against various databases every week before being approved. CPAC supports efforts to crack down on unemployment insurance fraud and supported this bill. The House passed this bill on May 15, 2023 by a vote of 31-27 but the bill was vetoed by Governor Hobbs.

HB 2254 Keeping the Bureaucracy in Check.

This bill requires that, if a bureaucratic regulation is expected to incur costs over \$500,000 within 5 years after its implementation, the agency promulgating the regulation first receive permission from the legislature prior to enacting the regulation. CPAC supports efforts to increase legislative oversight over the bureaucracy and supported this bill. The House passed this bill on May 15, 2023 by a vote of 31-27 but the bill was vetoed by Governor Hobbs.

HB 2305 Improving Signature Verification Procedures During Elections.

This bill, the likes of which is one of numerous election reform bills that the legislature attempted to pass in 2023, requires that both a Democrat and a Republican be permitted to oversee the signature verification process for early, provisional, and conditional provisional ballots. CPAC supports efforts to shore up election security and supported this bill. The House passed this bill on May 15, 2023 by a vote of 31-26 but the bill was vetoed by Governor Hobbs.

HB 2309 Helping Ensure that Federal Immigration Laws are Enforced.

This bill prohibits state entities from interfering in the enforcement of federal immigration laws. CPAC supports efforts to secure the Southern border of the US and supported this bill. The House passed this bill on May 15, 2023 by a vote of 31-26 but the bill was vetoed by Governor Hobbs.

HB 2379 Preventing Infringements on the Property Rights of Hotels and Other Similar Establishments.

This bill prohibits the government from requiring hotels and motels to participate in programs that offer housing vouchers to homeless people such that they may occupy "unoccupied" hotel rooms. CPAC opposes government efforts to cram down regulations and programs onto hotels, opposes this form of twisted welfare, and supported this bill. The House passed this bill on February 21, 2023 by a vote of 31-29 but the bill was vetoed by Governor Hobbs.





HB 2394 Further Protecting Second Amendment Freedoms from Federal Overreach.

This bill makes it such that the state may not enforce any taxes, levies, or fees imposed by the federal government on the sale of firearms. CPAC supports the founders' belief in the Second Amendment and supported this bill. The House passed this bill on April 12, 2023 by a vote of 31–29 but the bill was vetoed by Governor Hobbs.

HB 2472 Removing the Threat of a State-Sponsored Social Credit Score.

This bill states that the government may not require banks or other financial institutions to use a social credit score when deciding whether or not they should lend money to a customer. CPAC opposes government-imposed social credit scores and supported this bill. The House passed this bill on February 21, 2023 by a vote of 31-28 but the bill was vetoed by Governor Hobbs.

HB 2499 Creating a New Pilot Program within Arizona's Welfare System.

This bill establishes a pilot program that allows individuals who, because of their income, no longer qualify for SNAP benefits to receive nutrition assistance. CPAC opposes the creation of new welfare programs and opposed this bill. The House passed this bill on March 8, 2023 by a vote of 40-18 but the bill never became law.

HB 2505 Extending the Life of Unnecessary Bureaucracies.

This bill extends the sunset date on the Arizona Outdoor Recreation Coordinating Commission to July 1, 2031. This commission, in part, establishes "equitable" criteria for the distribution of funding to outdoor recreation causes. CPAC does not believe that the government should involve itself in this way in outdoor recreation, opposes the use of equity in determining how funding is allocated, and opposed this bill. The House passed this bill on February 20, 2023 by a vote of 52-4 and the bill later became law.

HB 2507 Extending the Life of the Grain Research and Promotion Council.

This bill extends the sunset date of the Grain Research and Promotion Council to 2031. CPAC does not believe that the government should possess bureaucracies that favor specific agricultural industries and opposed this bill. The House passed this bill on March 7, 2023 by a vote of 52-8 and the bill later became law.





HB 2545 Protecting Arizona's Democracy Against Globalist Influences.

This bill prohibits the state from using its resources to enforce public health orders issued by intergovernmental health organizations. It also limits the ability of the governor to declare and prolong emergencies. CPAC supports measures that diminish the ability of the WHO to influence domestic policy, supports measures that strengthen the influence of the people's will on politics, and supported this bill. The House passed this bill on May 15, 2023 by a vote of 31-27 but the bill was vetoed Governor Hobbs.

HB 2552 Taking Down Unjust Voting Methods in Arizona.

This bill prohibits localities from using ranked choice voting methods when determining the winner of a particular election. Ranked choice voting, in some instances, allows those who receive the second highest number of votes to win the election by apportioning votes from other losing candidates to that person. CPAC believes that those who come in first in an election should win the election and supported this bill. The House passed this bill on March 1, 2023 by a vote of 31-28 but the bill was vetoed by Governor Hobbs.

HB 2675 Declaring Drug Cartels to be Terrorist Organizations.

This bill states that drug cartels are now to be considered and treated as terrorist organizations by the state. CPAC recognizes that drug cartels are responsible for the deaths of thousands of Americans, approves of appropriate efforts to subdue them, and supported this bill. The House passed this bill on March 1, 2023 by a vote of 31-28 but the bill was vetoed by Governor Hobbs.

SB 1001 Improving Parental Rights in Education.

This bill prohibits the employees or independent contractors of school districts from referring to a student using pronouns that do not align with their sex without the express consent of that student's parent. CPAC supports parental rights in education and supported this bill. The House passed this bill on May 15, 2023 by a vote of 31-27 but the bill was vetoed by Governor Hobbs.

SB 1009 Protecting the Nation's Monuments and Statues.

This bill makes it a crime of aggravated criminal damage to deface or tamper with a public or private monument, memorial, or statue. CPAC believes that voters and elected officials should oversee what monuments are put on display (not unruly mobs), opposes the wanton destruction of public and private property, and supported this bill. The House passed this bill on March 29, 2023 by a vote of 31-26 but the bill was vetoed by Governor Hobbs.





SB 1026 No Taxpayer Funds for Drag Shows for Minors.

This bill prohibits the government from using taxpayer funds to pay for drag shows targeted at minors. CPAC does not believe that minors should watch drag shows, believes that it is inappropriate to force taxpayers to pay for drag shows for minors, and supported this bill. The House passed this bill on May 15, 2023 by a vote of 31-27 but the bill was vetoed by Governor Hobbs.

SB 1040 Protecting the Privacy of Intimate Spaces at Public Schools.

This bill opens schools up to civil actions if they allow people to enter bathrooms that are not designated for members of their sex. CPAC supports efforts to create a safe and private environment within school bathrooms and supported this bill. The Senate passed this bill on May 15, 2023 by a vote of 31–27 but the bill was vetoed by Governor Hobbs.

SB 1074 Protecting the Security of Ballot Tabulating Machines.

This bill requires that electronic equipment used to administer elections meet the standards set by the Department of Defense for cybersecurity. CPAC supports efforts to protect the state's elections against foreign interference and supported this bill. The House passed this bill on March 30, 2023 by a vote of 31-27 but the bill was vetoed by Governor Hobbs.

SB 1102 Extending the Life of One of Maricopa County's Taxes.

The final version of this bill extends the life of the Maricopa County transportation excise tax by upwards of 20 years. It then devotes 37% of the proceeds from this tax to the public transit system. CPAC opposes measures that increase the tax burden on citizens and opposed this bill as a step in the wrong direction. The House passed the final version of this bill on July 31, 2023 by a vote of 43-14 and the bill later became law.

SB 1109 Removing a Ban on Certain Firearms Accessories.

This bill repeals a provision from public law that banned the possession of gun silencers. CPAC supports the founders' belief in the Second Amendment and supported this bill. The House passed this bill on April 4, 2023 by a vote of 31-28 but the bill was vetoed by Governor Hobbs.

SB 1146 Divesting from Companies that Fund Abortionists and Trans Indoctrination.

This bill requires the state to create a process that will help it divest itself from companies that donate to and support abortionists and organizations that attempt to provide young individuals with sexually explicit materials. CPAC believes abortion is always a human tragedy, opposes radical Left-wing gender ideology, believes that taxpayer funds should not help fund either of these causes, and supported this bill. The House passed this bill on May 15, 2023 by a vote of 31-27 but the bill was vetoed by Governor Hobbs.





SB 1234 Exterminating Some Mechanisms of Taxation by Citation.

This bill prohibits municipalities and agencies from using speed cameras in order to issue tickets to drivers for speeding. CPAC opposes the use of automated traffic enforcement systems and supported this bill. The House passed this bill on May 15, 2023 by a vote of 32–26 but the bill was vetoed by Governor Hobbs.

SB 1305 Cracking Down on CRT in Schools.

This bill prohibits schools from teaching curricula that supports certain divisive principles. These principles include those that state that one is inherently responsible for the malfeasance of past members of their race, that one is inherently racist because of their race, and that meritocracy is racist. CPAC opposes the teaching of CRT and CRT-adjacent principles in schools and supported this bill. The House passed this bill on February 21, 2023 by a vote of 31-29 but the bill was vetoed by Governor Hobbs.

SB 1410 Allowing Parents to File Complaints Against Schools.

This bill permits parents to file complaints against a state educational institution if the parent believes that the state is violating the rights of the parent or the student. CPAC supports parental rights in education and supported this bill. The House passed this bill on May 15, 2023 by a vote of 31-27 but Governor Hobbs vetoed the bill.

SB 1500 Protecting Arizona's State Investments from ESG-Obsessed Public Fiduciaries.

This bill prohibits public fiduciaries from investing funds from the states retirement plans exclusively to further ESG objectives. It also requires the State Treasurer to publish the list of investments that the state has made on a publicly-accessible website. CPAC supports efforts to diminish the influence of ESG standards in the government's decision-making processes and supported this bill. The House passed this bill on May 15, 2023 by a vote of 31-27 but the bill was vetoed by Governor Hobbs.

SB 1600 Improving Laws Already Set in Place to Protect Life.

This bill makes it such that babies born following a failed abortion must now be treated as legal people by physicians. It additionally strengthens the responsibility that physicians possess to protect the lives of these born-alive infants. CPAC opposes infanticide, believes that physicians should protect the lives of infants, and supported this bill. The Senate passed this bill on March 30, 2023 by a vote of 32-26 but the bill was vetoed by Governor Hobbs.





SB 1611 Protecting the Procurement Process from the Excesses of ESG Objectives.

This bill prohibits the government from requiring that a company adopt an ESG standards policy in order to enter into a contract with the government. CPAC supports measures to diminish the influence of ESG standards in the government's halls of power and supported this bill. The House passed this bill on Ma7 15, 2023 by a vote of 31-27 but the bill was vetoed by Governor Hobbs.

SB 1658 Protecting Critical Infrastructure from Foreign Interference.

This bill prohibits the state government from entering into agreements involving critical infrastructure if that agreement would give the government or citizens of China, North Korea, Russia, or Iran access to or control over critical infrastructure. CPAC supports appropriate efforts to protect the US' critical infrastructure from interference by America's opposition and supported this bill. The House passed this bill on May 15, 2023 by a vote of 36-22 but the bill was vetoed by Governor Hobbs.
