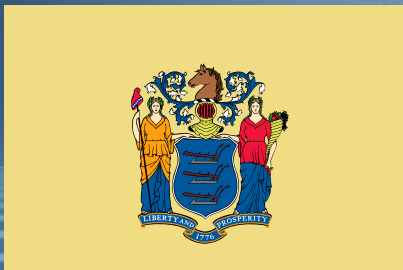

## ABOUT THE CENTER FOR LEGISLATIVE ACCOUNTABILITY

The Center for Legislative Accountability (CLA), an initiative of the American Conservative Union Foundation (ACUF), is the premier organization for holding lawmakers accountable. The CLA produces the longest-running conservative congressional scorecard and our state program is the only one in the nation that scores all 8,000 lawmakers in the 50 states across every policy area. In addition to ACUF's Conservative Political Action Conference (CPAC), the largest gathering of conservatives in the world, the CLA develops conservative policy solutions and educates everyday citizens and activists on the proper role of government. In 1971, ACUF launched its *Ratings of Congress* to provide a comprehensive evaluation of the voting records of every Member of Congress.

The Ratings quickly became considered the "gold standard" and over the following decades have been utilized by activists, voters, academics and elected officials to determine which lawmakers best adhere to conservative principles. In 2011, these Ratings were expanded into state legislatures as part of a five-state pilot program. By 2015, *Ratings of the States* grew to include all 50 states and all 99 legislative chambers.

Today, the CLA annually analyzes over 105,000 pieces of legislation to issue scores for all of America's federal and state lawmakers and presents awards to lawmakers who score 80% or better in recognition of their conservative voting records.

## METHODOLOGY

The CLA's Ratings of Congress and the States illustrate how elected officials view the role of government in an individual's life. When determining a position on a particular issue, the CLA begins by defining conservatism: the political philosophy that sovereignty resides in the person. Then, we apply the founders' belief that the proper role of government is to protect Life, Liberty and Property.

In order to depict how closely a lawmaker adheres to conservative principles, the CLA selects from the full spectrum of issues relating to the economy, culture, national security and government integrity. Some key areas include taxation, spending, education, labor, licensure, regulation, environment, life, free speech, Second Amendment rights, foreign aid, defense priorities and global organizations, including the United Nations. All congressional and state analyses are conducted after the adjournment of a legislative session to ensure that no issue is neglected.

Each lawmaker is evaluated on a zero to 100 scale, with a score of 100 representing a voting record that is perfectly aligned with conservative principles. Officials who earn a score of 90% or higher are presented with the CLA's highest honor, the Award for Conservative Excellence, while those who earn a score of 80% or higher, but less than 90%, are presented with the Award for Conservative Achievement. Additionally, any lawmaker who earns a score of 10% or lower qualifies for the ACUF's Coalition of the Radical Left.

To determine legislative rankings, the CLA annually evaluates over 105,000 bills that were introduced in Congress and every convening state legislature running from January 1 to December 31. Of those bills, the CLA ultimately selects roughly 2,000 pieces of legislation that best illustrate how elected officials view the role of government in an individual's life. The CLA calculates individual scores for a total of nearly 8,000 federal and state lawmakers based on over 157,000 votes cast on the 2,000 bills selected. The CLA provides a score for each legislative chamber, which is based upon the average scores of all members within that respective chamber. A legislature's overall score is calculated by averaging each state's two legislative chambers together in order to better reflect the differences in political power between the chambers. (The exception being Nebraska, the nation's only unicameral legislature comprising a single legislative chamber, on which the state's overall score is based.)

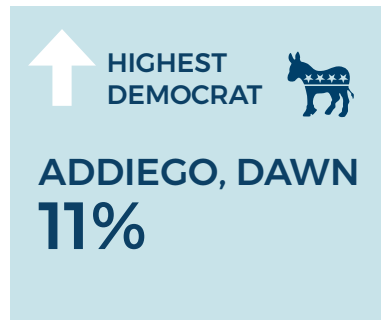
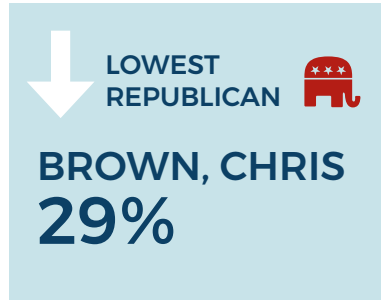
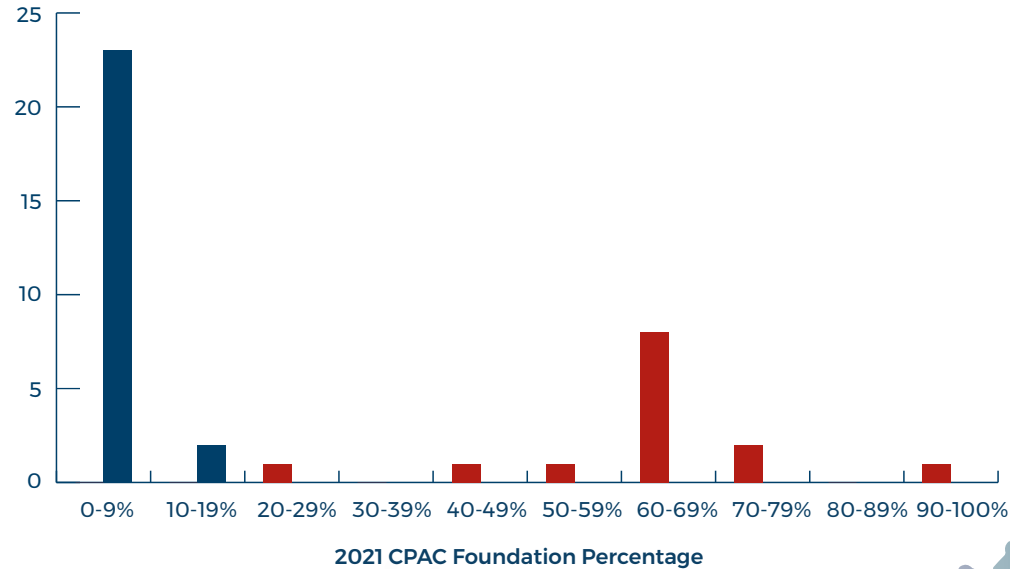


### NEW JERSEY SENATE CONSERVATIVE RATINGS

## NEW JERSEY SENATE VOTE DESCRIPTIONS

1. **A 12 Further Socializing Higher Education Costs Through New Subsidies Under the So-Called "College Affordability Act".** ACU believes higher education subsidies represent one of the largest transfers of wealth, especially at the expense of individuals who wish to pursue careers that do not require degrees such as the trades and small business. ACU opposes further socializing the costs of countless Woke Leftist degree programs and believes the best way to make college truly "affordable" is by eliminating wasteful programs and useless administrative positions and opposed this bill. The Senate passed the bill on June 24, 2021 by a vote of 39-0 and the bill was signed into law.
2. **SR 106 Advancing a Partisan Political Attack by Urging the Impeachment of President Donald J. Trump.** ACU recognizes that on multiple occasions President Trump called for the protests on January 6th to remain peaceful. ACU further recognizes that at the time of this vote President Trump had only nine days remaining in office and this call for impeachment solely serves as a personal political attack to prevent President Trump from seeking a future term and deny him government benefits and Secret Service protection as a private citizen. ACU opposes this partisan attack on the president and opposed this resolution. The Senate passed the resolution on January 11, 2021 by a vote of 24-5.
3. **SCR 117 Amending the Constitution to Provide a Crucial Legislative Check on the Governor's Emergency Powers (Motion to Defeat).** ACU supports this critical check on executive branch powers, especially considering the authoritarian actions taken by Gov. Phil Murphy throughout the COVID-19 pandemic and supported this resolution. The Senate voted to table (Defeat) the bill on March 25, 2021 by a vote of 19-13. (A "no" vote supported the ACU position.)
4. **S 703 Increasing Health Care Costs by Requiring Hospitals to Provide Implicit Bias Training.** ACU supports equal rights under the law for all, believes all individuals should be treated with dignity and respect. ACU opposes this measure designed to enrich radical leftists consultants at the expense of patients and opposed this bill. The Senate passed the bill on March 25, 2021 by a vote of 26-0 and the bill was signed into law.
5. **S 853 Hiking Taxpayer Costs and Enriching Unions Through Protectionist "Buy American" Procurement Mandates for Highway and Bridge Projects.** ACU opposes protectionist mandates which unnecessarily drive-up taxpayer costs by prohibiting procurement of products that are of the highest quality and greatest value to taxpayers and are primarily designed to enrich unions and other special interest groups and opposed this bill. The Senate concurred with the governor's recommendations on June 21, 2021 by a vote of 40-0 and the bill was signed into law.
6. **S 942 Reducing Unnecessary Occupational Licensing Barriers for Reformed Individuals with Prior Criminal Convictions.** ACU's Nolan Center for Justice is a national leader in criminal justice reform and works to cut crime, reduce taxpayer costs, protect victims, define the proper scope of government, and safely reduce incarceration rates. ACU opposes the proliferation of licensing requirements which are primarily designed to restrict competition, supports efforts to lower recidivism by reducing barriers to the workforce and supported this bill. The bill passed the Senate on March 25, 2021 by a vote of 37-0 and the bill was signed into law.
7. **S 989 Driving Up Transportation Costs Through New Prevailing Wage Mandates at Airports and Train Stations.** ACU opposes these artificial wages that unnecessarily drive-up transportation costs and reduce employment opportunities and opposed this bill. The Senate passed the bill on February 19, 2021 by a vote of 23-12 and the bill was signed into law.
8. **S 1010 Indebting Taxpayers by Authorizing Localities to Issue Bonds for the Purchase of Alternative Fuel and Electric Vehicles.** ACU opposes the authorization of greater municipal and local debt, especially for the purpose of advancing the leftist environmental agenda surrounding electric vehicles and opposed this bill. The Senate passed the bill on June 30, 2021 by a vote of 28-10 and the bill was signed into law.
9. **S 1144 Advancing the State's War on Individual Liberties by Banning the Sale of Tobacco and Vaping Products at Pharmacies and Major Department Stores.** ACU opposes this measure which restricts competition and serves as yet another tool to grow the nanny state and advance the state's war on individual liberties and opposed this bill. The Senate passed the bill on February 22, 2021 by a vote of 25-12. (The bill failed to advance in the Assembly.)



10. **A 1536 Hiking Taxpayer Costs by Expanding Prevailing Wage Mandates to Include Public Sign Fabrication.** ACU has long opposed prevailing wage mandates which needlessly drives up the costs of taxpayer-funded public works projects and opposed this bill. The Senate passed the bill on June 21, 2021 by a vote of 36-2 and the bill was signed into law.
- 
11. **A 1653 Encouraging Localities to Socialize Electric Vehicle Infrastructure in their Redevelopment Plans.** ACU supports all vehicle propulsion systems and believes the free market and private sector is the best institution to expand electrification. ACU opposes the advancement of yet another mechanism to socialize vehicle costs and opposed this bill. The Senate passed the bill on June 3, 2021 by a vote of 33-2 and the bill was signed into law. (The Assembly voted in 2020.)
- 
12. **S 2039 Distorting the Marketplace by Imposing Price Controls on Men and Women's Products and Services to End the So-Called "Pink Tax".** ACU believes empowering the free market and reducing anti-competitive barriers and regulations is the best way to prevent discrimination and lower the costs of goods and services for consumers of all backgrounds. ACU opposes this measure which further distorts the marketplace, leading to higher costs and less consumer choice, and opposed this bill. The Senate passed the bill on June 30, 2021 by a vote of 35-0. (The bill failed to advance in the Assembly.)
- 
13. **A 2374 Placing Taxpayers at Risk Through a Commercial Property Assessed Clean Energy (C-PACE) Scheme.** ACU has long opposed Property Assessed Clean Energy (PACE) schemes which harm the lending industry and place taxpayers at risk in the event of a default and opposed this bill. The Senate passed the bill on June 24, 2021 by a vote of 38-1 and the bill was signed into law.
- 
14. **S 2515 Hiking Consumer Costs by Banning Styrofoam and Imposing Recycled Content Mandates on Consumer Plastic Products.** ACU opposes this attack on the offerings of the private sector which unnecessarily drive-up consumer costs in order to advance a politicized Leftist environmental agenda and opposed this bill. The Senate passed the bill on June 24, 2021 by a vote of 22-14. (The bill failed to advance in the Assembly in 2021.)
- 
15. **S 2600 Increasing Transparency and Accountability Within the Incompetent New Jersey Transit Corporation.** ACU supports efforts to increase government transparency as well as cut waste, fraud and abuse by holding New Jersey Transit bureaucrats accountable – especially considering the entity receives over a billion dollars of taxpayer funds – and supported this bill as a step in the right direction. The Senate passed the bill on December 2, 2021 by a vote of 25-5. (The bill failed to advance in the Assembly.)
- 
16. **S 2769 Advancing Government Racial Discrimination Through a New Program which Provides Grants to Only "Minority" Businesses.** ACU supports equal rights and opportunities under the law for all, and believes it is the role of government to apply all laws equally. ACU opposes measures which socialize private business investment onto taxpayers – especially on the grounds of racial discrimination – and opposed this bill. The Senate passed the bill on January 28, 2021 by a vote of 30-1. (The bill failed to advance in the Assembly.)
- 
17. **S 2834 Forcing Teachers to Undergo Training on Critical Race Theory and Other Leftist Propaganda.** ACU opposes taking away the ability of teachers to receive valuable training in core education fields and instead indoctrinate them with Leftist propaganda and enrich the companies and providers of such training and opposed this bill. The Senate passed the bill on December 20, 2021 by a vote of 32-6 and the bill was signed into law.
- 
18. **S 3091 Socializing the Costs of "Low-Carbon Concrete" Through Tax Credits and a State Procurement Preference.** ACU opposes placing new mandates on builders, expanding cronyism within the tax code and unnecessarily driving up taxpayer costs in order to advance a Leftist politicized environmental agenda and opposed this bill. The Senate passed the bill on March 25, 2021 by a vote of 24-11 and the bill was signed into law.
- 
19. **S 3093 Reopening the Economy Following the COVID-19 Pandemic and Combatting Gov. Murphy's Authoritarian Rule Through County-Based Plans.** ACU supports the ability of Americans to manage their own risk related to illnesses, believes that many of government's one-size fits all reactions to COVID-19 have done more harm than good and supported this bill. The Senate passed the bill on January 28, 2021 by a vote of 33-0 but the bill was vetoed by the governor.

20. **A 3352 Raising Construction Costs by Mandating Solar Energy Systems for Newly Constructed Warehouses.** ACU believes the market is the best mechanism to determine solar energy infrastructure needs and which amenities builders should offer, opposes this one-size fits all mandate which unnecessarily drives up construction costs and opposed this bill. The Senate passed the bill on June 3, 2021 by a vote of 25-13 and the bill was signed into law.
- 
21. **S 3414 Hiking Taxpayer Costs by Expanding Project Labor Agreement Mandates to Include All Projects Above \$5 Million.** ACU opposes project labor agreement mandates which are designed to enrich powerful union bosses, instead supports a free and open competitive bidding process for public works projects that provides the greatest value to taxpayers and opposed this bill. The Senate passed the bill on February 22, 2021 by a vote of 31-4 and the bill was signed into law.
- 
22. **S 3667 Codifying the State's Authoritarian Energy Goals into Law – Mandating Electric Vehicles and Renewable Energy.** ACU supports all sources of energy and does not believe government should favor one source of energy over another. ACU opposes this measure which will lead to skyrocketing costs for taxpayers and consumers in order to advance a Leftist climate change agenda and opposed this bill. The Senate passed the bill on June 21, 2021 by a vote of 25-13. (The bill failed to advance in the Assembly.)
- 
23. **S 3926 Infringing Property Rights Through the Use of Eminent Domain for Transmission Lines to Off-Shore Windmills.** ACU recognizes that the cost of procuring energy from offshore wind is nearly three times more costly to ratepayers than traditional energy sources. ACU believes overcharging families three times for their power is horrific enough, opposes even worsening the situation by seizing property from landowners as part of the Left's radical environmental agenda and opposed this bill. The Senate passed the bill on June 24, 2021 by a vote of 25-13 and the bill was signed into law.
- 
24. **A 4410 Socializing the Cost of "Free College" Through the Establishment of the Community College Opportunity Grant Program.** ACU believes higher education subsidies represent one of the largest transfers of wealth, especially at the expense of individuals who wish to pursue careers that do not require degrees such as the trades and small business. ACU opposes further socializing the costs of countless Woke Leftist degree programs and believes the best way to make college truly "affordable" is by eliminating wasteful programs and useless administrative positions and opposed this bill. The Senate passed the bill on January 11, 2021 by a vote of 26-6 and the bill was signed into law.
- 
25. **A 4463 Driving Up Rental Rates by Preventing Landlords from Accessing Tenant Eviction History Throughout the COVID-19 Pandemic.** ACU recognizes that payment and eviction history help landlords assess and price risk. ACU opposes this measure which ultimately drives up rental costs for everyone by exposing landlords to significant new risks – especially considering the state's lengthy eviction process – and opposed this bill. The Senate passed the bill on June 30, 2021 by a vote of 25-13 and the bill was signed into law.
- 
26. **A 4554 Hiking Electricity Rates by Socializing \$1.2 Billion in Costs for Solar Energy Projects onto Ratepayers.** ACU supports all sources of energy and believes government should not support one source of energy over another. ACU opposes unnecessarily hiking the power costs of New Jersey residents in order to enrich solar power developers and advance a radical Leftist environmental agenda and opposed this bill. The Senate passed the bill on June 30, 2021 by a vote of 24-12 and the bill was signed into law.
- 
27. **A 4630 Enriching Unions at the Expense of Small Businesses by Mandating "Labor Harmony Agreements" for Public Retail and Distribution Projects.** ACU opposes this scheme to enrich powerful union bosses, while making the state less business friendly and harming economic growth and opposed this bill. The Senate passed the bill on June 30, 2021 by a vote of 25-12 but the bill was vetoed by the governor.
- 
28. **A 5121 Expanding Cronyism by Providing Special Tax Exemptions to Government-Favored Recycled Materials Manufacturing Companies.** ACU supports a tax code that is broadly applied and with as low of rates as possible for everyone. ACU opposes this cronyism which provides competitive advantages to select companies while shifting tax burdens to other industries and companies not favored by government and opposed this bill. The Senate passed the bill on June 24, 2021 by a vote of 26-14 and the bill was signed into law.

29. **A 5130 Socializing Housing Costs and Distorting the Marketplace through the So-Called "New Jersey Foreclosure Prevention Act".** ACU opposes the establishment of yet another new government bureaucracy which disincentives the responsible repayment of backed mortgages and socializing such costs onto taxpayers. ACU instead believes the state should make homeownership more affordable for everyone by reducing property taxes and excessive zoning restrictions and opposed this bill. The Senate passed the bill on February 19, 2021 by a vote of 26-9 and the bill was signed into law.
- 
30. **A 5160 Infringing Consumer Choice Through Appliance Efficiency Mandates.** ACU opposes this attack on consumer choice which unnecessarily drives up the costs of countless appliances and everyday household items in order to advance a politicized environmental agenda and opposed this bill. The Senate passed the bill on December 20, 2021 by a vote of 26-13 and the bill was signed into law.
- 
31. **A 5207 Further Obstructing Federal Immigration Enforcement by Prohibiting State and Local Detention Agreements with ICE.** ACU supports assisting the federal government in its constitutional role to enforce our nation's immigration laws and opposed this bill. The Senate passed the bill on June 24, 2021 by a vote of 23-15 and the bill was signed into law.
- 
32. **A 5373 Undermining Democracy and Election Integrity by Authorizing the Political Placement of Ballot Drop Boxes by Local Officials.** ACU believes all elections should be conducted in a non-partisan manner and with strong safeguards to prevent vote fraud. ACU opposes this measure which enables corruption in the electoral process and provides benefits to select candidates and political parties and opposed this bill. The Senate passed the bill on March 25, 2011 by a vote of 24-12 and the bill was signed into law.
- 
33. **A 5597 Attacking Parental Rights by No Longer Requiring Schools to Receive Permission to Survey Students on Health Topics and Sexual Behavior.** ACU supports strong parental rights, opposes Leftist attempts to bypass parents and indoctrinate children on sensitive issues and opposed this bill. The Senate passed the bill on June 24, 2021 by a vote of 24-15 and the bill was signed into law.
- 
34. **A 5683 Worsening Cronyism and Government Central Planning Through an Expansion of the Garden State Growth Zone Tax Exemption Program.** ACU believes the free marketplace is the best mechanism to direct investment to the most beneficial projects and recognizes the countless failures that result from government central planning. ACU opposes this cronyism which enriches select developers and property owners while shifting tax burdens to other property owners and regions not favored by government and opposed this bill. The Senate passed the bill on June 30, 2021 by a vote of 26-12 and the bill was signed into law.
- 
35. **A 5758 Socializing Housing Advocacy and "Free" Tenant Legal Aid Through New Programs Operated out of Seton Hall and Rutgers Law Schools.** ACU recognizes New Jersey already has a lengthy eviction process which infringes property rights. ACU opposes this measure which socializes legal aid costs onto taxpayer while making it more difficult for landlords to evict non-paying tenants, which leads to greater landlord risk and ultimately higher rental rates and opposed this bill. The Senate passed the bill on June 24, 2021 by a vote of 39-0 and the bill was signed into law.
- 
36. **A 5820 Preserving Gov. Murphy's Overreaching COVID-19 Executive Orders Including Mask Mandates and the Eviction Moratorium.** ACU supports the ability of Americans to manage their own risk related to illnesses, believes that many of government's reactions to COVID-19 have done more harm than good and opposed this bill. The Senate passed the bill on June 3, 2021 by a vote of 21-16 and the bill was signed into law.
- 
37. **A 5840 Advancing the Uneconomical New Jersey Wind Port and Hundreds of Millions in Wasteful Taxpayer Expenditures.** ACU opposes socializing the costs on inefficient renewable energy initiatives onto taxpayers in order to enrich special interests and advance a radical Leftists environmental agenda and opposed this bill. The Senate passed the bill on June 30, 2021 by a vote of 25-10 and the bill was signed into law.
-

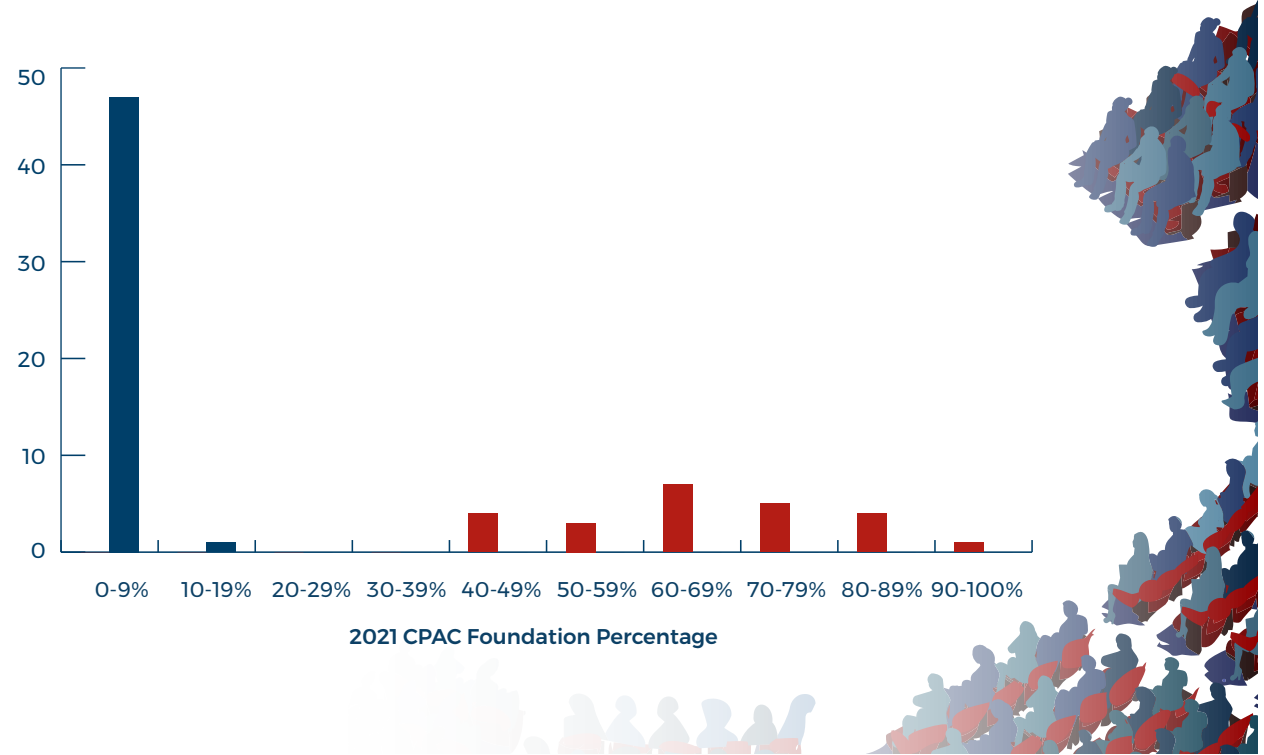
## NEW JERSEY ASSEMBLY CONSERVATIVE RATINGS

## NEW JERSEY ASSEMBLY VOTE DESCRIPTIONS

- 1. A 12 Further Socializing Higher Education Costs Through New Subsidies Under the So-Called "College Affordability Act".** ACU believes higher education subsidies represent one of the largest transfers of wealth, especially at the expense of individuals who wish to pursue careers that do not require degrees such as the trades and small business. ACU opposes further socializing the costs of countless Woke Leftist degree programs and believes the best way to make college truly "affordable" is by eliminating wasteful programs and useless administrative positions and opposed this bill. The Assembly passed the bill on June 24, 2021 by a vote of 75-0 and the bill was signed into law.
- 2. AR 213 Advancing a Partisan Political Attack by Urging the Impeachment of President Donald J. Trump.** ACU recognizes that on multiple occasions President Trump called for the protests on January 6th to remain peaceful. ACU further recognizes that at the time of this vote President Trump had only nine days remaining in office and this call for impeachment solely serves as a personal political attack to prevent President Trump from seeking a future term and deny him government benefits and Secret Service protection as a private citizen. ACU opposes this partisan attack on the president and opposed this resolution. The Assembly passed the resolution on January 11, 2021 by a vote of 47-8.
- 3. A 284 Imposing Overreaching New Licensing and Sale Mandates on Bamboo.** ACU recognizes the damages that unmanaged running bamboo can cause to property and supports reasonable restrictions, such as property line setback requirements, to protect the property rights of surrounding landowners. ACU opposes this measure which contains multiple anti-competitive licensing and sale mandates which unnecessarily drive-up costs and infringe the ability of responsible property owners to utilize and cultivate their land and opposed this bill. The Assembly passed the bill on June 21, 2021 by a vote of 70-1. (The bill failed to advance in the Senate.)
- 4. S 703 Increasing Health Care Costs by Requiring Hospitals to Provide Implicit Bias Training.** ACU supports equal rights under the law for all, believes all individuals should be treated with dignity and respect. ACU opposes this measure designed to enrich radical leftists consultants at the expense of patients and opposed this bill. The Assembly passed the bill on March 25, 2021 by a vote of 53-20 and the bill was signed into law.
- 5. S 853 Hiking Taxpayer Costs and Enriching Unions Through Protectionist "Buy American" Procurement Mandates for Highway and Bridge Projects.** ACU opposes protectionist mandates which unnecessarily drive-up taxpayer costs by prohibiting procurement of products that are of the highest quality and greatest value to taxpayers and are primarily designed to enrich unions and other special interest groups and opposed this bill. The Assembly concurred with the governor's recommendations on June 21, 2021 by a vote of 71-0 and the bill was signed into law.
- 6. S 942 Reducing Unnecessary Occupational Licensing Barriers for Reformed Individuals with Prior Criminal Convictions.** ACU's Nolan Center for Justice is a national leader in criminal justice reform and works to cut crime, reduce taxpayer costs, protect victims, define the proper scope of government, and safely reduce incarceration rates. ACU opposes the proliferation of licensing requirements which are primarily designed to restrict competition, supports efforts to lower recidivism by reducing barriers to the workforce and supported this bill. The Assembly passed the bill on March 1, 2021 by a vote of 69-0 and the bill was signed into law.
- 7. S 989 Driving Up Transportation Costs Through New Prevailing Wage Mandates at Airports and Train Stations.** ACU opposes these artificial wages that unnecessarily drive-up transportation costs and reduce employment opportunities and opposed this bill. The Assembly passed the bill on March 25, 2021 by a vote of 47-25 and the bill was signed into law.
- 8. S 1010 Indebting Taxpayers by Authorizing Localities to Issue Bonds for the Purchase of Alternative Fuel and Electric Vehicles.** ACU opposes the authorization of greater municipal and local debt, especially for the purpose of advancing the leftist environmental agenda surrounding electric vehicles and opposed this bill. The Assembly passed the bill on June 24, 2021 by a vote of 55-20 and the bill was signed into law.

9. **A 1536 Hiking Taxpayer Costs by Expanding Prevailing Wage Mandates to Include Public Sign Fabrication.** ACU has long opposed prevailing wage mandates which needlessly drives up the costs of taxpayer-funded public works projects and opposed this bill. The Assembly passed the bill on June 21, 2021 by a vote of 58-14 and the bill was signed into law.
- 
10. **A 1971 Imposing \$10 Million in Unnecessary Costs onto Taxpayers Through an Electric School Bus Pilot Program.** ACU opposes unnecessarily hiking taxpayer costs in order to advance the leftist environmental agenda surrounding electric and opposed this bill. The Assembly passed the bill on June 21, 2021 by a vote of 57-14. (The bill failed to advance in the Senate.)
- 
11. **A 2374 Placing Taxpayers at Risk Through a Commercial Property Assessed Clean Energy (C-PACE) Scheme.** ACU has long opposed Property Assessed Clean Energy (PACE) schemes which harm the lending industry and place taxpayers at risk in the event of a default and opposed this bill. The Assembly passed the bill on June 24, 2021 by a vote of 63-12 and the bill was signed into law.
- 
12. **S 2476 Abusing the Workers Compensation System by Providing Death Benefits to Dependents of Any "Essential Employee" who Contracted COVID-19.** ACU recognizes the workers compensation system is funded through payroll taxes imposed on all employers. ACU opposes driving up employment costs by abusing the workers compensation system and opposed this bill. The Assembly passed the bill on March 1, 2021 by a vote of 55-12. (The Senate passed the bill in 2020.)
- 
13. **S 2525 Increasing Government Racial and Sexual Discrimination in Procurement by Further Empowering the State's Chief Diversity Officer.** ACU believes in equal rights under the law for all and that it is the duty of government to ensure all laws are applied equally. ACU opposes unnecessarily driving up taxpayer costs by awarding projects based on racial and sexual discrimination and opposed this bill. The Assembly passed the bill on June 21, 2021 by a vote of 66-5 but the bill was vetoed by the governor. (The Senate passed the bill in 2020.)
- 
14. **S 2545 Exposing Nursing Homes to Frivolous Litigation Through a New LGBTQI "Bill of Rights."** ACU vehemently opposes discrimination and believes that businesses that discriminate will face serious repercussions in the marketplace. ACU opposes this measure which is primarily designed to enrich greedy plaintiff's attorneys by subjecting long-term care facilities to frivolous litigation for failing to meet new employee training mandates or any one of the bill's other countless new regulations and opposed this bill. The Assembly passed the bill on January 11, 2021 by a vote of 69-1. (The Senate passed the bill in 2020.)
- 
15. **S 2834 Forcing Teachers to Undergo Training on Critical Race Theory and Other Leftist Propaganda.** ACU opposes taking away the ability of teachers to receive valuable training in core education fields and instead indoctrinate them with Leftist propaganda and enrich the companies and providers of such training and opposed this bill. The Assembly passed the bill on December 20, 2021 by a vote of 46-18 and the bill was signed into law.
- 
16. **S 2932 Enriching Unions and Hiking Costs at State-Funded Colleges and Universities Through a Prohibition on Subcontracting.** ACU opposes this anti-competitive scheme to enrich powerful union bosses, instead supports a free and open competitive hiring process for university projects that provides the greatest value to taxpayers and opposed this bill. The Assembly passed the bill on May 20, 2021 by a vote of 67-8. (The Senate voted in 2020.)
- 
17. **S 3091 Socializing the Costs of "Low-Carbon Concrete" Through Tax Credits and a State Procurement Preference.** ACU opposes placing new mandates on builders, expanding cronyism within the tax code and unnecessarily driving up taxpayer costs in order to advance a Leftist politicized environmental agenda and opposed this bill. The Assembly passed the bill on June 3, 2021 by a vote of 57-14 and the bill was signed into law.
- 
18. **S 3093 Reopening the Economy Following the COVID-19 Pandemic and Combatting Gov. Murphy's Authoritarian Rule Through County-Based Plans.** ACU supports the ability of Americans to manage their own risk related to illnesses, believes that many of government's one-size fits all reactions to COVID-19 have done more harm than good and supported this bill. The Assembly passed the bill on May 20, 2021 by a vote of 76-0 but the bill was vetoed by the governor.

19. **A 3352 Raising Construction Costs by Mandating Solar Energy Systems for Newly Constructed Warehouses.** ACU believes the market is the best mechanism to determine solar energy infrastructure needs and which amenities builders should offer, opposes this one-size fits all mandate which unnecessarily drives up construction costs and opposed this bill. The Assembly passed the bill on June 3, 2021 by a vote of 46-24 and the bill was signed into law.
- 
20. **S 3414 Hiking Taxpayer Costs by Expanding Project Labor Agreement Mandates to Include All Projects Above \$5 Million.** ACU opposes project labor agreement mandates which are designed to enrich powerful union bosses, instead supports a free and open competitive bidding process for public works projects that provides the greatest value to taxpayers and opposed this bill. The Assembly passed the bill on March 25, 2021 by a vote of 60-10 and the bill was signed into law.
- 
21. **S 3926 Infringing Property Rights Through the Use of Eminent Domain for Transmission Lines to Off-Shore Windmills.** ACU recognizes that the cost of procuring energy from offshore wind is nearly three times more costly to ratepayers than traditional energy sources. ACU believes overcharging families three times for their power is horrific enough, opposes even worsening the situation by seizing property from landowners as part of the Left's radical environmental agenda and opposed this bill. The Assembly passed the bill on June 24, 2021 by a vote of 49-26 and the bill was signed into law.
- 
22. **A 4330 Expanding Cronyism Through State Investment in Private Companies Under the So-Called Economic Emergency Investment Stabilization Act.** ACU believes the free market is the best mechanism to direct investment, opposes expanding cronyism and government central planning powers and opposed this bill. The Assembly passed the bill on June 21, 2021 by a vote of 62-10. (The bill failed to advance in the Senate.)
- 
23. **A 4410 Socializing the Cost of "Free College" Through the Establishment of the Community College Opportunity Grant Program.** ACU believes higher education subsidies represent one of the largest transfers of wealth, especially at the expense of individuals who wish to pursue careers that do not require degrees such as the trades and small business. ACU opposes further socializing the costs of countless Woke Leftist degree programs and believes the best way to make college truly "affordable" is by eliminating wasteful programs and useless administrative positions and opposed this bill. The Assembly passed the bill on January 11, 2021 by a vote of 49-20 and the bill was signed into law.
- 
24. **A 4454 Advancing Critical Race Theory and Gender Identity Teachings on K-12 Students Through New State Curriculum Mandates.** ACU opposes state-wide educational mandates that do not pertain to core subject areas and recognizes that CRT is a tool used by the radical Left to advance division amongst Americans and expand the role of government. ACU believes it is abhorrent to advance this indoctrination on young students and opposed this bill. The Assembly concurred in Senate Amendment on January 11, 2021 by a vote of 46-29 and the bill was signed into law. (The Senate passed the bill in 2020.)
- 
25. **A 4463 Driving Up Rental Rates by Preventing Landlords from Accessing Tenant Eviction History Throughout the COVID-19 Pandemic.** ACU recognizes that payment and eviction history help landlords assess and price risk. ACU opposes this measure which ultimately drives up rental costs for everyone by exposing landlords to significant new risks – especially considering the state's lengthy eviction process – and opposed this bill. The Assembly passed the bill on March 25, 2021 by a vote of 52-14 and the bill was signed into law.
- 
26. **A 4554 Hiking Electricity Rates by Socializing \$1.2 Billion in Costs for Solar Energy Projects onto Ratepayers.** ACU supports all sources of energy and believes government should not support one source of energy over another. ACU opposes unnecessarily hiking the power costs of New Jersey residents in order to enrich solar power developers and advance a radical Leftist environmental agenda and opposed this bill. The Assembly passed the bill on June 24, 2021 by a vote of 57-16 and the bill was signed into law.
- 
27. **A 4630 Enriching Unions at the Expense of Small Businesses by Mandating "Labor Harmony Agreements" for Public Retail and Distribution Projects.** ACU opposes this scheme to enrich powerful union bosses, while making the state less business friendly and harming economic growth and opposed this bill. The Assembly passed the bill on June 24, 2021 by a vote of 49-25 but the bill was vetoed by the governor.

28. **A 5121 Expanding Cronyism by Providing Special Tax Exemptions to Government-Favored Recycled Materials Manufacturing Companies.** ACU supports a tax code that is broadly applied and with as low of rates as possible for everyone. ACU opposes this cronyism which provides competitive advantages to select companies while shifting tax burdens to other industries and companies not favored by government and opposed this bill. The Assembly passed the bill on March 25, 2021 by a vote of 60-11 and the bill was signed into law.
- 
29. **A 5130 Socializing Housing Costs and Distorting the Marketplace Through the So-Called "New Jersey Foreclosure Prevention Act".** ACU opposes the establishment of yet another new government bureaucracy which disincentives the responsible repayment of backed mortgages and socializing such costs onto taxpayers. ACU instead believes the state should make homeownership more affordable for everyone by reducing property taxes and excessive zoning restrictions and opposed this bill. The Assembly passed the bill on January 11, 2021 by a vote of 60-15 and the bill was signed into law.
- 
30. **A 5207 Further Obstructing Federal Immigration Enforcement by Prohibiting State and Local Detention Agreements with ICE.** ACU supports assisting the federal government in its constitutional role to enforce our nation's immigration laws and opposed this bill. The Assembly passed the bill on June 21, 2021 by a vote of 46-24 and the bill was signed into law.
- 
31. **A 5373 Undermining Democracy and Election Integrity by Authorizing the Political Placement of Ballot Drop Boxes by Local Officials.** ACU believes all elections should be conducted in a non-partisan manner and with strong safeguards to prevent vote fraud. ACU opposes this measure which enables corruption in the electoral process and provides benefits to select candidates and political parties and opposed this bill. The Assembly passed the bill on March 25, 2021 by a vote of 50-21 and the bill was signed into law.
- 
32. **A 5597 Attacking Parental Rights by No Longer Requiring Schools to Receive Permission to Survey Students on Health Topics and Sexual Behavior.** ACU supports strong parental rights, opposes Leftist attempts to bypass parents and indoctrinate children on sensitive issues and opposed this bill. Assembly passed the bill on May 20, 2021 by a vote of 48-28 and the bill was signed into law.
- 
33. **A 5683 Worsening Cronyism and Government Central Planning Through an Expansion of the Garden State Growth Zone Tax Exemption Program.** ACU believes the free marketplace is the best mechanism to direct investment to the most beneficial projects and recognizes the countless failures that result from government central planning. ACU opposes this cronyism which enriches select developers and property owners while shifting tax burdens to other property owners and regions not favored by government and opposed this bill. The Assembly passed the bill on June 24, 2021 by a vote of 57-18 and the bill was signed into law.
- 
34. **A 5758 Socializing Housing Advocacy and "Free" Tenant Legal Aid Through New Programs Operated Out of Seton Hall and Rutgers Law Schools.** ACU recognizes New Jersey already has a lengthy eviction process which infringes property rights. ACU opposes this measure which socializes legal aid costs onto taxpayers while making it more difficult for landlords to evict non-paying tenants, which leads to greater landlord risk and ultimately higher rental rates and opposed this bill. The Assembly passed the bill on June 24, 2021 by a vote of 70-0 and the bill was signed into law.
- 
35. **A 5820 Preserving Gov. Murphy's Overreaching COVID-19 Executive Orders Including Mask Mandates and the Eviction Moratorium.** ACU supports the ability of Americans to manage their own risk related to illnesses, believes that many of government's reactions to COVID-19 have done more harm than good and opposed this bill. The Assembly passed the bill on June 3, 2021 by a vote of 44-28 and the bill was signed into law.
- 
36. **A 5840 Advancing the Uneconomical New Jersey Wind Port and Hundreds of Millions in Wasteful Taxpayer Expenditures.** ACU opposes socializing the costs on inefficient renewable energy initiatives onto taxpayers in order to enrich special interests and advance a radical Leftists environmental agenda and opposed this bill. The Assembly passed the bill on June 24, 2021 by a vote of 48-25 and the bill was signed into law.

37. **A 5879 Enriching Developers Through \$20 Million in “Affordable” Housing Tax Credits.** ACU supports a tax code that is broadly applied with as low of rates as possible for everyone. ACU has long opposed the federal Low Income Housing Tax Credit (LIHTC) program which enriches government-favored developers while shifting tax burdens to other property owners and taxpayers not favored by government. ACU believes the best way to make housing truly “affordable” is by eliminating excessive building and zoning mandates and opposed this bill. The Assembly passed the bill on June 21, 2021 by a vote of 48-24. (The bill failed to advance in the Senate.)
- 
38. **A 5883 Further Hiking Government Spending by Channeling Even More Funds to Schools Participating in the Federal “Breakfast After the Bell” Program.** ACU opposes further growing government spending by forcing state taxpayers to also channel funds to local school districts which have chosen to participate in the breakfast after the bell entitlement program, originally established under the Obama administration, and opposed this bill. The Assembly passed the bill on June 24, 2021 by a vote of 72-3 and the bill was signed into law.
- 
39. **A 5890 Providing the DOL Commissioner Overreaching Authority to Issue Stop Work Orders and Impose Draconian Penalties for Alleged Labor Violations.** ACU opposes this authoritarian power granted to the Department of Labor Commissioner to shut down and financially devastate businesses for alleged violations of the state’s draconian labor regulations and opposed this bill. The Assembly passed the bill on June 21, 2021 by a vote 48-22 and the bill was signed into law.
- 
40. **A 5891 Further Growing Government Bureaucracy and Harassing Businesses Through the Creation of the “Office of Strategic Enforcement and Compliance” within DOLWD.** ACU opposes unnecessarily increasing taxpayer costs by hiring even more government bureaucrats within the Department of Labor and Workforce Development (DOLWD) to harass private businesses over their adherence to the state’s litany of draconian labor regulations and opposed this bill. The Assembly passed the bill on June 21, 2021 by a vote of 51-21 and the bill was signed into law.
- 
41. **A 6020 Growing the Nanny State by Mandating Retailers of Tobacco Products Carry Nicotine Replacement Therapy Products and Post Signage.** ACU opposes imposing placing unnecessary additional costs onto retailers in order to further advance the state’s war on individual liberties and opposed this bill. The Assembly passed the bill on December 20, 2021 by a vote of 50-18 and the bill was signed into law. (The Senate vote was in 2022.)
