The Center for Legislative Accountability (CLA), an initiative of the CPAC Foundation, is the premier organization for holding lawmakers accountable. The CLA produces the longest-running conservative congressional scorecard and our state program is the only one in the nation that scores all 8,000 lawmakers in the 50 states across every policy area.

In 1971, ACUF launched its Ratings of Congress to provide a comprehensive evaluation of the voting records of every Member of Congress. The Ratings quickly became considered the “gold standard” and over the following decades have been utilized by activists, voters, academics and elected officials to determine which lawmakers best adhere to conservative principles.

In 2011, these Ratings were expanded into state legislatures as part of a five-state pilot program. By 2015, Ratings of the States grew to include all 50 states and all 99 legislative chambers. Today, the CLA annually analyzes over 105,000 pieces of legislation to issue scores for all of America’s federal and state lawmakers and presents awards to lawmakers who score 80% or better in recognition of their conservative voting records.

In order to depict how closely a lawmaker adheres to conservative principles, the CLA selects from the full spectrum of issues relating to the economy, culture, national security and government integrity. Some key areas include taxation, spending, education, labor, licensure, regulation, environment, life, free speech, Second Amendment rights, foreign aid, defense priorities and global organizations, including the United Nations. All congressional and state analyses are conducted after the adjournment of a legislative session to ensure that no issue is neglected.

To determine legislative rankings, the CLA annually evaluates over 105,000 bills that were introduced in Congress and every convening state legislature running from January 1 to December 31.

Of those bills, the CLA ultimately selects roughly 2,000 pieces of legislation that best illustrate how elected officials view the role of government in an individual's life. The CLA calculates individual scores for a total of nearly 8,000 federal and state lawmakers based on over 157,000 votes cast on the 2,000 bills selected.

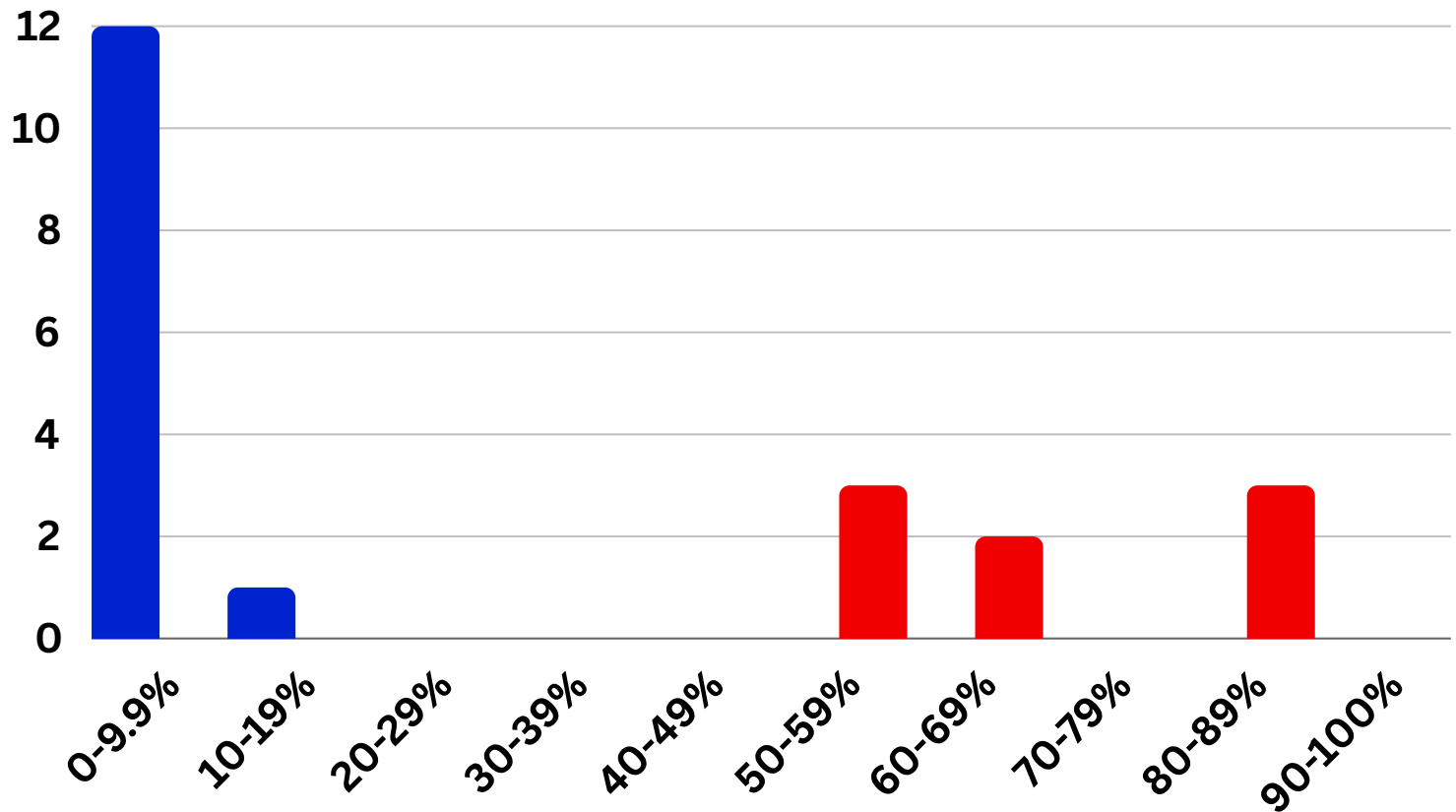

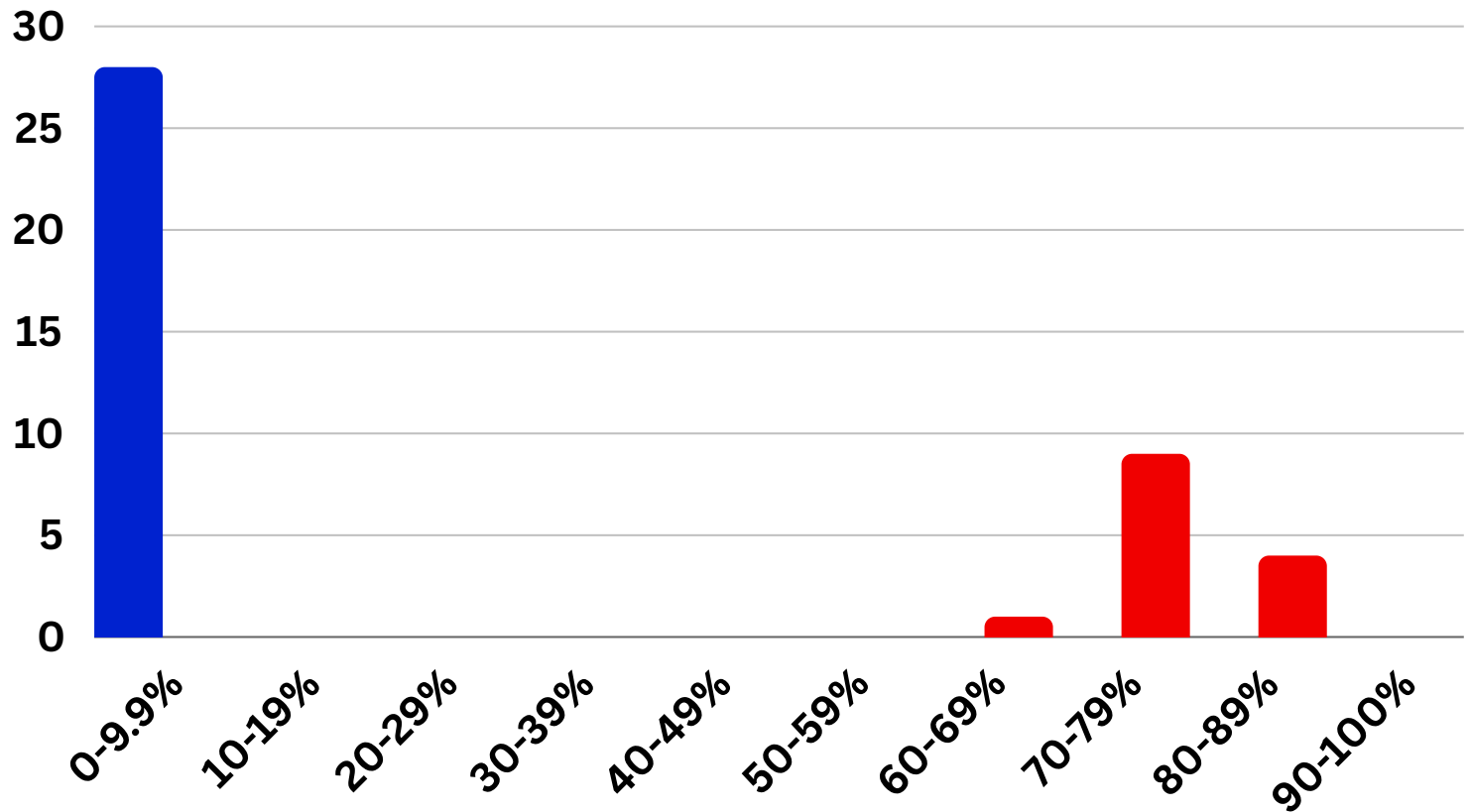

## **AJR 6 Entering Nevada into the National Popular Vote Compact.**

This resolution proposes a measure to voters that would enter Nevada into the National Popular Vote Compact. If voters decide to enter Nevada into this compact, its electoral votes for the presidential election will be apportioned to the winner of the national popular vote. CPAC believes that the candidate that wins the majority number of votes in Nevada should win Nevada's electoral votes and opposed this resolution. The Senate passed this resolution on May 18, 2023 by a vote of 12-9.

---

## **AB 77 Supporting Nevada's Efforts to Direct the Economy and Bloat the Bureaucracy.**

This bill establishes the Office of Entrepreneurship, the likes of which will work to strengthen policies and programs supporting the growth of entrepreneurship in the state. CPAC opposes expansions in the size of the bureaucracy, opposes measures that empower its central planning efforts, and opposed this bill. The Senate passed this bill on May 31, 2023 by a vote of 18-3 and the bill later became law.

---

## **AB 144 Blanket Ban on Fluorescent Lamps.**

This bill bans the sale of certain types of fluorescent lamps. CPAC believes that the government shouldn't micromanage the types of lighting products that people purchase and opposed this bill. The Senate passed this bill on May 24, 2023 by a vote of 12-9 but Governor Lombardo vetoed the bill.

---

## **AB 172 Building the Email Lists of Public Education Unions.**

This bill requires school districts to semiannually provide the following information about their employees to unions recognized by the school district: their names, addresses, email addresses, telephone numbers, work contact numbers, and work locations. CPAC does not believe that the government should work on behalf of unions and opposed this bill. The Senate passed this bill on May 25, 2023 by a vote of 13-7 but Governor Lombardo vetoed the bill.

---

## **AB 184 More Taxpayer Money for So-Called Green Vehicles.**

This bill establishes a "Clean Trucks and Buses" Incentive Program, the likes of which will dole out monetary incentives to organizations such that various public and private entities may more easily purchase low-emissions medium- and heavy-duty vehicles. CPAC supports all forms of energy, believes that the government should not support one form of energy over another, and opposed this bill. The Senate passed this bill on June 3, 2023 by a vote of 18-2 and the bill later became law.





## **AB 235 Hiking the Cost of Government Projects in Nevada.**

This bill requires that the prevailing wage be paid to certain employees in return for their work on public works projects. This mandate covers employees that assist with plumbing, heating, and ventilation systems. CPAC recognizes that prevailing wage mandates ratchet up the cost of public projects, believes that such projects should instead be completed at the lowest cost to the taxpayer, and opposed this bill. The Senate passed this bill on May 23, 2023 by a vote of 12-8 but Governor Lombardo vetoed the bill.

---

## **AB 250 Instituting Price Controls for Prescription Drugs.**

This bill prevents entities from purchasing certain drugs at rates higher than the established “maximum fair price” for that drug. The Senate passed this bill on May 26, 2023 by a vote of 13-7 but Governor Lombardo vetoed the bill.

---

## **AB 305 Burdensome Work Requirements on Public Contractors.**

This bill requires that at least 2 percent of the work hours performed by apprentices for public contractors be completed by women. CPAC believes that public contracts should be fulfilled by those who will do the best job at the lowest cost to the taxpayer, opposes sexist hiring practices, and opposed this bill. The Senate passed this bill on May 25, 2023 by a vote of 16-4 but Governor Lombardo vetoed the bill.

---

## **AB 310 Enriching Developers with Supportive Housing Grant Programs.**

This bill requires the Department of Business and Industry to develop a grant program aimed at fostering the construction of supportive housing. CPAC opposes government involvement in the housing industry and opposed this bill. The Senate passed this bill on June 5, 2023 by a vote of 20-1 and the bill later became law.

---

## **AB 354 Expanding Nevada’s Gun-Free Zones.**

This bill prohibits individuals from handling firearms within 100 feet of “election sites.” The definition of an “election site” includes polling places, places where a ballot drop box is present, and central counting places. CPAC opposes the expansion of gun-free zones and opposed this bill. The Senate passed this bill on May 15, 2023 by a vote of 12-8 but Governor Lombardo vetoed this bill.



### **AB 355 Raising the Age at Which Nevadans May Handle Certain Firearms.**

This bill prohibits individuals under the age of 21 from using or handling semi-automatic shotguns or rifles. CPAC believes that adults should be permitted to handle such firearms, supports the founders' belief in the Second Amendment, and opposed this bill. The Senate passed this bill on May 15, 2023 by a vote of 12-8 but Governor Lombardo vetoed the bill.

---

### **AB 359 Taking the Power to Directly Control Fuel Tax Increases Away from the People.**

This bill removes a requirement stating that a majority of voters must approve a countywide fuel tax increase before it can go into effect. In its place, the bill allows the county's board of commissioners to adopt ordinances authorizing such increases without the explicit agreement of voters. CPAC opposes measures that allow for wanton tax increases and opposed this bill. The Senate passed this bill on May 23, 2023 by a vote of 15-5 but Governor Lombardo vetoed the bill.

---

### **AB 383 Protecting Nevadan Abortionists from Government Intrusion.**

This bill prohibits public entities from interfering with a person's reception of an abortion. CPAC believes abortion is always a human tragedy, opposes its protection, and opposed this bill. The Senate passed this bill on June 5, 2023 by a vote of 16-5 but Governor Lombardo vetoed the bill.

---

### **AB 394 Interfering with the Accuracy of Vote Tabulations.**

This bill prohibits election officials from counting ballots a second time save during certain audits. CPAC opposes measures that reduce election security and opposed this bill. The Senate passed this bill on May 25, 2023 by a vote of 13-8 but Governor Lombardo vetoed the bill.

---

### **AB 396 Requiring Taxpayers to Offset Other People's Housing Costs.**

This bill apportions millions of dollars to a rental assistance program. CPAC does not believe that taxpayers should be forced to pay off other people's housing costs and opposed this bill. The Senate passed this bill on June 5, 2023 by a vote of 21-0 and the bill later became law.



## **AB 428 Forcing Taxpayers to Pay Off the Tuition of Nevadan Teachers.**

This bill establishes a program whereby teachers serving in Nevada’s public schools may have some of their tuition reimbursed after working in an educational capacity for at least 3 years. The bill also establishes a program to develop “career pathways” aimed at funneling people into positions that meet the long-term needs of the state. CPAC does not believe that taxpayers should be forced to help pay for other people’s tuition and opposed this bill. The Senate passed this bill on June 5, 2023 by a vote of 21-0 and the bill later became law.

---

## **SB 1(SS) \$380,000,000 Giveaway to a Wealthy Sports Team.**

This bill commits \$380,000,000 in tax credits and bond proceeds to the construction of a new baseball stadium in Las Vegas such that the Oakland Athletics may relocate themselves to Nevada. CPAC believes that taxpayers should not be forced to subsidize wealthy sports teams or leagues and opposed this bill. The Senate passed this bill on June 13, 2023 by a vote of 13-8 and the bill later became law.

---

## **SB 131 Transforming Nevada into a Sanctuary State for Abortionists.**

This bill prohibits medical licensing boards from denying a license to a physician because of their participation in abortion procedures. It also prohibits the governor from surrendering a person for arrest who has been charged in another state for participating in an abortion. CPAC believes abortion is always a human tragedy, opposes its protection, and opposed this bill. The Senate passed this bill on April 19, 2023 by a vote of 15-6 and the bill later became law.

---

## **SB 153 Making Nevadan Prisons Less Safe for Women.**

This bill allows the government to permit men who believe that they are women to be incarcerated with women. CPAC opposes measures that open female prisoners up to sexual abuse, further opposes measures that gratify transgender ideology, and opposed this bill. The Senate passed this bill on April 17, 2023 by a vote of 15-5 and the bill later became law.

---

## **SB 163 Driving Up Nevada’s Insurance Costs with More Mandates.**

This bill requires insurance plans to cover “medically necessary” treatments for gender dysphoria and gender incongruence. CPAC recognizes that, because of the broadness of the interpretations of the term “medically necessary,” coverage will undoubtedly be provided for radical gender surgeries and hormone replacement therapy. CPAC opposes insurance mandates, opposes the socialization of the costs of grotesque and unethical treatments related to gender dysphoria, and opposed this bill. The Senate passed this bill on June 2, 2023 by a vote of 13-8 and the bill later became law.



## **SB 210 Instituting DEI Requirements for State Appointments.**

This bill states that it is the public policy of Nevada to appoint people that reflect the ethnic and gender identity diversity of the state to state boards and other public positions. CPAC believes that individuals should be appointed to government positions because of their merits and not because of their perceived “gender identity” and opposed this bill. The Senate passed this bill on April 17, 2023 by a vote of 16-4 but Governor Lombardo vetoed the bill.

---

## **SB 240 Government Investments in Favored Businesses.**

This bill establishes a tax credit program designed to promote investments into “impact qualified low-income community businesses.” A company can qualify as one of these businesses by having 51% or more of its ownership interest in the hands of women, favored racial groups, or LGBTQ+ people. CPAC opposes government favoritism toward particular racial and ethnic groups and opposed this bill. The Senate passed this bill on May 30, 2023 by a vote of 18-2 and the bill later became law.

---

## **SB 251 Upholding Public Union Interests at the Expense of Students.**

This bill requires local school precincts to hire union-backed teachers from large school districts that are laid off as a result of a situation in which there are too many employees within the large school district. CPAC recognizes that this provision harms the ability of principals to hire teachers that are most suited to the needs of their students, supports the interests of students over those of teachers’ unions, and opposed this bill. The Senate passed this bill on April 25, 2023 by a vote of 13-8 but Governor Lombardo vetoed the bill.

---

## **SB 275 Imposing Rent Controls on Manufactured Home Parks.**

This bill prohibits the owners of manufactured home parks from increasing rent by a rate greater than a specific rate annually set by the Department of Business and Industry. CPAC supports property rights, recognizes that rent controls contribute to shortages in housing, and opposed this bill. The Senate passed this bill on May 15, 2023 by a vote of 13-8 but Governor Lombardo vetoed the bill.

---

## **SB 302 Transforming Nevada Into a Sanctuary State for Radical Gender Surgeries.**

This bill prohibits medical licensing boards from retaliating against physicians for participating in so-called “gender-affirming care.” The bill also prohibits the government from assisting other states that are conducting investigations related to “gender-affirming care.” CPAC opposes the promotion of transgender ideology and opposed this bill. The Senate passed this bill on April 24, 2023 by a vote of 13-8 but Governor Lombardo vetoed the bill.



**SB 363 Instituting a New Marriage Penalty on Affordable Housing.**

This bill allows bureaucrats operating Nevada's Account for Affordable Housing to prioritize the funding of housing projects aimed at assisting formerly incarcerated women and single people with children. CPAC sees no good reason to transform formerly incarcerated women into a privileged group, believes that this law inappropriately incentivizes single parenthood, and opposed this bill. The Senate passed this bill on April 20, 2023 by a vote of 18-3 and the bill later became law.

---

**SB 404 Weakening Residency Requirements for the Purposes of Voter Registration.**

This bill allows individuals to register to vote using a variety of non-governmental forms of identification. For example, it allows individuals to use their utility bill, a statement concerning the mortgage of their residence, a bank statement, and other documents for this purpose. CPAC recognizes that increasing the list of non-governmental documents that may be used to fulfill voter registration requirements reduces election security, opposes measures that reduce election security, and opposed this bill. The Senate passed this bill on April 25, 2023 by a vote of 13-8 but Governor Lombardo vetoed the bill.

---

**SB 429 Requiring Nevadan Employers to Implement a Paid Family and Medical Leave Program.**

This bill requires employers to offer at least 12 weeks of paid family and medical leave to their employees. CPAC believes that employees should negotiate their own salaries and benefits with employers and opposed this bill. The Senate passed this bill on April 25, 2023 by a vote of 17-4 but Governor Lombardo vetoed the bill.

## **AJR 6 Entering Nevada into the National Popular Vote Compact.**

This resolution proposes a measure to voters that would enter Nevada into the National Popular Vote Compact. If voters decide to enter Nevada into this compact, its electoral votes for the presidential election will be apportioned to the winner of the national popular vote. CPAC believes that the candidate that wins the majority number of votes in Nevada should win Nevada's electoral votes and opposed this resolution. The Assembly passed this resolution on April 17, 2023 by a vote of 27-14.

---

## **AB 77 Supporting Nevada's Efforts to Direct the Economy and Bloat the Bureaucracy.**

This bill establishes the Office of Entrepreneurship, the likes of which will work to strengthen policies and programs supporting the growth of entrepreneurship in the state. CPAC opposes expansions in the size of the bureaucracy, opposes measures that empower its central planning efforts, and opposed this bill. The Assembly passed this bill on June 5, 2023 by a vote of 30-12 and the bill later became law.

---

## **AB 144 Blanket Ban on Fluorescent Lamps.**

This bill bans the sale of certain types of fluorescent lamps. CPAC believes that the government shouldn't micromanage the types of lighting products that people purchase and opposed this bill. The Assembly passed this bill on April 13, 2023 by a vote of 28-14 but Governor Lombardo vetoed the bill.

---

## **AB 172 Building the Email Lists of Public Education Unions.**

This bill requires school districts to semiannually provide the following information about their employees to unions recognized by the school district: their names, addresses, email addresses, telephone numbers, work contact numbers, and work locations. CPAC does not believe that the government should work on behalf of unions and opposed this bill. The Assembly passed this bill on April 14, 2023 by a vote of 28-14 but Governor Lombardo vetoed the bill.

---

## **AB 184 More Taxpayer Money for So-Called Green Vehicles.**

This bill establishes a "Clean Trucks and Buses" Incentive Program, the likes of which will dole out monetary incentives to organizations such that various public and private entities may more easily purchase low-emissions medium- and heavy-duty vehicles. CPAC supports all forms of energy, believes that the government should not support one form of energy over another, and opposed this bill. The House passed this bill on May 31, 2023 by a vote of 42-0 and the bill later became law.





## **AB 235 Hiking the Cost of Government Projects in Nevada.**

This bill requires that the prevailing wage be paid to certain employees in return for their work on public works projects. This mandate covers employees that assist with plumbing, heating, and ventilation systems. CPAC recognizes that prevailing wage mandates ratchet up the cost of public projects, believes that such projects should instead be completed at the lowest cost to the taxpayer, and opposed this bill. The Assembly passed this bill on April 17, 2023 by a vote of 27-14 but Governor Lombardo vetoed the bill.

---

## **AB 250 Instituting Price Controls for Prescription Drugs.**

This bill prevents entities from purchasing certain drugs at rates higher than the established “maximum fair price” for that drug. CPAC opposes price controls and opposed this bill. The Assembly passed this bill on April 25, 2023 by a vote of 27-15 but Governor Lombardo vetoed the bill.

---

## **AB 305 Burdensome Work Requirements on Public Contractors.**

This bill requires that at least 2 percent of the work hours performed by apprentices for public contractors be completed by women. CPAC believes that public contracts should be fulfilled by those who will do the best job at the lowest cost to the taxpayer, opposes sexist hiring practices, and opposed this bill. The Assembly passed this bill on April 24, 2023 by a vote of 33-9 but Governor Lombardo vetoed the bill.

---

## **AB 310 Enriching Developers with Supportive Housing Grant Programs.**

This bill requires the Department of Business and Industry to develop a grant program aimed at fostering the construction of supportive housing. CPAC opposes government involvement in the housing industry and opposed this bill. The Assembly passed this bill on May 31, 2023 by a vote of 42-0 and the bill later became law.

---

## **AB 354 Expanding Nevada’s Gun-Free Zones.**

This bill prohibits individuals from handling firearms within 100 feet of “election sites.” The definition of an “election site” includes polling places, places where a ballot drop box is present, and central counting places. CPAC opposes the expansion of gun-free zones and opposed this bill. The Assembly passed this bill on April 25, 2023 by a vote of 28-14 but Governor Lombardo vetoed this bill.



### **AB 355 Raising the Age at Which Nevadans May Handle Certain Firearms.**

This bill prohibits individuals under the age of 21 from using or handling semi-automatic shotguns or rifles. CPAC believes that adults should be permitted to handle such firearms, supports the founders' belief in the Second Amendment, and opposed this bill. The Assembly passed this bill on April 21, 2023 by a vote of 26-14 but Governor Lombardo vetoed the bill.

---

### **AB 359 Taking the Power to Directly Control Fuel Tax Increases Away from the People.**

This bill removes a requirement stating that a majority of voters must approve a countywide fuel tax increase before it can go into effect. In its place, the bill allows the county's board of commissioners to adopt ordinances authorizing such increases without the explicit agreement of voters. CPAC opposes measures that allow for wanton tax increases and opposed this bill. The Assembly passed this bill on April 19, 2023 by a vote of 32-10 but Governor Lombardo vetoed the bill.

---

### **SB 363 Instituting a New Marriage Penalty on Affordable Housing.**

This bill allows bureaucrats operating Nevada's Account for Affordable Housing to prioritize the funding of housing projects aimed at assisting formerly incarcerated women and single people with children. CPAC sees no good reason to transform formerly incarcerated women into a privileged group, believes that this law inappropriately incentivizes single parenthood, and opposed this bill. The House passed this bill on May 24, 2023 by a vote of 29-13 and the bill later became law.

---

### **AB 383 Protecting Nevadan Abortionists from Government Intrusion.**

This bill prohibits public entities from interfering with a person's reception of an abortion. CPAC believes abortion is always a human tragedy, opposes its protection, and opposed this bill. The Assembly passed this bill on June 1, 2023 by a vote of 28-14 but Governor Lombardo vetoed the bill.

---

### **AB 394 Interfering with the Accuracy of Vote Tabulations.**

This bill prohibits election officials counting ballots a second time save during certain audits. CPAC opposes measures that reduce election security and opposed this bill. The Senate passed this bill on April 14, 2023 by a vote of 28-14 but Governor Lombardo vetoed the bill.



### **AB 396 Requiring Taxpayers to Offset Other People's Housing Costs.**

This bill apportions millions of dollars to a rental assistance program. CPAC does not believe that taxpayers should be forced to pay off other people's housing costs and opposed this bill. The Assembly passed this bill on June 3, 2023 by a vote of 36-6 and the bill later became law.

---

### **AB 428 Forcing Taxpayers to Pay Off the Tuition of Nevadan Teachers.**

This bill establishes a program whereby teachers serving in Nevada's public schools may have some of their tuition reimbursed after working in an educational capacity for at least 3 years. The bill also establishes a program to develop "career pathways" aimed at funneling people into positions that meet the long-term needs of the state. CPAC does not believe that taxpayers should be forced to help pay for other people's tuition and opposed this bill. The Assembly passed this bill on June 2, 2023 by a vote of 42-0 and the bill later became law.

---

### **SB 1(SS) \$380,000,000 Giveaway to a Wealthy Sports Team.**

This bill commits \$380,000,000 in tax credits and bond proceeds to the construction of a new baseball stadium in Las Vegas such that the Oakland Athletics may relocate themselves to Nevada. CPAC believes that taxpayers should not be forced to subsidize wealthy sports teams or leagues and opposed this bill. The Assembly passed this bill on June 14, 2023 by a vote of 25-15 and the bill later became law.

---

### **SB 131 Transforming Nevada into a Sanctuary State for Abortionists.**

This bill prohibits medical licensing boards from denying a license to a physician because of their participation in abortion procedures. It also prohibits the governor from surrendering a person for arrest who has been charged in another state for participating in an abortion. CPAC believes abortion is always a human tragedy, opposes its protection, and opposed this bill. The Assembly passed this bill on May 22, 2023 by a vote of 27-14 and the bill later became law.

---

### **SB 153 Making Nevadan Prisons Less Safe for Women.**

This bill allows the government to permit men who believe that they are women to be incarcerated with women. CPAC opposes measures that open female prisoners up to sexual abuse, further opposes measures that gratify transgender ideology, and opposed this bill. The Assembly passed this bill on May 23, 2023 by a vote of 28-14 and the bill later became law.



## **SB 163 Driving Up Nevada's Insurance Costs with More Mandates.**

This bill requires insurance plans to cover "medically necessary" treatments for gender dysphoria and gender incongruence. CPAC recognizes that, because of the broadness of the interpretations of the term "medically necessary," coverage will undoubtedly be provided for radical gender surgeries and hormone replacement therapy. CPAC opposes insurance mandates, opposes the socialization of the costs of grotesque and unethical treatments related to gender dysphoria, and opposed this bill. The Assembly passed this bill on June 4, 2023 by a vote of 26-14 and the bill later became law.

---

## **SB 210 Instituting DEI Requirements for State Appointments.**

This bill states that it is the public policy of Nevada to appoint people that reflect the ethnic and gender identity diversity of the state to state boards and other public positions. CPAC believes that individuals should be appointed to government positions because of their merits and not because of their perceived "gender identity" and opposed this bill. The Assembly passed this bill on May 22, 2023 by a vote of 27-14 but Governor Lombardo vetoed the bill.

---

## **SB 240 Government Investments in Favored Businesses.**

This bill establishes a tax credit program designed to promote investments into "impact qualified low-income community businesses." A company can qualify as one of these businesses by having 51% or more of its ownership interest in the hands of women, favored racial groups, or LGBTQ+ people. CPAC opposes government favoritism toward particular racial and ethnic groups and opposed this bill. The Assembly passed this bill on June 3, 2023 by a vote of 42-0 and the bill later became law.

---

## **SB 251 Upholding Public Union Interests at the Expense of Students.**

This bill requires local school precincts to hire union-backed teachers from large school districts that are laid off as a result of a situation in which there are too many employees within the large school district. CPAC recognizes that this provision harms the ability of principals to hire teachers that are most suited to the needs of their students, supports the interests of students over those of teachers' unions, and opposed this bill. The Assembly passed this bill on May 26, 2023 by a vote of 26-14 but Governor Lombardo vetoed the bill.

---

## **SB 275 Imposing Rent Controls on Manufactured Home Parks.**

This bill prohibits the owners of manufactured home parks from increasing rent by a rate greater than a specific rate annually set by the Department of Business and Industry. CPAC supports property rights, recognizes that rent controls contribute to shortages in housing, and opposed this bill. The Assembly passed this bill on June 3, 2023 by a vote of 28-14 but Governor Lombardo vetoed the bill.



**SB 302 Transforming Nevada Into a Sanctuary State for Radical Gender Surgeries.**

This bill prohibits medical licensing boards from retaliating against physicians for participating in so-called “gender-affirming care.” The bill also prohibits the government from assisting other states that are conducting investigations related to “gender-affirming care.” CPAC opposes the promotion of transgender ideology and opposed this bill. The Assembly passed this bill on May 25, 2023 by a vote of 28-14 but Governor Lombardo vetoed the bill.

---

**SB 404 Weakening Residency Requirements for the Purposes of Voter Registration.**

This bill allows individuals to register to vote using a variety of non-governmental forms of identification. For example, it allows individuals to use their utility bill, a statement concerning the mortgage of their residence, a bank statement, and other documents for this purpose. CPAC recognizes that increasing the list of non-governmental documents that may be used to fulfill voter registration requirements reduces election security, opposes measures that reduce election security, and opposed this bill. The House passed this bill on May 24, 2023 by a vote of 28-14 but Governor Lombardo vetoed the bill.

---

**SB 429 Requiring Nevadan Employers to Implement a Paid Family and Medical Leave Program.**

This bill requires employers to offer at least 12 weeks of paid family and medical leave to their employees. CPAC believes that employees should negotiate their own salaries and benefits with employers and opposed this bill. The Assembly passed this bill on May 26, 2023 by a vote of 26-14 but Governor Lombardo vetoed the bill.
