## SELECTING THE VOTES

The Center for Legislative Accountability (CLA), an initiative of the CPAC Foundation, is the premier organization for holding lawmakers accountable. The CLA produces the longest-running conservative congressional scorecard and our state program is the only one in the nation that scores all 8,000 lawmakers in the 50 states across every policy area.

In 1971, ACUF launched its Ratings of Congress to provide a comprehensive evaluation of the voting records of every Member of Congress. The Ratings quickly became considered the “gold standard” and over the following decades have been utilized by activists, voters, academics and elected officials to determine which lawmakers best adhere to conservative principles.

In 2011, these Ratings were expanded into state legislatures as part of a five-state pilot program. By 2015, Ratings of the States grew to include all 50 states and all 99 legislative chambers. Today, the CLA annually analyzes over 105,000 pieces of legislation to issue scores for all of America’s federal and state lawmakers and presents awards to lawmakers who score 80% or better in recognition of their conservative voting records.

In order to depict how closely a lawmaker adheres to conservative principles, the CLA selects from the full spectrum of issues relating to the economy, culture, national security and government integrity. Some key areas include taxation, spending, education, labor, licensure, regulation, environment, life, free speech, Second Amendment rights, foreign aid, defense priorities and global organizations, including the United Nations. All congressional and state analyses are conducted after the adjournment of a legislative session to ensure that no issue is neglected.

To determine legislative rankings, the CLA annually evaluates over 105,000 bills that were introduced in Congress and every convening state legislature running from January 1 to December 31.

Of those bills, the CLA ultimately selects roughly 2,000 pieces of legislation that best illustrate how elected officials view the role of government in an individual's life. The CLA calculates individual scores for a total of nearly 8,000 federal and state lawmakers based on over 157,000 votes cast on the 2,000 bills selected.

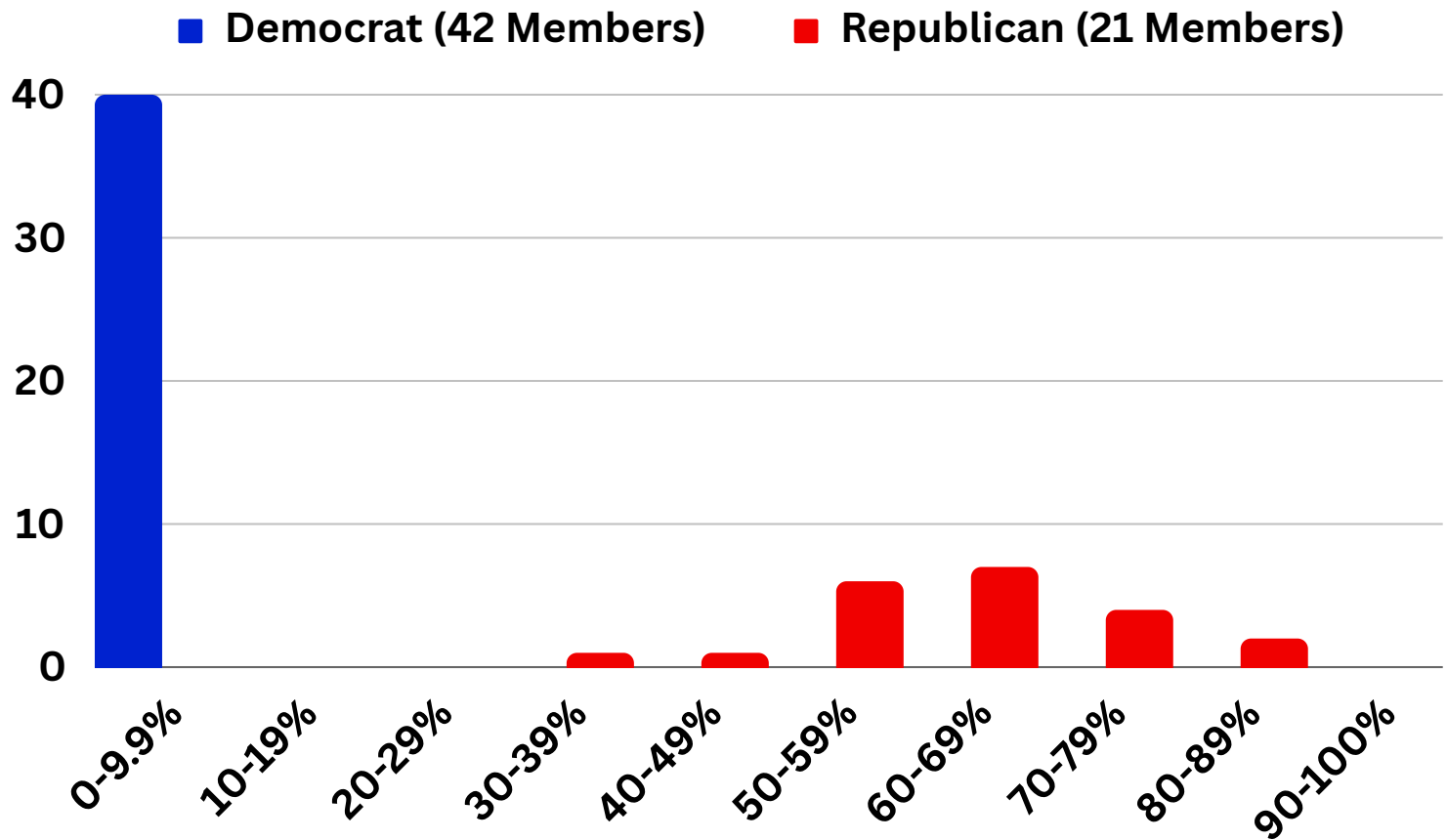

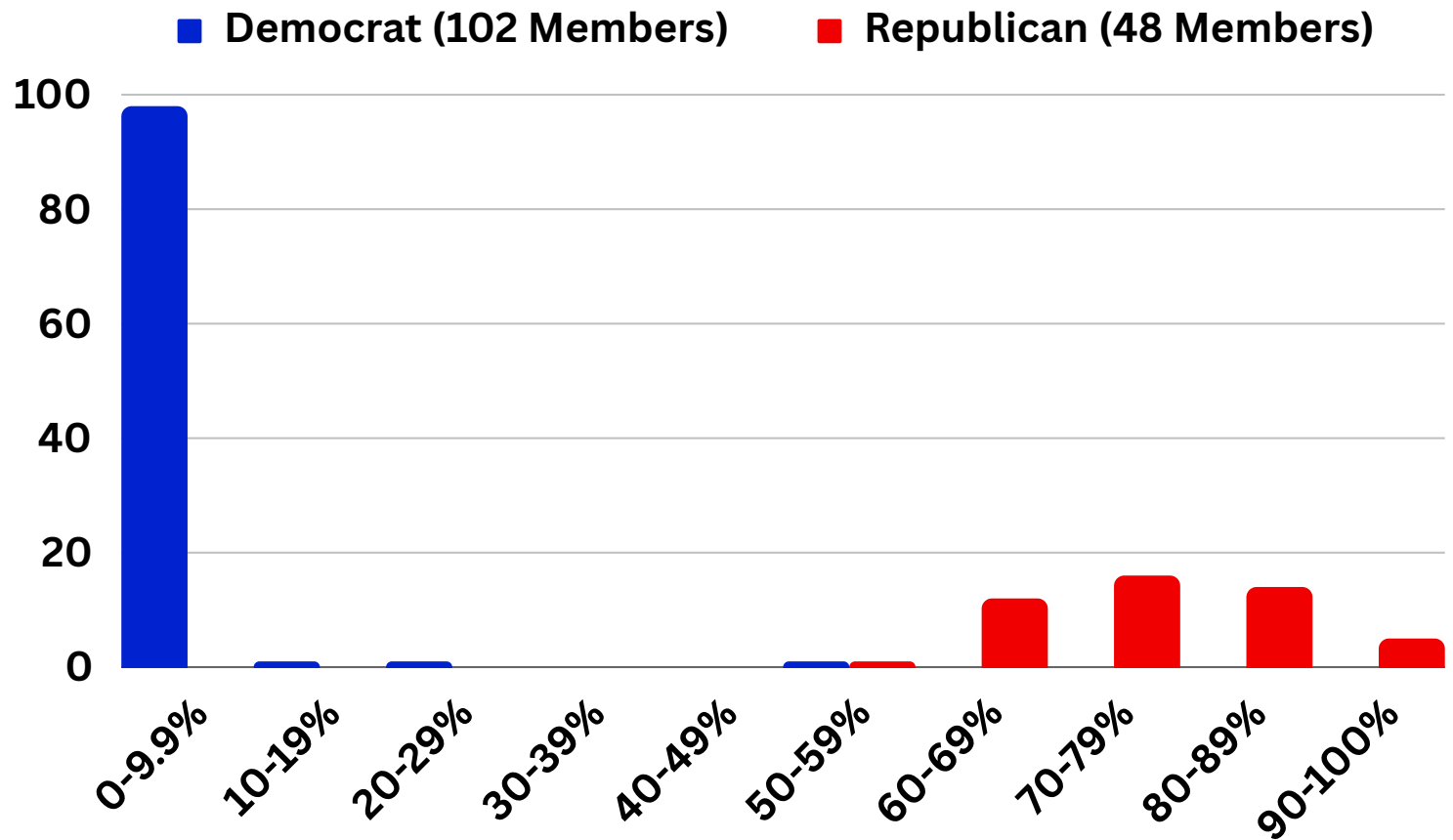

### **A 1142 Providing for the Erasure of Women and Men from Public Law.**

This bill prohibits all public laws and regulations issued by the state in the future from containing gendered language. CPAC recognizes that this provision sets the state up to remove mothers and fathers from law, opposes measures that gratify radical gender theory, and opposed this bill. The Senate passed this bill on May 22, 2023 by a vote of 46-15 and the bill later became law.

---

### **A 1177 Reducing Election Security by Increasing the Tabulation of Potentially Fraudulent Ballots.**

This bill allows tabulators to count ballots that have been sealed with tape or glue during an election. CPAC opposes measures that blatantly reduce ballot security and opposed this bill. The Senate passed this bill on June 9, 2023 by a vote of 42-21 and the bill later became law.

---

### **A 1283 Absurd Expansion of Civil Rights Law.**

This bill states that no person may be subject to discrimination by any firm or corporation because of their gender identity or decision to have an abortion. CPAC believes that this measure constitutes a flagrant violation of First Amendment freedoms, recognizes that its passage would bring a blizzard of frivolous lawsuits down onto conservative businesses, and opposed this bill. The Senate passed this bill on January 24, 2023 by a vote of 43-20 but the bill never became law.

---

### **A 1395 Providing Access to Prescription Abortion Drugs at New York's Public Universities.**

This bill requires all public universities to provide students with access to abortion drugs. CPAC believes abortion is always a human tragedy, opposes the expansion of the practice, and opposed this bill. The Senate passed this bill on April 19, 2023 by a vote of 42-18 and the bill later became law.

---

### **A 4956 Forcing Taxpayers to Pay Other People's Utility Bills.**

This bill establishes an emergency heating energy assistance program to provide funds to people who are at risk of having their electricity shut off because they did not pay their utility bills. CPAC believes that this will incentivize the nonpayment of utility bills, believes that taxpayers should not be forced to pay other people's utility bills, and opposed this bill. The Senate passed this bill on June 8, 2023 by a vote of 57-5 but the bill never became law.



## **A 7355 Enabling Even More Frivolous Lawsuits Against Conservatives.**

This bill prohibits entities from discriminating against people based on their “gender identity” under New York’s human rights law. CPAC recognizes that this provision will serve as a means of waging war upon conservatives that do not unabashedly affirm Leftist principles and opposed this bill. The Senate passed this bill on June 5, 2023 by a vote of 57-4 and the bill later became law.

---

## **S 616 Allowing Political Agents to Better Bribe Voters.**

This bill expands the list of items that individuals may give to people waiting in line at the polls. CPAC opposes this clear form of election fraud, opposes the buying of votes with material gifts at the polls, and opposed this bill. The Senate passed this bill on January 9, 2023 by a vote of 45-15 but the bill never became law.

---

## **S 818 Quickening Reductions in Election Security by Moving Up the Timetable for Fraud-Promoting Election Laws.**

This bill amends the John R. Lewis Voting Rights Act such that it now comes into law on July 1, 2023. CPAC recognizes that the numerous ambiguous restrictions that this act places onto election officials open further opportunities for vote fraud, opposes measures that decrease election security, and opposed this bill. The Senate passed this bill on February 8, 2023 by a vote of 41-21 and the bill later became law.

---

## **S 1066 Strengthening Laws Constituting New York as a Sanctuary State for Abortionists.**

This bill amends existing law to expand protections for abortions within the state of New York. For example, it expands the list of people who may not cooperate with out-of-state governments investigating abortions to include all government employees. CPAC believes abortion is always a human tragedy, opposes its protection, and opposed this bill. The Senate passed this bill on May 30, 2023 by a vote of 39-22 and the bill later became law.

---

## **S 1326 Extending the Tendrils of Onerous Employment Mandates.**

This bill expands provisions requiring that employers disclose salary ranges on their job postings by requiring that such information be provided in disclosures about promotions and transfer opportunities and by requiring that such information be provided when the job is to be performed outside of New York state under the direction of a supervisor in New York. CPAC opposes measures that micromanage employer hiring practices and opposed this bill. The Senate passed this bill on February 8, 2023 by a vote of 48-14 and the bill later became law.



## **S 1346 Raising Costs on Taxpayers with Electric Vehicle Mandates.**

This bill requires each state agency to prepare a fleet decarbonization plan and to transition entirely to zero emission vehicles by 2035. CPAC supports all forms of energy, does not believe that the government should support one form of energy over another, recognizes that this measure will incur high costs to taxpayers, and opposed this bill. The Senate passed this bill on February 8, 2023 by a vote of 50-12 and the bill later became law.

---

## **S 1359 Bloating the DEI Bureaucracy.**

This bill establishes the Office of Racial Equity and Social Justice, the likes of which will assist the state in carrying out its racist DEI initiatives. CPAC opposes the expansion of the bureaucracy, opposes the expansion of DEI initiatives, and opposed this bill. The Senate passed this bill on March 27, 2023 by a vote of 42-21 but the bill never became law.

---

## **S 1419 Special Privileges for Government-Favored Businesses.**

This bill requires state agencies, upon denying a minority- or women-owned business a part in a public contract, to send them the following information: the identity of the successful bidders, the business' reason for not being selected, guidance about how the business may make more successful proposals, and information about the state's opportunities for women- and minority-owned businesses. CPAC opposes the creation of racist and sexist laws and opposed this bill. The Senate passed this bill on February 7, 2023 by a vote of 60-1 but the bill never became law.

---

## **S 1731 Hampering the Hiring Efforts of Employers throughout New York.**

This bill prohibits employers from considering a person's credit score when deliberating over whether they should hire that person. CPAC believes that this measure will weaken the ability of employers to hire the correct people, opposes government interference in the hiring process, and opposed this bill. The Senate passed this bill on June 7, 2023 by a vote of 41-20 but the bill never became law.

---

## **S 2440 Implanting the Fat Pride Agenda into Employer Mandates.**

This bill prohibits employers from discriminating against employees and potential employees because of their weight. CPAC opposes measures that micromanage employer hiring practices, recognizes that this measure constitutes a severe burden on employers, and opposed this bill. The Senate passed this bill on June 6, 2023 by a vote of 54-8 but the bill never became law.



## **S 2475 Transforming New York into a Sanctuary State for Radical Transgenderism.**

This bill prohibits the state from aiding out-of-state law enforcement agencies in procuring information about a person's reception of radical gender surgeries. The bill also allows the state to ignore laws from other states that would remove a child from one of their parents' care if the parent is helping the child receive hormone replacement therapy or a gender surgery. CPAC opposes child mutilation, opposes its promotion by the government, and opposed this bill. The Senate passed this bill on June 6, 2023 by a vote of 44-18 and the bill later became law.

---

## **S 2674 Further Extending Welfare Benefits for Favored Individuals.**

This bill raises the cutoff age at which "homeless youths" may no longer receive shelter services from 21 to 24. CPAC opposes the expansion of welfare programs and opposed this bill. The Senate passed this bill on June 1, 2023 by a vote of 43-15 but the bill never became law.

---

## **S 3609 Providing More Means of Protecting Abortion Services.**

This bill requires that a person's future access to abortion procedures be considered in health equity impact assessments. CPAC believes abortion is always a human tragedy, opposes the Left's transformation of abortion into a holy sacrament, and opposed this bill. The Senate passed this bill on March 30, 2023 by a vote of 39-23 but the bill never became law.

---

## **S 4511 Loan Forgiveness for One of the Highest Paid Professions in the Country.**

This bill expands the state loan forgiveness program for certain attorneys favored by the government. CPAC opposes the provision of welfare to wealthy attorneys and opposed this bill. The Senate passed this bill on May 31, 2023 by a vote of 57-1 but the bill never became law.

---

## **S 4818 Expanding Barriers to Second Amendment Freedoms.**

This bill requires that individuals wait 10 days after purchasing a firearm to claim that firearm. CPAC supports the founders' belief in the Second Amendment and opposed this bill. The Senate passed this bill on June 7, 2023 by a vote of 42-19 but the bill never became law.

---

## **S 4859 Government Largesse for Favored Businesses.**

This bill dually prohibits the government from contracting with businesses whose supply chains contribute to tropical forest degradation and establishes the supply chain transparency assistance program, the likes of which would assist minority- and women-owned business in complying with this measure. CPAC opposes government favoritism toward particular racial groups and opposed this bill. The Senate passed this bill on April 25, 2023 by a vote of 42-19 but the bill never became law.



## **S 4887 Majorly Increasing the Cost of Utilities for Taxpayers.**

This bill requires that contractors working on projects wherein they are required to excavate or use streets pay their workers the prevailing wage. CPAC opposes measures that grossly increase the cost of government projects for taxpayers and opposed this bill. The Senate passed this bill on June 5, 2023 by a vote of 53-8 and the bill later became law.

---

## **S 4907 Compromising the Ability of Consumer Reporting Agencies to Accurately Construct Credit Scores.**

This bill prohibits medical service providers from reporting medical debt to a consumer reporting agency. It also prohibits such agencies from including medical debt in their reports. CPAC recognizes that this mandate will damage the ability of financial institutions to properly make decisions regarding loans and opposed this bill. The Senate passed this bill on May 31, 2023 by a vote of 50-8 but the bill never became law.

---

## **S 4982 Micromanaging Workplace Meetings in New York.**

This bill prohibits employers from requiring their employees to attend workplace meetings related to politics, including those that concern labor unions. CPAC opposes the government's micromanagement of the workplace, opposes measures that permit the government to do the dirty work of unions, and opposed this bill. The Senate passed this bill on June 8, 2023 by a vote of 53-9 and the bill later became law.

---

## **S 5853 Subsidies for Government-Favored Landscaping Equipment.**

This bill establishes the electric landscaping equipment rebate program, the likes of which will provide rebates to entities that purchase electric landscaping equipment. CPAC supports all forms of energy, does not believe that the government should support one form of energy over another, and opposed this bill. The Senate passed this bill on June 7, 2023 by a vote of 58-3 but the bill never became law.

---

## **S 6350 Aiding and Abetting those Hoping to Show Pornography to Children in Schools.**

This bill enacts provisions that "empower" librarians to insert any book that they deem "developmentally appropriate" into the shelves of their library. CPAC believes that the ambiguity of this bill will enable Leftist librarians and schools to make pornography and other materials associated with the LGBT+ agenda available to young children and opposed this bill. The Senate passed this bill on June 6, 2023 by a vote of 61-1 but the bill never became law.

### **A 856 Government Micromanagement of Employer Hiring Practices.**

This bill prohibits employers from requiring, as a condition of employment, that a worker waive certain privileges. CPAC opposes measures that micromanage employer hiring practices, recognizes that this measure constitutes a severe burden on employers, and opposed this bill. The Assembly passed this bill on May 17, 2023 by a vote of 97-49 but the bill never became law.

---

### **A 1142 Providing for the Erasure of Women and Men from Public Law.**

This bill prohibits all public laws and regulations issued by the state in the future from containing gendered language. CPAC recognizes that this provision sets the state up to remove mothers and fathers from law, opposes measures that gratify radical gender theory, and opposed this bill. The Assembly passed this bill on May 17, 2023 by a vote of 93-53 and the bill later became law.

---

### **A 1177 Reducing Election Security by Increasing the Tabulation of Potentially Fraudulent Ballots.**

This bill allows tabulators to count ballots that have been sealed with tape or glue during an election. CPAC opposes measures that blatantly reduce ballot security and opposed this bill. The Assembly passed this bill on June 7, 2023 by a vote of 100-48 and the bill later became law.

---

### **A 1273 Expanding the Left's Infiltration of the Bureaucracy.**

This bill establishes the LGBTQ+ Advisory Board, the likes of which will only contain LGBT+ individuals and advise the state government on ways it can benefit the LGBT+ community. CPAC opposes government measures that expressly benefit a favored class of people, opposes the infiltration of the LGBT+ agenda into the halls of government, and opposed this bill. The Assembly passed this bill on May 30, 2023 by a vote of 141-3 but the bill never became law.

---

### **A 1283 Absurd Expansion of Civil Rights Law.**

This bill states that no person may be subject to discrimination by any firm or corporation because of their gender identity or decision to have an abortion. CPAC believes that this measure constitutes a flagrant violation of First Amendment freedoms, recognizes that its passage would bring a blizzard of frivolous lawsuits down onto conservative businesses, and opposed this bill. The Assembly passed this bill on January 24, 2023 by a vote of 97-46 but the bill never became law.

---

### **A 1395 Providing Access to Prescription Abortion Drugs at New York's Public Universities.**

This bill requires all public universities to provide students with access to abortion drugs. CPAC believes abortion is always a human tragedy, opposes the expansion of the practice, and opposed this bill. The Assembly passed this bill on April 18, 2023 by a vote of 100-49 and the bill later became law.



### **A 4956 Forcing Taxpayers to Pay Other People’s Utility Bills.**

This bill establishes an emergency heating energy assistance program to provide funds to people who are at risk of having their electricity shut off because they did not pay their utility bills. CPAC believes that this will incentivize the nonpayment of utility bills, believes that taxpayers should not be forced to pay other people’s utility bills, and opposed this bill. The Assembly passed this bill on June 5, 2023 by a vote of 96-49 but the bill never became law.

---

### **A 5212 Providing for Sexist Appointments to State Boards.**

This bill enacts various measures that attempt to promote a balance between the genders in the list of people appointed to state and local boards. CPAC recognizes that this measure is absolutely ludicrous by the Left’s standards because of the supposed infinite quantity of genders that exist in the Left’s belief system. Regardless, CPAC opposes measures that facilitate decision-making based on sexist principles and opposed this bill. The Assembly passed this bill on May 23, 2023 by a vote of 119-30 but the bill never became law.

---

### **A 7355 Enabling Even More Frivolous Lawsuits Against Conservatives.**

This bill prohibits entities from discriminating against people based on their “gender identity” under New York’s human rights law. CPAC recognizes that this provision will serve as a means of waging war upon conservatives that do not unabashedly affirm Leftist principles and opposed this bill. The Assembly passed this bill on May 30, 2023 by a vote of 141-3 and the bill later became law.

---

### **S 818 Quickening Reductions in Election Security by Moving Up the Timetable for Fraud-Promoting Election Laws.**

This bill amends the John R. Lewis Voting Rights Act such that it now comes into law on July 1, 2023. CPAC recognizes that the numerous ambiguous restrictions that this act places onto election officials open further opportunities for vote fraud, opposes measures that decrease election security, and opposed this bill. The Assembly passed this bill on June 10, 2023 by a vote of 95-45 and the bill later became law.

---

### **S 1066 Strengthening Laws Constituting New York as a Sanctuary State for Abortionists.**

This bill amends existing law to expand protections for abortions within the state of New York. For example, it expands the list of people who may not cooperate with out-of-state governments investigating abortions to include all government employees. CPAC believes abortion is always a human tragedy, opposes its protection, and opposed this bill. The Assembly passed this bill on June 20, 2023 by a vote of 98-47 and the bill later became law.



## **S 1326 Extending the Tendrils of Onerous Employment Mandates.**

This bill expands provisions requiring that employers disclose salary ranges on their job postings by requiring that such information be provided in disclosures about promotions and transfer opportunities and by requiring that such information be provided when the job is to be performed outside of New York state under the direction of a supervisor in New York. CPAC opposes measures that micromanage employer hiring practices and opposed this bill. The Assembly passed this bill on February 13, 2023 by a vote of 88-50 and the bill later became law.

---

## **S 1359 Bloating the DEI Bureaucracy.**

This bill establishes the Office of Racial Equity and Social Justice, the likes of which will assist the state in carrying out its racist DEI initiatives. CPAC opposes the expansion of the bureaucracy, opposes the expansion of DEI initiatives, and opposed this bill. The Assembly passed this bill on June 5, 2023 by a vote of 129-16 but the bill never became law.

---

## **S 1419 Special Privileges for Government-Favored Businesses.**

This bill requires state agencies, upon denying a minority- or women-owned business a part in a public contract, to send them the following information: the identity of the successful bidders, the business' reason for not being selected, guidance about how the business may make more successful proposals, and information about the state's opportunities for women- and minority-owned businesses. CPAC opposes the creation of racist and sexist laws and opposed this bill. The Assembly passed this bill on June 20, 2023 by a vote of 107-39 but the bill never became law.

---

## **S 1346 Raising Costs on Taxpayers with Electric Vehicle Mandates.**

This bill requires each state agency to prepare a fleet decarbonization plan and to transition entirely to zero emission vehicles by 2035. CPAC supports all forms of energy, does not believe that the government should support one form of energy over another, recognizes that this measure will incur high costs to taxpayers, and opposed this bill. The Assembly passed this bill on March 15, 2023 by a vote of 102-43 and the bill later became law.

---

## **S 2475 Transforming New York into a Sanctuary State for Radical Transgenderism.**

This bill prohibits the state from aiding out-of-state law enforcement agencies in procuring information about a person's reception of radical gender surgeries. The bill also allows the state to ignore laws from other states that would remove a child from one of their parents' care if the parent is helping the child receive hormone replacement therapy or a gender surgery. CPAC opposes child mutilation, opposes its promotion by the government, and opposed this bill. The Assembly passed this bill on June 10, 2023 by a vote of 97-47 and the bill later became law.





### **S 3609 Providing More Means of Protecting Abortion Services.**

This bill requires that a person's future access to abortion procedures be considered in health equity impact assessments. CPAC believes abortion is always a human tragedy, opposes the Left's transformation of abortion into a holy sacrament, and opposed this bill. The Assembly passed this bill on June 7, 2023 by a vote of 98-50 but the bill never became law.

### **S 4859 Government Largesse for Favored Businesses.**

This bill dually prohibits the government from contracting with businesses whose supply chains contribute to tropical forest degradation and establishes the supply chain transparency assistance program, the likes of which would assist minority- and women-owned business in complying with this measure. CPAC opposes government favoritism toward particular racial groups and opposed this bill. The Assembly passed this bill on June 21, 2023 by a vote of 115-26 but the bill never became law.

### **S 4887 Majorly Increasing the Cost of Utilities for Taxpayers.**

This bill requires that contractors working on projects wherein they are required to excavate or use streets pay their workers the prevailing wage. CPAC opposes measures that grossly increase the cost of government projects for taxpayers and opposed this bill. The Assembly passed this bill on June 8, 2023 by a vote of 132-16 and the bill later became law.

### **S 4907 Compromising the Ability of Consumer Reporting Agencies to Accurately Construct Credit Scores.**

This bill prohibits medical service providers from reporting medical debt to a consumer reporting agency. It also prohibits such agencies from including medical debt in their reports. CPAC recognizes that this mandate will damage the ability of financial institutions to properly make decisions regarding loans and opposed this bill. The Assembly passed this bill on June 20, 2023 by a vote of 109-38 but the bill never became law.

### **S 4982 Micromanaging Workplace Meetings in New York.**

This bill prohibits employers from requiring their employees to attend workplace meetings related to politics, including those that concern labor unions. CPAC opposes the government's micromanagement of the workplace, opposes measures that permit the government to do the dirty work of unions, and opposed this bill. The Assembly passed this bill on June 10, 2023 by a vote of 112-28 and the bill later became law.
