# AIRCRAFT EXEMPTION AFFIDAVIT

## INCOMPLETE AFFIDAVIT FORMS WILL BE RETURNED TO SENDER

**THIS AFFIDAVIT MUST BE FILED ON OR BEFORE THE LAST DAY OF FEBRUARY OR WITHIN SIXTY (60) DAYS AFTER PURCHASE OF AIRCRAFT OR ENTRY OF AIRCRAFT INTO ARIZONA. FAILURE TO DO SO REQUIRES THE PAYMENT OF THE REGISTRATION FEE, LICENSE TAX AND A \$25 PENALTY WITH AN ADDITIONAL \$5 PENALTY FOR EACH SUBSEQUENT MONTH OF DELINQUENCY AS PROVIDED UNDER A.R.S. § 28-8329.**
