RECORD ON SMALL BUSINESS
ISSUES | 2020 EDITION

Roll call votes by your state legislators on small business issues are listed here. While the Voting Record does not reflect all elements considered by a lawmaker when voting, it is a guide to evaluating your legislators' attitudes toward small business. Many issues affecting small business are decided in committees and never make it to the floor of the House and Senate. Please thank those legislators who supported small business.

SENATE AND HOUSE

- 1. Personal Income Taxes.** SB211 by Sen. Jon Dismang. Cuts income taxes by \$103 million per year by reducing the top tax rate from 6.9% to 5.9%. Will create income tax savings for 579,000 taxpayers. Passed the Senate 28-5 with 2 not voting. Passed the House 82-14 with 4 not voting. Signed by the governor. **A "Yes" vote supports NFIB's position on the bill.**
- 2. Business Income Taxes.** SB576 by Sen. Bart Hester. Increases the net loss carryforward from 5 years to 10. Will save Arkansas small businesses \$70 million per year. Reduces corporate tax rates from 6.9% to 5.9% which will save businesses another \$39 million per year. Passed the Senate 31-3 with 1 not voting. Passed the House 68-20 with 12 not voting. Signed by the governor. **A "Yes" vote supports NFIB's position on the bill.**
- 3. Unemployment Insurance Reform.** SB298 by Sen. Kim Hammer. Reduces the amount of wages that employers pay unemployment insurance on from the first \$10,000.00 to the first \$7,000. Creates a \$40 million savings for small business. Passed the Senate 34-1. Passed the House 84-8 with 8 not voting. Signed by the governor. **A "Yes" vote supports NFIB's position on the bill.**
- 4. Healthcare Insurance.** HB1837 by Rep. Austin McCollum. Allows associations such as NFIB to allow members to band together to buy health insurance from a large insurance company. It would create significant savings for our members versus buying a policy for their own business. Passed the Senate 34-0 with 1 excused. Passed the House 92-0 with 8 not voting and 1 present. Signed by the governor. **A "Yes" vote supports NFIB's position on the bill.**

- 5. General Employment.** HB1850 by Rep. Austin McCollum. Changes the definitions of employer and contractor for unemployment insurance and workers' compensation purposes. Seeks to stop government agencies from making contractors employees. Passed the Senate 24-4 with 7 not voting. Passed the House 82-9 with 6 not voting and 1 present. Signed by the governor. **A "Yes" vote supports NFIB's position on the bill.**

SENATE ONLY

- 6. Family Law.** HB1686 by Rep. Andrew Collins. Would have changed state law so that a farm or business inherited before marriage would be considered marital property and make any increase in the value of that business a marital asset if the owner also worked there; it would not have applied to people with a stake in a family business who worked someplace else. The bill would have made it more difficult to hand ownership of a family farm or business to subsequent generations. Failed in the Senate by a vote of 9-18 with 8 not voting. **A "No" vote supported the NFIB position.**

HOUSE ONLY

- 7. Government Overreach.** House Bill 1309 by Rep. Stephen Meeks. "The Night Sky Bill" sought to limit a business owners' ability to up a lighted sign on their business and how bright the sign could be. Failed the House 33-38 with 29 not voting. **A "No" vote supports NFIB's position on the bill.**
