BOTH CHAMBERS

- 1. Corporate Income Tax Rate Reduction (2021-LB 432):** LB 432 contained provisions to reduce the maximum corporate income tax rate. **A "NO" vote supports the NFIB position.** A General File amendment to remove these provisions from the bill failed on a vote of 23-23.
- 2. Corporate Income Tax Rate Reduction (2021-LB 432):** A General File amendment to reduce maximum corporate income tax rates from 7.81% to 6.84%. **A "YES" vote supports the NFIB position.** The amendment was adopted on a vote of 30-7.
- 3. Property Tax Request Act (2021-LB 408):** LB 408 would have limited the annual increase in property taxes imposed by political subdivisions. **A "YES" vote supports the NFIB position.** A motion to invoke cloture failed on a vote of 29-8.
- 4. Consumption Tax (2021-LR 11CA):** LR 11CA proposed a Constitutional Amendment to allow voters to consider adoption of a "consumption tax" (tax on services and purchases of new goods) and repeal all other forms of taxation. **A "NO" vote supports the NFIB position.** The proposed Constitutional Amendment failed to advance on a vote of 23-19.
- 5. Paid Sick Leave (2021-LB 258):** LB 258 would have adopted paid sick leave for employees. **A "NO" vote supports the NFIB position.** A vote to advance the bill from General File failed to advance on a vote of 17-20.
- 6. Income/Property Tax Relief (2021-LB 825):** LB 825 would have reduced maximum individual and corporate income tax rates, provided additional property tax relief, and repealed the income tax on Social Security benefits. **A "YES" vote supports the NFIB position.** A motion to invoke cloture failed on a vote of 32-0.
- 7. Income/Property Tax Relief (2022-LB 873):** LB 873 provides significant income and property tax relief for individuals and businesses. **A "YES" vote supports the NFIB position.** An amendment to reduce maximum individual income tax rates was adopted on a vote of 43-0. Signed by the governor.
- 8. Corporate Income/Property Tax Relief (2022-LB 873):** LB 873 provides significant income and property tax relief for individuals and businesses. **A "YES" vote supports the NFIB position.** An amendment to reduce maximum corporate income tax rates was adopted on a vote of 32-12. Signed by the governor.
- 9. State Budget Bill-Workforce Housing (2022-LB 1013):** LB 1013 is the state budget bill. **A "YES" vote supports the NFIB position.** An amendment to provide funding for Rural Workforce and Middle-Income Workforce Housing was adopted on a vote of 40-3. Signed by the governor.
- 10. Consumption Tax (2022-LR 264CA):** LR 264CA proposed a Constitutional Amendment to allow voters to consider adoption of a "consumption tax" (tax on services and purchases of new goods) and repeal all other forms of taxation. **A "NO" vote supports the NFIB position.** The proposed Constitutional Amendment failed to advance on a vote of 19-14.
- 11. School Spending Restraints (2022-LB 986):** LB 986 would have placed restrictions on the amount of growth in property taxes imposed by school districts each year. **A "YES" vote supports the NFIB position.** A motion to invoke cloture failed on a vote of 28-21.

12. Vaccine Exemptions (2022-LB 906): LB 906, as originally introduced contained broad vaccine provisions. An amendment to narrow the scope of the bill to align with the COVID-19 vaccine requirements under federal law. **A "YES" vote supports the NFIB position.** The amendment was adopted on a vote of 35-0. Signed by the governor.

13. Rural Workforce Housing Investment Fund (2022-LB 1069): LB 1069 extends the Rural Workforce Housing Act for an additional five years and reduces the local matching requirements for receiving workforce housing funds. **A "YES" vote supports the NFIB position.** Advancement of the bill from General File to Select File was adopted on a 30-3 vote. Signed by the governor.
