Linear regression: Taking a high school civics class as a predictor of civics knowledge items (controlling for sex, age, education, race, and political ideology)

We created a knowledge index comprising five items: 1) correctly naming all three branches, 2) correctly naming all 5 First Amendment rights, 3) saying it is inaccurate that the First Amendment says Facebook must permit all Americans to freely express themselves on Facebook pages, 4) saying the Supreme Court has the final say about whether a law is constitutional, and 5) knowing the meaning of a 5-4 Supreme Court decision.

Annenberg Constitution Day Survey 2022 – 2023 Methodology

Between 2006 and 2021, the Annenberg Public Policy Center (APPC) conducted the Annenberg Constitution Day Survey with random digit dialing (RDD) phone surveys. In 2022, APPC conducted the Constitution Day Survey using both an online panel and a RDD phone survey to explore possible differences in responses caused by how the survey was administered ("mode effects"). In 2023, the Constitution Day Survey was only conducted using an online panel.

This Appendix and Topline contain data from the three most recent Constitution Day surveys: the 2023 online panel and the 2022 online panel and 2022 RDD phone sample. Below you will find the methodological summaries of these three surveys. For more detail on the steps we took to change from a telephone to online survey, see the white paper here.

2023 Online Panel Methodology

The Annenberg Public Policy Center of the University of Pennsylvania (APPC) engaged SSRS to conduct the 2023 Civics Knowledge Survey. The survey was conducted via the SSRS Opinion Panel as part of series of APPC projects known as the Annenberg Survey of Attitudes on Public Health (ASAPH). The Civics Knowledge Survey invited U.S. adults aged 18 and older who completed the first ASAPH survey to participate. Data collection was conducted from August 9-15, 2023, among a sample of 1,482 respondents in English (1,455) and Spanish (27). The web total respondents were 1,442 and there were 40 telephone respondents. Data were weighted to represent the target U.S. adult population.

Data were weighted to represent adults 18+ using the SSRS Opinion Panel. The adjusted margin of error for total respondents in the sample is +/-3.5% at the 95% confidence level. The data were weighted by first applying a base weight then balancing the demographic profile of the sample to target population parameters. The total sample design effect for this survey is 1.88.

2022 Online Panel Methodology

The Annenberg Public Policy Center of the University of Pennsylvania (APPC) engaged SSRS to conduct the 2022 Civics Knowledge Survey. The survey was conducted via the SSRS Opinion Panel as part of series of APPC projects known as the Annenberg Survey of Attitudes on Public Health (ASAPH). The Civics Knowledge Survey invited U.S. adults aged 18 and older who completed the first ASAPH survey to participate. Data collection was conducted from August 2-8, 2022, among a sample of 1,584 respondents in English (1,554) and Spanish (30). The web total respondents were 1,546 and there were 38 telephone respondents. Data were weighted to represent the target U.S. adult population.

Data were weighted to represent adults 18+ using the SSRS Opinion Panel. The adjusted margin of error for total respondents in the sample is +/-3.4% at the 95% confidence level. The data were weighted by



first applying a base weight then balancing the demographic profile of the sample to target population parameters. The total sample design effect for this survey is 1.86.

2022 RDD Phone Survey Methodology

The 2022 Annenberg Civics Survey was conducted for the Annenberg Public Policy Center via telephone (CATI) by SSRS, an independent research company. Interviews were conducted August 2 – August 13, 2022, among 1,113 U.S. adults, aged 18 and older. Respondents were drawn from a national probability sample in all 50 states. The dual frame sample included 889 cell phone respondents and 37 respondents who completed the survey in Spanish.

Data were weighted to represent the target U.S. adult population. The adjusted margin of error for total respondents in the sample is +/-3.6% at the 95% confidence level. The design effect is 1.48. Totals in the topline may add up to either greater than or less than 100% due to rounding. For more information on the methodology click [here].
