### Request

A request under Freedom of Information concerning Clos des Pauvres was dated 19 July 2017. It is not absolutely clear, but it seems to be restricted to land held under gifts of the Don Gruchy. The requested information from each Parish was:

- The Fields
- Current rental income
- Length of lease
- To which Parish account the income is allocated and how is it spent
- The current use of the Field

My understanding of the position is that land held under Don Gruchy is not the only such land. I attach photos recording other gifts:



This stone is on La Rue de Croiserie, Trinity. It shows the benefit of the Don Gruchy gift to the parish, with which it acquired land of 9 vergées 7 perches compared to the existing holding of Charité 2 vergées 3 perches.

This stone is on Trinity Main Road:

The next two stones are both in Grouville, the first on Rue Marais à la Cocque, the second on Rue de Fauvic.



All these stones are evidence of gifts of land to the parishes (?) but outside the Don Gruchy, including existing holdings under the heading Charité. Clearly there will be cases other than those I have photographed.

My requested information for each parish is the same as those asked previously in respect of the Don Gruchy ie

- The Fields
- Current rental income
- Length of lease
- To which Parish account the income is allocated and how is it spent
- The current use of the Field

In addition, what particular provisions apply to the separate gifts as they are likely to be outside the provisions applying to Don Gruchy?
