- 1. How many defibrillators is each parish responsible for? (St Ouen, St Brelade, Trinity, St Peter, St Martin, St Lawrence, St Helier, St Saviour, St John, Grouville, St Mary and St Clement).
- 2. Of the defibrillators listed, according to the defibrillator's instructions, how often should each machine have its battery checked? (For example: Weekly, Monthly etc) (To ensure it can be used when needed).
- 3. Of the defibrillators listed, according to the defibrillator's instructions, how often should each machine have the expiry date of its defib pads checked? (For example: Weekly, Monthly).
- 4. Please can you provide confirmation of the date each defibrillator was last/most recently checked?
- 5. Please can each parish identify which defibrillators are currently out of use and cannot be used.
- 6. For each defibrillator which is out of use, please provide a reason why.
