## 2018 AGC Legislative Scorecard Bill Summaries: State Senate

### Floor and Committee votes

**E2SHB 1080.** Authorizes up to \$2,930,230,000 in state general obligation bonds to finance projects in the 2017-19 Capital Budget and to pay expenses incurred in the issuance and sale of the bonds. Signed into law. *AGC supported.*

**E2SHB 1600.** Establishes the work-integrated learning demonstration pilot project to promote work-integrated learning experiences for students through the completion of demonstration programs at selected high schools. Signed into law. *AGC supported.*

**E2SHB 1622.** Establishes a variety of reforms of the State Building Code Council and provides it with additional resources to improve the economic analysis of proposed code changes. Signed into law. *AGC supported.*

**SSB 6090.** 2017-2019 Capital Budget authorizes \$4 billion in capital projects for state agencies and institutions of higher education. Signed into law. *AGC supported.*

**ESSB 6091.** Addresses State Supreme Court Hirst decision by clarifying water rights thereby allowing development to proceed in affected counties. Signed into law. *AGC supported.*

**E2SHB 1851.** Would have required comprehensive impact assessments and other barriers to government contracting out to private entities for certain services. Passed House, passed Senate Ways and Means Committee. Did not reach Senate floor. *AGC opposed.*

**SB 6203.** Imposes a carbon tax. This version included language that would have used the existence of a community workforce agreement (CWA) as a criteria for expending collected revenue for capital projects. CWAs, also known as Project Labor Agreements (PLAs) discriminate against open shop contractors. *AGC opposed.*

**SB 6062.** Would have required most health carriers and third-party administrators (TPAs) to pay a new tax to fund a new claims-based reinsurance program for individual-market health plans. Passed out of Senate Health and Long-Term Care and Ways and Means Committees. *AGC opposed.*

### Bonus/Negative points for bill sponsorship

**SB 5667.** Original bill would have made it an unfair practice for an employer to take an adverse employment action against an employee or prospective employee because that person participates in an activity that is lawful under state law. This would have hindered drug-testing plans. *AGC opposed original bill.*
