Bill #	Bill Title	Chamber	Description	Our position
1	Licensure for Athletic Trainers (SF614)	Both	A bill that requires individuals who want to engage in the business of athletic training to be licensed by the state; it also creates further regulations on the athletic training industry	Against
2	Financial Exploitation of Elderly (HF3833)	Both	A bill that allows investment advisors to freeze assets of elderly clients if they fear exploitation is occurring; requires citizens to contact the Dept of Commerce to unfreeze their funds	Against
3	Regulation for Sports Agents (HF2363)	Both	A bill that expands regulations for sports agents; creates larger barriers-to-entry	Against
4	Debt Spending Bill (HF4404)	Both	A bill that adds \$825 Million of debt on the state credit card; this bill is full of pork	Against
5	Pipeline Construction Authorization (HF3759)	Both	A bill that allows the construction of the Enbridge pipeline in Minnesota; this bill would allow private development in the state that would create jobs and improve an existing pipeline that moves crude oil from Canada to Wisconsin	For
6	Omnibus Supplemental Budget Bill (SF3656)	Both	A bill that increases spending above and beyond the two-year budget that was passed last year; this bill is also unconstitutional based on Article 4, Section 17's single subject rule (Note: House amended bill to add its own spending priorities)	Against
7	Brewing & Winemaking on Premises (HF3972)	Both	A bill that allows customers to legally brew or make wine at a "brew on premise" store; the bill also expands Sunday sales hours	For
8	Final Omnibus Spending Bill (SF3656)	Both	A bill that emerged from the joint House & Senate conference committee that combines multiple subjects and increases spending above and beyond the two-year budget that was passed last year; this bill is unconstitutional based on Article 4, Section 17's single subject rule; the bill was 998 pages and brought to the Senate floor an hour after being made available to the public	Against
9	Final Omnibus Debt Bill (HF4425)	Both	A bill that spends a total of \$1.5 Billion; \$825 Million in the bill is general obligation debt full of wasteful pork projects	Against
10	Approval for Water Pollution Fees (HF2940)	Both	A bill that takes away the authority of a government agency, MPCA, to determine fees on citizens by requiring legislative approval; fees and taxes should always be determined by elected officials, not government bureaucrats	For
11-h	Fantasy Sports Regulation (HF1415)	House	A bill that expands regulations on operators of fantasy sports leagues	Against
12-h	Omnibus Ed Finance Bill (HF4328)	House	A bill that increases spending on public education in Minnesota despite being fully funded under the previous year's biennium budget. Although we support provisions that strengthen school safety, funding for it should be appropriated from other spending areas passed into law last year instead of taken from the budget surplus.	Against
13-h	House's Tax Conformity (HF4385)	House	A bill that conforms Minnesota's tax laws to the new federal tax cuts and reduces taxes for Minnesotans; we would have liked to see this bill go further, but our organization will positively score a bill when it keeps resources in the hands of individuals and businesses instead of in the government coffers	For
14-h	Health & Transportation Omnibus Bill (HF3138)	House	A bill that increases spending in the health and human services department and the transportation department; this bill grows government by over \$100 Million despite the state already operating under a 2-year budget; the bill is also unconstitutional based on the single subject rule (Article 4, Section 17)	Against
11-s	Regulating Sales of Firearms for Private Parties (Latz Amdt to SF3656)	Senate	An amendment to a bill that would create burdensome regulations on private individuals who choose to sell or transfer firearms to other individuals; the Senate President ruled the Latz Amendment "not germane" and a vote occurred that challenged the ruling	Uphold
12-s	Senate's Tax Conformity (SF4385)	Senate	A bill that conforms Minnesota's tax laws to the new federal tax cuts and reduces taxes for Minnesotans; this bill would provide tax relief of \$168 Million (about half of the surplus funds)	For
13-s	Gov't Mandated Sex Trafficking Training (SF3367)	Senate	A bill that adds regulations on the hotel industry, requiring training on sex trafficking for all employees; this bill also fails the Constitution's "single subject" rule as it also covers an autism reporting program and requirements for documenting immunizations	Against
14-s	Opiate Stewardship Program (SF730)	Senate	A bill that establishes a new fee on manufacturers of opiates in Minnesota and creates a new government program; this bill would raise health care prices and grow the government bureaucracy; the bill also assumes that politicians can solve a societal problem	Against
