- d) After the transfer of work, DHS may initiate action for creation of the posts for the aforesaid Cell.
- The sovereign and policy functions i.e. creation of posts, recruitment rules, recruitment, promotion, ACP/MACP will be with the H&FW Deptt. Policy decisions with regard to the above posts will be taken with the approval of A&FW Deptt.
