- (7) Altering the name of the administrative unit of "Department of Industry, Technology and Resources" in column one to "Department of Industry and Economic Planning"; and
- (8) Altering the name of the office of "Director-General of Industry, Technology and Resources" in column two to "Director-General of Industry and Economic Planning"; and
- (9) Altering the name of the administrative unit of "Department of Management and Budget" in column one to "Department of the Treasury"; and
- (10) Altering the name of the office of "Director-General, Department of Management and Budget" in column two to "Director-General of the Treasury"; and
- (11) Altering the name of the administrative unit of "Ministry for Planning and Environment" in column one to "Department of Planning and Urban Growth"; and
- (12) Altering the name of the office of "Secretary for Planning and Environment" in column two to "Director-General of Planning and Urban Growth"—

ADMINISTRATIVE ARRANGEMENTS  
ORDER (No. 74) 1990

1. This Order is called the Administrative Arrangements Order (No. 74) 1990.
2. This Order is made under the powers conferred by section 3 of the *Administrative Arrangements Act 1983* and under every other available power.
3. This Order takes effect on and after 2 April 1990.
4. In respect of the item in the Schedule a reference to the Old Body in any provision of an Act, specified in Column 2 or in any statutory or other instrument made under any provision of an Act, specified in Column 2 shall be construed as a reference to the New Body.
5. Where—
  - (a) before this Order takes effect a transaction happened in relation to an Old Body,then—
  - (b) this Order does not affect the validity or continuity of the transaction, and the transaction shall continue and may be completed in relation to the New Body in the same way as it would have been completed and may have been completed in relation to the Old Body if this Order had not been made.
6. In this Order—

"The Act" means the *Administrative Arrangements Act 1983*.

"Body" means Minister, Administrative Unit or Officer.

"Instrument" includes contract and agreement.

"Old Body" and "New Body" mean respectively the Body specified in Column 1 and Column 3 of each item in the Schedule.

"Schedule" means the Schedule to this Order.

"Transaction" includes—
  - (a) Agreement, bond, contract, deed or other consensual arrangement whatsoever;

- (b) Action, appeal, arbitration, prosecution or other legal proceeding whatsoever;
- (c) Assignment, charge, lease, mortgage, transfer or other dealing with property whatsoever;
- (d) Loan, guarantee, indemnity or other dealing with money whatsoever;
- (e) Approval, consent, delegation, direction, licence, Order, permit, requirement or other authority whatsoever;
- (f) Notice; and
- (g) Any other Act, entitlement or liability in the law whatsoever.
