Introduction

Hence, the impetus for its professional development series of books. Along with its predecessors, Financial Management in Radiology, Communication & Information Management in Radiology, Human Resource Management in Radiology, and Asset Management in Radiology, Operations Management in Radiology continues the tradition of discussing material in depth to aid the continuing education of the imaging administrator.
