## **IEEM Intellectual Property Law Programme 2024**

### **The 17<sup>th</sup> Intellectual Property Law School**

**28 October to 1 November 2024, Macau Artyzen Grand Lapa Hotel**

The IP Law School is a unique initiative in Asia, offering an intensive programme in international Intellectual Property Law and its relevance for global, European and Asian economic development and innovation policy. The IP Law School is extremely suited for trainee lawyers, Intellectual Property professionals with an economic or policy background, and master's students in Intellectual Property wishing to enhance their skills at post-academic level.

Starting from the roots of IP law in civil law and the international basis of IP in the Paris and Berne conventions, the course covers the development of Intellectual Property Law all the way to the WTO TRIPS Agreement and the challenges posed by technical developments such as the internet and artificial intelligence. Regional agreements, free trade agreements and bilateral investment arrangements covering intellectual property, just as the specific enforcement obligations and mechanisms, will also be covered. The classes are taught using an intensive Socratic and interactive format by experts in the field, and importance is attached to the students' active participation and their articulation of opinions.

This challenging programme also expects participants to jointly prepare and argue several moot cases in a friendly, yet competitive atmosphere, providing a unique insight into the way in which colleagues from various jurisdictions approach international and domestic legal problems.

## The 20<sup>th</sup> IEEM Intellectual Property Seminar

### **Proportionality in Intellectual Property Law**

**Artyzen Grand Lapa Hotel**

**Macau 4 and 5 November 2024**

#### Abstract and Objectives:

Greek philosophy has identified "*μηδὲν ἄγαν*" (*midèn ágan*, nothing in excess) as one of the guiding principles of human society. It was written over the entrance of the oracle of Delphi and has been intensely discussed in the dialogues of Platon. Also law as a framework to balance different individual and societal interests is guided by this principle, now commonly referred to as "proportionality". In particular intellectual property as a construct to foster and protect human achievements for the benefit of society must be mindful of a proper balancing of interests, be it at the stage of legislation or enforcement: Insufficient protection does not lead to a sustainable production of achievements, overprotection to unwarranted monopolies at the expense of commons.

The principle of proportionality is enshrined in e.g. Article 3 of the European Enforcement Directive. The first sentence of paragraph 2 states that "measures, procedures and remedies" to enforce "intellectual property rights" must be "proportionate" in addition to being "effective" and "dissuasive". The second sentence of Article 3(2) teaches that this principle of proportionality requires, in particular, that the measures, procedures and remedies referred to must be "applied in such a way as to avoid the creation of barriers to legitimate trade and to provide safeguards against the abuse of such procedures."

Article 3 teaches that the principle of proportionality seeks to counterbalance the private interest of the IP right holder - who benefits from deterrent and effective law enforcement - and stands for the public interest which benefits from unimpeded legitimate trade and does not benefit from abusive litigation. The principle of proportionality is also found in the TRIPS Agreement of 1995, which implies that it should be respected not only on the basis of EU law, but is also subject to interpretation by the WTO.

The seminar for the first day looks at the roots and justifications of proportionality, and two major instances where this concept must be applied: At the stage of lawmaking, and in the context of enforcement. The third part will look at specific cases of proportionality, namely in the context of an estoppel against enforcement due to conduct that is either inequitable or distorting competition.
