**SUBJECT:** 2025 Regular Session Calendar

**DATE:** September 3, 2024

LRC ratification pending, the attached calendar is approved. The 2025 Regular Session calendar provides that:

- Part I shall convene on Tuesday, January 7;
- Part II convenes on Tuesday, February, 4;
- The President's Day holiday is Monday, February 17;
- The last day for introduction of new Senate bills is Tuesday, February 18;
- The last day for introduction of new House bills is Wednesday, February 19;
- The concurrence days are Thursday and Friday, March 13 and 14;
- The veto recess is March 15 to March 26; and
- The 29<sup>th</sup> and 30<sup>th</sup> legislative days are Thursday and Friday, March 27 and 28.

The session calendar may be amended during the session upon agreement of Senate and House leadership.
