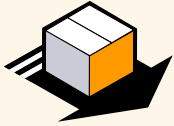

## Calculating your FBA fees

Simply add together your fulfilment and storage fees and any optional services you require to calculate your total FBA Fee. Calculate your fulfilment fee by identifying the destination country, ship speed, and size band of your units shipped.



### 1. Fulfilment Fee

A flat fee per unit, based on both dimensions and unit weight (unit weight or dimensional weight).

Envelopes and special oversize products will be charged as per the actual unit weight of the product whereas small and standard parcels, small oversize, standard oversize and large oversize products will be charged as per the greater of the unit weight or the dimensional weight. The dimensional weight in kilograms is calculated as (length x width x height cm<sup>3</sup>) divided by 5000.

### 2. Storage Fee

Charged per cubic metre per month or cubic foot per month.

**Monthly storage fees** - Storage fees are charged for all items stored in an Amazon fulfilment centre based on fulfilment centre location, calendar month, and your daily average volume of inventory.

**Aged Inventory Surcharge** - Applies to inventory stored for: More than 271 days.

**Storage utilisation surcharge** - Applies for professional sellers with a storage utilisation ratio above 26 weeks and for products outside of clothing, eyewear, shoes and bags. The ratio is calculated as the average daily inventory volume stored divided by the average daily shipped volume over the past 13 weeks.

### 3. Optional Services Fee

Includes local returns, crossborder returns (see zone 1 and zone 2 definitions), disposal, labelling, bagging, bubble wrap, taping, and opaque bagging. Services are charged per unit.

### 4. Referral Fee

Amazon charges a referral fee for each item sold. The amount depends on the product category. Most referral fees are between 8% and 15%.

We calculate the Referral fees based on the Offer Price that you provide.

# Standard Fulfilment by Amazon Domestic FBA, MCI, Pan-European

Effective July 29th 2024

Fulfilment fees are applied based on the store where the item is sold. For the Pan-European FBA programme, we currently apply a per-unit surcharge to all oversize items fulfilled in France, Italy and Spain. Starting September 1, 2024, we'll no longer apply this surcharge to oversize products where the country of inbound is the same as the country of sale. The Pan-EU fulfilment fee surcharge for oversize products will apply to our stores in Germany, France, Italy and Spain. Applicable for products above £10 (UK), €11 (DE), €12 (FR/IT/ES/NL), SEK 140 (SE), and PLN 55 (PL). Additional oversize surcharges apply. See [page 7](#). For more information, [see here](#).

## Standard Fulfilment by Amazon Pan-EU oversize surcharge

Effective 1st September 2024

Fees for oversize products is based on the greater of the unit or dimensional weight. We will calculate the historical inbound minus sales quantity metric at the seller-FNSKU and the Pan-EU store level, as the difference in the historical inbound receive quantity and the historical sales quantity for a given seller-FNSKU. The surcharge will only apply if both the short-term (last 30 days) and long-term (last 150 days) historical inbound sales quantity is less than zero in the country of sale. Effective 1st September, 2024, we will update the eligibility for the Pan-European FBA (Pan-EU) surcharge for oversize products. The surcharge will no longer apply to your Pan-EU sales in the France, Italy, and Spain stores if you inbound inventory in that store. For more information [see here](#).

## Standard Fulfilment by Amazon Pan-EU Low-Inventory Cost Coverage Fee

Effective 1st of April 2024

A low-inventory cost coverage fee (Pan-EU) will apply to standard-size products fulfilled through the Pan-European FBA (Pan-EU) programme when inventory units are less than 28 days relative to shipped units across Germany, France, Italy and Spain. This will only apply if a product's historical inventory levels relative to historical demand (known as historical days of supply) is below 28 days. ## Calculating your MCF fees

Simply add together your fulfilment and storage fees and any optional services you require to calculate your total MCF Fee. Calculate your fulfilment fee by identifying the destination country, ship speed, and size band of your units shipped.



### 1. Fulfilment Fee

**A flat fee per unit based on dimension and unit weight.**

Product size bands are determined per the dimensions and the actual unit weight. Fee is charged based on the size band the product falls in and units per order being shipped.

### 2. Storage Fee

**Charged per cubic metre per month or cubic foot per month.**

**Monthly storage fees** - Storage fees are charged for all items stored in an Amazon fulfilment centre based on fulfilment center location, calendar month, and your daily average volume of inventory.

**Aged Inventory Surcharge** - Applies to inventory stored for: More than 271 days

# Frequently Asked Questions

## FAQs

### Fulfilment by Amazon Fees

**Q1: If I am selling on Amazon, do I pay other fees in addition to the fulfilment fees, storage fees, and optional service fees?**

Yes, you pay a subscription fee or per-item fee depending on your current selling plan. You also pay a referral fee per category and closing fee per media item sold. A returns processing fee is charged on customer-returned products sold on Amazon (see FAQ 4). To see which fees and selling plan apply to you, please visit [Selling on Amazon Fee Schedule](#) and [Seller Pricing and Plans](#).

**Q2: How are Storage Fees calculated?**

Storage Fees are charged for all units stored in an Amazon fulfilment centre based on calendar month and your daily average volume per cubic metre (or cubic feet for UK). The cubic metre of any unit will be based on the unit's size as properly packaged and ready for shipment to customers in accordance with [FBA programme policies](#). Amazon will be entitled to make its own measurement of the cubic metre or weight of any packaged unit or representative sample thereof and in the event of any conflict between such measurement and information provided by the seller, Amazon's measurement will govern.

**Q3: How do you calculate Pan-EU oversize surcharge?**

We will use a metric called the historical inbound minus sales quantity. The metric is calculated at the seller-FNSKU and the Pan-EU store level as the difference between total inbound receive units and total shipped units, over both the long-term (last 150 days) and short-term (last 30 days) periods.

The historical inbound minus sales quantity metric is calculated based on the inbound receive units and shipped units of the Pan-EU stores in Germany, France, Italy and Spain. The Pan-EU surcharge for oversize items will only apply to a product when both its long-term and short-term historical days of supply are below zero (<0).

**Q4: What is the returns processing fee?**

Starting on January 1, 2025, we'll introduce a returns processing fee for high-return-rate products in all categories, excluding clothing, eyewear, shoes and handbags, to address the operational costs of returns and to reduce waste. The fee will only apply to products that have return rates above a threshold specific to each category. The first charge will be between the 7th and 15th of April 2025.

Your product's return rate will be the percent of your product's shipped units in a given month that are returned by customers over that month and the subsequent two calendar months. For a given month's shipped units, the returns processing fee will be charged for each returned unit above the product category's return rate threshold.

The Returns Processing Fee is equal to 50% of the total fulfilment fee for a given product in the clothing, eyewear, shoes and handbags categories. These fees apply to units fulfilled from local inventory as well as across Europe through the European Fulfilment Network (EFN) program. **Q5: Are media and non-media items that are Sold On Amazon charged different Fulfilment Fees?**

Media and non-media items that are Sold On Amazon are charged the same Fulfilment Fees.

**Q6: What is the low inventory cost coverage fee?**

A low-inventory cost coverage fee (Pan-EU) will apply to standard-size products fulfilled through the Pan-European FBA (Pan-EU) programme when inventory units are less than 28 days relative to shipped units across Germany, France, Italy and Spain. When sellers carry low inventory relative to shipped units, we're unable to distribute products across our network optimally, which reduces delivery speed and drives higher shipping costs. The low-inventory cost coverage fee (Pan-EU) will only apply if a product's historical inventory levels relative to historical demand (known as historical days of supply) is below 28 days. We will only charge the low-inventory cost coverage fee (Pan-EU) when both the long-term historical days of supply (last 90 days) and short-term historical days of supply (last 30 days) are below 28 days (4 weeks), otherwise sellers will not incur the fee.

**Q7: What is the Ships in Product Packaging discount?**

Ships in Product Packaging (formerly known as Ships in Own Container) is a programme in which products are shipped to the customer in their original packaging, without any additional packaging from Amazon.

Products that are certified for this programme will automatically receive lowered Fulfilment by Amazon fulfilment fees on each certified unit shipped. Products may be certified by Amazon if their packaging meets the guidelines for the programme, or they may be enrolled in the programme when packaging is adapted to meet these guidelines.

**Q8: What is the aged inventory surcharge?**

Inventory that is overstocked or stored indefinitely in our fulfilment centres limits our ability to provide space for fast-selling products that customers want. The aged inventory surcharge helps us ensure that we can continue to provide high levels of service to all sellers and provide customers with products that they want. Inventory items that have been stored in our fulfilment centres for extended periods will incur a monthly aged inventory surcharge depending on the period and marketplace.

### Fulfilment by Amazon Policies

**Q9: Am I restricted on the types of products I can fulfil through FBA?**

**Q10: How do customer returns work?**

Amazon processes your customer returns using [Amazon's customer returns policies](#). Reimbursement credits and referral fee credits are issued to you for all or part of the value of a refund. FBA fees, restocking fees, and returns processing fees may be charged depending on the item. ### Q11: What happens if my items are damaged or lost when being handled by FBA?

### Q12: Do my customers receive Amazon's customer service?

For items sold on Amazon, Amazon will handle fulfilment and customer service for their orders. This customer service includes managing customer enquiries, refunds and returns for FBA items bought on the Amazon website. ### Q13: What are Amazon's policies and requirements for preparing and shipping inventory to fulfilment centres?

## Additional Services and Programs

### Q14: What is the Central Europe Program (CEP)?

Amazon has extended its German Fulfilment network with several Fulfilment centres in Poland and Czech Republic in order to fulfil growing demand and increase efficiencies. Sellers with German inventory can opt to either store their inventory in Amazon's fulfilment network including Poland and Czech Republic or continue to store their inventory exclusively in Germany. Sellers storing their inventory exclusively in Germany are charged an additional £0.26/€0.26/€0.27 (for FR inclusive of DST)/2.50 kr/1.15 zł of Fulfilment Fee per FBA unit shipped from German fulfilment centres. Pan EU Sellers who do not participate in CEP are also charged this additional fee. Some product categories may not be eligible for the CEP. Amazon charges no extra costs for participation in the CEP. Remember: it is the responsibility of the seller to know that storing inventory in Poland and Czech Republic will trigger VAT obligations and other reporting requirements. ### Q15: What are the cross-border fulfilment options?

Fulfilment by Amazon offers three cross-border fulfilment solutions: Pan-European FBA, European Fulfilment Network (EFN), and Multi-Country Inventory (MCI).

### Q16: What is Pan-European FBA?

With Pan-European FBA, Selling Partners choose where to store their products for Amazon to distribute them according to expected customer demand, at no additional cost. In the countries enabled for placement, Selling Partners will benefit from local FBA fulfilment fees and faster delivery promise<sup>1</sup>. By storing goods in additional countries other than the home store, additional VAT reporting requirements may arise. Amazon supports Selling partners by providing resources and solutions that can help with VAT compliance. VAT Services on Amazon is a solution to manage your European VAT registration and filing obligations through Seller Central.

### Q17: What is European Fulfilment Network (EFN)?

With European Fulfilment Network (EFN), you can reach customers in all 7 EU marketplaces with local product listings. Sellers send their inventory to one local fulfilment centre and deliver to other EU marketplaces with cross-border fees and deliver domestically with local fulfilment fees. For example, an Italian customer shopping on Amazon.it can see products sold by a DE seller with a product listing translated in Italian, and buy it for delivery to Italy. The DE seller would pay cross-border fees if the inventory is in a DE fulfilment centre. Note: Due to Brexit, as of January 1st 2021, Amazon is unable to fulfill FBA orders across the border between the UK and EU. To sell with FBA in both the UK and EU, you will need to send inventory to fulfilment centres in the UK and EU. Click [here](#) to learn more.

### Q18: What is Multi-Country Inventory (MCI)?

Multi-Country Inventory (MCI) allows you to send items directly to international Amazon fulfilment centres for storage in the other marketplaces that is not your local marketplace. Local FBA fees apply for sales in marketplaces where you store inventory and cross-border fees apply for sales in marketplaces where you do not store inventory; however, you need to manage your inventory and demand forecasting yourself. Amazon.nl does not participate in MCI.

### Q19: What are the tax implications of international selling?

If you sell goods in any EU country, it's likely you may be required to register for Value Added Tax (VAT) and comply with VAT filing requirements in each country you sell in. Storing goods in any EU country will likely also require you to comply with VAT obligations in that country. Visit [Amazon's VAT Knowledge Centre](#) to find out more. Remember: it's the responsibility of each Amazon seller to ensure they are VAT compliant and you should seek professional advice if you are unsure of your obligations.
