AFRICA

CAR: SG reports on the situation in CAR and MINUSCA

Resolution [2709 \(2023\)](#) of 15 November 2023

Para. 58(a): Requests the Secretary-General to report to the Council on 15 February 2024, 15 June 2024 and 13 October 2024 on the progress in implementing MINUSCA's mandate, as well as on the situation in the CAR, including on all elements set out in paragraph 58 (a) of resolution [2659 \(2022\)](#);

The report of the Secretary-General is expected to be issued in June 2024.

DRC: SG reports on MONUSCO

Resolution [2717 \(2023\)](#) of 19 December 2023

Para. 29: Requests the Secretary-General to report to the Council every three months including:
– updates on progress towards the implementation of the disengagement plan [...]

The report of the Secretary-General is expected to be issued in June 2024.

DRC: SG reports on possible support to regional force

Resolution [2717 \(2023\)](#) of 19 December 2023

Para. 48: Requests the Secretary-General, in consultation with stakeholders, including the AU and regional organizations, to report to the Security Council by 30 June 2024 on possible logistical and operational support the United Nations can provide to regional forces present in DRC at the request of the host country and the organization concerned, in line with the Secretary-General's 2 August 2023 report, including recommendations to ensure, in such case, coherence, coordination, complementarity and efficient articulation of efforts between MONUSCO and these forces;

The report of the Secretary-General is expected to be issued in June 2024.

Libya: UNSMIL: SG to report to SC on the implementation of resolution [2702 \(2023\)](#)

Resolution [2702 \(2023\)](#) of 30 October 2023

Para. 13: Requests the Secretary-General to report to the Security Council on the implementation of this resolution every 60 days;

The Secretary-General is expected to report in June 2024.

Sudan: SG to report on UN efforts to support Sudan

Resolution [2715 \(2023\)](#) of 1 December 2023

Para. 7: Requests the Secretary-General to provide a written report in 90 days, and then brief the Security Council every 120 days on UN efforts to support Sudan on its path towards peace and stability, and to keep this reporting under review;

The Secretary-General is expected to report in June 2024.

UNOWAS: SG reports to SC

PSC letter of 31 January ([S/2020/85](#))

Second para: The members concur with the recommendation contained in your letter to extend the mandate of UNOWAS, as set forth in the annex to this letter, for a further period of three years, from 1 February 2020 to 31 January 2023. The members of the Council request that you report to the Council every six months on the fulfilment by UNOWAS of its mandate.

Resolution 2349 (2017) of 31 March 2017

Para. 34: Requests the Secretary-General to produce a written report within five months on the United Nations' assessment of the situation in the Lake Chad Basin Region as it relates to elements of this resolution, particularly regarding the progress made and remaining challenges, and possible measures for consideration, including with respect to achieving greater coherence of efforts in the context of overlapping regional strategies, and thereafter to include these elements in regular reporting by UNOCA and UNOWAS.

S/PRST/2020/2 of 11 February 2020

Last para.: The Security Council requests the Secretary-General to continue to provide information on UN efforts with respect to aspects highlighted in this statement, the UNOWAS mandate and the situation in West Africa and the Sahel and reiterates its call for an assessment of the implementation of its resolution 2349 to be integrated into regular reporting by UNOWAS.

S/PRST/2021/3 of 3 February 2021

Penultimate para.: [...]The Security Council welcomes the appointment of Abdoulaye Mar Dieye as the UN Special Coordinator for development in the Sahel as an opportunity to boost the implementation of the UNISS and the UNSPS and calls for more detailed and concrete reporting on this implementation through the Secretary-General's regular reporting on UNOWAS.

S/PRST/2021/16 of 17 August 2021

Last para.: The Security Council requests the Secretary-General to continue to provide information on UN efforts with respect to aspects highlighted in this statement and the UNOWAS mandate, including on the negative impact of the activities of non-state actors on the overall security, political and humanitarian situation in the region.

The report of the Secretary-General is expected to be issued in June 2024.

AMERICAS

Colombia: SG to report on Verification Mission

Resolution 2366 (2017) of 10 July 2017

Para. 8: Further requests the Secretary-General, based on the reporting of the Special Representative, to report to the Security Council on the implementation of the Verification Mission's mandate every 90 days after the start of its verification activities;

Resolution 2545 (2020) of 25 September 2020

Para. 1: Decides to extend, to 25 September 2021, the mandate of the Verification Mission and reporting requirements in accordance with its resolutions [2366 \(2017\)](#), [2377 \(2017\)](#), [2435 \(2018\)](#), and [2487 \(2019\)](#), headed by a Special Representative of the Secretary-General of the United Nations;

Resolution 2574 (2021) of 11 May 2021

Para. 3: Welcomes the Secretary-General's proposal to incorporate reporting with respect to the verification of compliance with the sentences referred to in paragraph 1 of this resolution within the existing reporting cycle for the Verification Mission, and to keep the Council fully informed of the preparations of the Verification Mission and the progress, assessment, and eventual results of the verification;

The report of the Secretary-General is expected to be issued in June 2024.

Haiti: SG reports on BINUH on the implementation of resolution [2692 \(2023\)](#)

Resolution [2692 \(2023\)](#) of 14 July 2023

Para. 1: Decides to extend, to 15 July 2024 the mandate of BINUH in accordance with its resolution [2476 \(2019\)](#), headed by a Special Representative of the Secretary General of the United Nations, and the reporting requirements as specified in paragraph 1 of resolution [2645 \(2022\)](#);

Haiti: SG reports on Multinational Security Support Mission

Resolution [2699 \(2023\)](#) of 2 October 2023

Para. 19: Requests the Secretary-General to provide as part of the Secretary-General's regular reporting to the Security Council, no later than nine months following adoption of this resolution, recommendations on possible adaptation of the mandate of the Multinational Security Support mission or its transformation as needed;

The report of the Secretary-General is expected to be issued in June 2024.

Afghanistan: SG reports on UNAMA

Resolution [2727 \(2024\)](#) of 15 March 2024

Para. 5: Requests that the Secretary-General reports to the Council every three months on the situation in Afghanistan and the implementation of UNAMA's mandate, including at the subnational level;

The report of the Secretary-General is expected to be issued in June 2024.

The situation in the Middle East, including the Palestinian question

Resolution [1322 \(2000\)](#) of 7 October 2000

Para. 7: Invites the Secretary-General to continue to follow the situation and to keep the Security Council informed.

The Secretary-General is expected to report in June 2024.

The situation in the Middle East, including the Palestinian Question: SG to report to the Council on the implementation of resolution [2334 \(2016\)](#)

Resolution [2334 \(2016\)](#) of 23 December 2016

Para. 12: Requests the Secretary-General to report to the Council every three months on the implementation of the provisions of the present resolution;

The report of the Secretary-General is expected to be issued in June 2024.

Middle East (Syria): SG report on the implementation of resolution [2268 \(2016\)](#)

Resolution [2268 \(2016\)](#) of 26 February 2016

Para. 10: Requests the Secretary-General to report to the Council on the implementation of this resolution, including by drawing on information provided by the ISSG ceasefire taskforce, and on resolution [2254 \(2015\)](#), within 15 days of the adoption of this resolution and every 30 days thereafter;

The Secretary-General is expected to report in June 2024.

Middle East (Syria): OPCW DG to report to SC (through SG) on implementation of resolution 2118 (2013)

Resolution 2118 (2013) of 27 September 2013

Para. 12: Decides to review on a regular basis the implementation in the Syrian Arab Republic of the decision of the OPCW Executive Council of 27 September 2013 and this resolution, and requests the Director-General of the OPCW to report to the Security Council, through the Secretary-General, who shall include relevant information on United Nations activities related to the implementation of this resolution, within 30 days and every month thereafter, and requests further the Director-General of the OPCW and the Secretary-General to report in a coordinated manner, as needed, to the Security Council, non-compliance with this resolution or the OPCW Executive Council decision of 27 September 2013.

The report of the Secretary-General is expected to be issued in June 2024.

Middle East (UNDOF): SG reports on developments in the situation and measures taken to implement resolution 338 (1973)

Resolution 2718 (2023) of 21 December 2023

Para. 16: Requests the Secretary-General to report every 90 days on developments in the situation and the measures taken to implement resolution 338 (1973).

The report of the Secretary-General is expected to be issued in June 2024.

Middle East (Yemen): SG to report to SC on implementation of resolution 2691 (2023)

Resolution 2691 (2023) of 10 July 2023

Para. 2: Requests the Secretary-General to report to the Security Council on a monthly basis on progress regarding the implementation of this resolution, in accordance with paragraph 8 of resolution 2643 (2022);

Resolution 2643 (2022) of 13 July 2022

Para. 8: Requests the Secretary-General to report to the Security Council on a monthly basis on progress regarding the implementation of this resolution, including, inter alia on any obstructions to the effective operation of UNMHA caused by any party, any violations of the Hodeidah Agreement ceasefire, any attempts to bring any military reinforcements and military objects to and through the city, the ports of Hodeidah, Salif, and Ras Issa, and the governorate, any failures to remove any military manifestations from the city, and on resolution 2451 (2018), including on any non-compliance by any party;

The Secretary-General is expected to report in June 2024.

Middle East (Yemen): SG to report to SC under resolution 2722 (2024)

Resolution 2722 (2024) of 10 January 2024

Para. 10: Requests the Secretary-General provide written monthly reports, through July 1, 2024, to the Security Council on any further Houthi attacks on merchant and commercial vessels in the Red Sea to inform the Council's future consultations;

The report of the Secretary-General is expected to be issued in June 2024.

Middle East (Yemen): SG to present to SC a further review of UNMHA

Resolution 2691 (2023) of 10 July 2023

Para. 3: Further requests the Secretary-General to present to the Council a further review of UNMHA, at least one month before UNMHA's mandate is due to expire;

The report of the Secretary-General is expected to be issued in June 2024.

COUNTER-TERRORISM/NON-PROLIFERATION

Non-proliferation (Iran): SG reports on the implementation of resolution 2231 (2015)

Note by the PSC of 16 January 2016

Para. 7: The Security Council requests that the Secretary-General report to the Security Council every six months on the implementation of resolution 2231 (2015). Prior to the public release of that report, the Security Council shall meet informally, normally at the expert level, to review the findings and recommendations contained in the report.

The report of the Secretary-General is expected to be issued in June 2024.

Non-proliferation (Iran): Facilitator to brief the other members of the SC

Note by the PSC of 16 January 2016

Para. 3: To facilitate its work under resolution 2231 (2015), the Security Council shall select on an annual basis one member to serve as its facilitator for the functions specified in the present note. The facilitator shall brief the other members of the Council on its work and the implementation of the resolution every six months, in parallel with the report submitted by the Secretary-General in accordance with paragraph 7 below.

Facilitator's proposal as agreed on 17 March 2017

The Joint Commission is expected to report in June 2024.

1988 Committee: Sanctions: Emergency Relief Coordinator to brief the Council on the delivery of humanitarian assistance in Afghanistan

Resolution 2615 (2021) of 22 December 2021

Para. 2: Requests the Emergency Relief Coordinator to brief the Security Council every six months from the adoption of this resolution based on the delivery of humanitarian assistance in Afghanistan including on any available information regarding payments of funds to, or for the benefit of, designated individuals or entities, any diversion of funds by the same, risk management and due diligence processes in place, and any obstacles to the provision of such assistance, and further requests relevant providers to assist the Emergency Relief Coordinator in the preparation of such briefings by providing information relevant to paragraph 1 above within 60 days of any such provision;

The Emergency Relief Coordinator is expected to report in June 2024.

OTHER

Maintenance of international peace & security: SG to provide an oral briefing on the implementation of Resolution 2686 (2023) [Tolerance and international peace and security]

Resolution 2686 (2023) of 14 June 2023

Para. 16: Requests the Secretary-General to provide an oral briefing to the Security Council by 14 June 2024, in a public meeting under the agenda item 'Maintenance of international peace and security', on the implementation of this resolution in the context of situations throughout the peace continuum which are on the agenda of the Council, utilizing information from available United Nations sources, including country teams, peacekeeping operations, and other United Nations personnel, and further requests the Secretary-General to swiftly inform the Council about threats to international peace and security in this regard, and expresses its intention to give its full attention to such information provided by the Secretary-General when those situations are brought to its attention.

The Secretary-General is expected to report in June 2024.

Residual mechanism: Progress reports

Resolution [1966 \(2010\)](#) of 22 December 2010

Para. 16: Requests the President of the Mechanism to submit an annual report to the Security Council and to the General Assembly, and the President and the Prosecutor of the Mechanism to submit six-monthly reports to the Security Council on the progress of the work of the Mechanism;

Resolution [2637 \(2022\)](#) of 22 June 2022

Para. 12: Reiterates its request to the Mechanism to include in its six-monthly reports to the Council information on progress achieved in implementing this resolution, as well as detailed information on the staffing and overall posts of the Mechanism, respective workload and related costs with breakdown by division and detailed projections of the duration of residual functions based on available data;

The progress report is expected to be issued in June 2024.
