Re: Request for a Declaration of Disaster

On June 29, 2012, the Alaska Federation of Natives¹, Legislative/Litigation Committee, met to discuss the crisis developing in western Alaska in the Yukon-Kuskokwim Delta as a result of the closure of the subsistence and commercial Chinook salmon fisheries. Salmon returns to western Alaska have been in decline for more than a decade, creating numerous hardships for the people and communities that depend so heavily on this fishery resource. Poor returns of Chinook salmon to the Yukon and Kuskokwim Rivers have resulted in repeated disaster declarations by the federal and state governments. This year is shaping up to be one of the worst Chinook returns to this region on record. As a result of poor returns of Chinook stocks in the Yukon and Kuskokwim River drainages this year, both the federal and state fisheries managers severely restricted the subsistence fisheries and closed the commercial fisheries.

Entire villages were unable to obtain the salmon they need to satisfy their basic food needs for the winter or to earn cash needed from the small commercial fishery to purchase other subsistence necessities. The severity and magnitude of the loss of Chinook salmon has caused wide-spread panic in the region. The food security of the people of this region is at risk. The situation is compounded by high energy prices and the rising costs of alternative sources of protein. Current resources in the region are not sufficient to deal with this emergency, and for that reason AFN is calling upon the Secretary of Commerce to issue a Declaration of Emergency Fishery Disaster for the Yukon and Kuskokwim 2012 Chinook salmon fisheries.

Pursuant to the enclosed AFN Legislative/Litigation Committee Resolution #12-07, we urge the Department to declare a disaster emergency so that the affected villages can access disaster relief to address their immediate subsistence needs. We also ask that you support increased funding

for research on the life cycle of Chinook salmon in the ocean and the effect changes to the ocean environment are having on Chinook returns.
