A BILL
ENTITLED

AN ACT concerning

Temporary Storage Units in Residential Zones

FOR the purpose of amending the definition of “Temporary Storage Unit;” and generally relating to temporary storage units and general safety provisions.

BY repealing and re-enacting, with amendments

Section 18-2-608
Article 18 – Transportation
Title 2 – Vehicles and Traffic
Subtitle 6 – General Safety Provisions
Baltimore County Code, 2015

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2 COUNTY, MARYLAND, that the Laws of Baltimore County read as follows:

8 § 18-2-608. Temporary Storage Units in Residential Zones.

9 (a) As used in this section, “temporary storage unit” means a portable container for the
10 temporary storage of ANY ITEMS, GOODS OR PROPERTY, WHICH MAY INCLUDE BUT
11 NOT BE LIMITED TO BULK ITEMS, furniture, clothing or other personal or household
12 belongings [as part of the process of household renovation or moving or the relocation of
13 household belongings to an offsite commercial storage location].

14 (b) (1) A person may not park or locate a temporary storage unit on any public road
15 or street within a residential zone in the county for a period of more than 5 days.

16 (2) A person may not park or locate a temporary storage unit on any private
17 property within a residential zone in the county for a period of more than 60 days.

18 (c) (1) A temporary storage unit may not be placed in any right-of-way or easement
19 or within 30 feet of any intersection and may not create a sight obstruction for any vehicular or
20 pedestrian traffic.

21 (2) Advertising is prohibited on a temporary storage unit with the exception of
22 the name and phone number of the vendor of the unit.

23 (3) A temporary storage unit shall have reflectors on the side of the unit that is

1 closest to the roadway in order to alert motorists to its presence.

2 (d) (1) A person who violates this section is subject to a civil penalty of \$100,
3 enforceable in accordance with Article 3, Title 6 of the Code.

4 (2) Each day of violation constitutes a separate offense.

6 SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by
7 the affirmative vote of five members of the County Council, shall take effect 14 days from the
8 date of its enactment.
