## A BILL ENTITLED

#### AN ACT concerning

The 2023-2024 Current Expense Budget Gifts and Grants Special Revenue Fund Access to Justice Diversity Equity and Inclusion

FOR the purpose of amending the 2023-2024 Current Expense Budget, by appropriating to the

Gifts and Grants Special Revenue Fund monies derived from state funds and made

available to the County through the Administrative Office of the Courts.

WHEREAS, the Administrative Office of the Courts has made an award of state funds

available to the Baltimore County Circuit Court, to be used for the Diversity, Equity and

Inclusion Program; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County

Charter and Section 10-6-102 of the Baltimore County Code, 2015, as amended, the County

Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

3	and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County					
4	Code, 2015, as amended, that the Current Expense Budget for the fiscal year ending June 30,					
5	2024, be and is hereby amended by appropriating state funds made available to the Baltimore					
6	County Circuit Court, in the amount herein specified, to the following program:					
7	GR-2108 Access to Justice Diversity Equity and Inclusion Grant \$84,544					
8	SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by					
9	the affirmative vote of five members of the County Council, shall take effect December 31,
