Supplemental Appropriation – Fund Balance to Capital Projects – Renovate State’s Attorneys Offices

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2022, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2023; and
3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2023; and
5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2022, the
6 Budget for Cecil County was adopted for Fiscal Year 2023; and
7 **WHEREAS**, the County Executive is requesting to transfer \$250,000 from the fund balance to
8 the Renovate State’s Attorneys Offices capital project; and
9 **WHEREAS**, additional funds are required to complete the project because construction costs
10 have risen; and
11 **WHEREAS**, Section 506 of the Charter of Cecil County requires that no final budget action may
12 be taken by the County Council until after a public hearing or hearings have been held in open public
13 session; and
14 **WHEREAS**, County Council has caused notice of a public budget hearing to be held on March 7,
15 2023, on the recommended appropriation to be published in a newspaper of general circulation in Cecil
16 County.
17 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
18 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
19 Year 2023 is hereby amended for the supplemental appropriation and by amending the Budget to
20 appropriate expenditure authority within the Renovate State’s Attorneys Offices capital project budget
21 in the amount of \$250,000 from fund balance.
22 **AND BE IT FURTHER RESOLVED** that this Bill shall take effect 60 calendar days from the date
23 that it becomes law.

SUMMARY OF LEGISLATION

SPONSOR: Council President at the request of the County Executive

BILL NO. 2023 –01- Supplemental Appropriation – Fund Balance – State’s Attorney’s Offices – Renovation Completion

SYNOPSIS: A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2023, to provide the State’s Attorney’s Office budget within the General Fund expenditure appropriation authority to authorize \$250,000 to be expended for completion of the State’s Attorney’s Office Renovation.

FISCAL IMPACT SUMMARY: The approval of this bill will have a net fiscal impact on the fund balance of \$250,000.

FISCAL ANALYSIS:

This bill will reduce the general fund balance by \$250,000 and increase the SAO CIP Budget by \$250,000.
