TOWN COUNCIL OF CENTREVILLE RESOLUTION 09-2024

A RESOLUTION OF THE TOWN COUNCIL OF CENTREVILLE FOR THE PURPOSE OF AMENDING THE TOWN CHARTER TO REVISE THE REPORTING STRUCTURE FOR THE CHIEF OF POLICE

WHEREAS, the Town Council has the authority under Article XI-E, Section 4 of the Maryland Constitution which allows for the adoption of a new charter, the amendment of any charter or local laws, or the repeal of any part of a charter or local laws; and

WHEREAS, the Town Council has the authority under Section 4-301 et. seq. of the Local Government Article of the Annotated Code of Maryland, which describes the process of charter amendment by resolution; and

WHEREAS, the Town Council wishes to amend Section 701 of the Charter of the Town of Centreville to address the reporting structure for the Chief of Police; and

WHEREAS, the Town Council of Centreville concurs with the recommendations of this Resolution;

NOW THEREFORE,

Section 1. BE IT RESOLVED BY THE TOWN COUNCIL OF CENTREVILLE, that Section 701 of the Centreville Town Charter be amended as follows, with deleted language shown in double bold faced brackets [[]] and added language shown in bold and underlined:

Section 701. Authority to Employ Personnel.

The town may employ such officers and employees as it deems necessary to execute the powers and duties provided by this Charter or other state law and to operate the town government. The town may appoint a Chief of Police who shall be responsible for the management and operation of the town police force, and who shall serve for an indefinite period [[under the supervision of the Town Manager]] at the Council's pleasure.

- Section 2. AND BE IT FURTHER RESOLVED that the date of passage of this Resolution is May 2, 2024, and the amendment of the Charter of the Town of Centreville hereby enacted shall become effective upon June 21, 2024 (the fiftieth day after passage), unless a proper petition for referendum hereon shall be filed with the Town Council on or before the fortieth day after passage in the form and in the manner prescribed in Section 4-304(d) of the Local Government Article of the Annotated Code of Maryland.
- Section 3. AND BE IT FURTHER RESOLVED that the Town Manager shall cause a full and exact copy of the Resolution to be continuously posted on the bulletin board of the Town Hall until June 11, 2024, (the fortieth day after passage) and that the Town Manager shall further cause a fair summary of the charter amendment enacted by this Resolution to be published in a newspaper of general circulation in the Town of Centreville at weekly intervals in each of the weeks of May 10, 2024, May 17, 2024, May 24, 2024 and May 31, 2024 and that the Town Clerk shall cause to be affixed to the minutes of this meeting appropriate certificates of publication and posting.

Section 4. AND BE IT FURTHER RESOLVED that the Town Council of Centreville is hereby authorized and enjoined to declare this Resolution to be effective by affixing their signatures hereto in the space provided on the effective date hereof.

Section 5. AND BE IT FURTHER RESOLVED THAT as soon as the Charter Amendment hereby enacted becomes effective (whether as herein provided or by referendum), the Town Manager shall cause to be delivered to the Department of Legislative Reference all the information regarding the Charter Amendment, this Resolution and any referendum held thereon as may be required by Sections 4-109 and 4-308 of the Local Government Article of the Annotated Code of Maryland.
