

RESOLUTION NO. 2024-R-2

**OF THE COMMISSIONERS OF PRESTON CAROLINE COUNTY
AN AMENDMENT TO THE TOWN'S WATER AND SEWER RATES**

WHEREAS the Town of Preston has repayment of loans used to upgrade the sewer plant, as well as increased operating costs, is leading to increased funds needed to operate the sewer system, and

WHEREAS, the Commissioners of Preston anticipate further spending to address an ongoing problem with infill and infiltration of its sewer lines,

NOW, THEREFORE, the Commissioners of Preston adopt the following Amendment to the Town's water and sewer rates:

1. For FY 2025 the water rates will increase by six per cent over the water rates for FY 2024, and the sewer rates will generally increase by six per cent over the sewer rates for FY 2024.

2. The FY 2025 water and sewer rates will be as follows (the figures in this Paragraph control, if there is a difference between this Paragraph and application of the percentages set forth in Paragraph 1):




