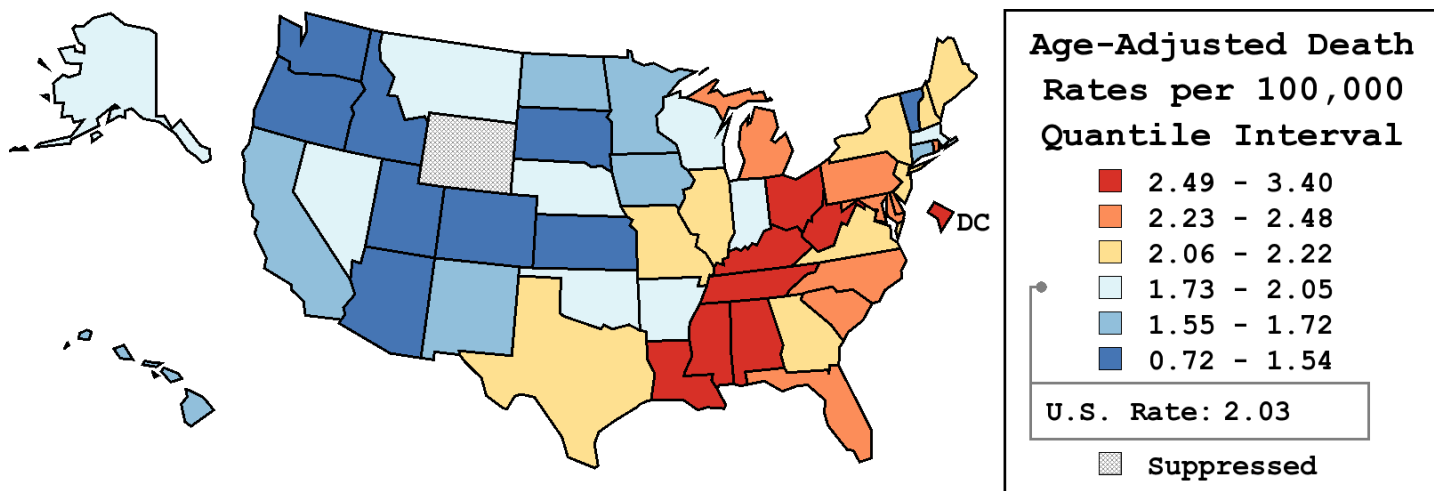

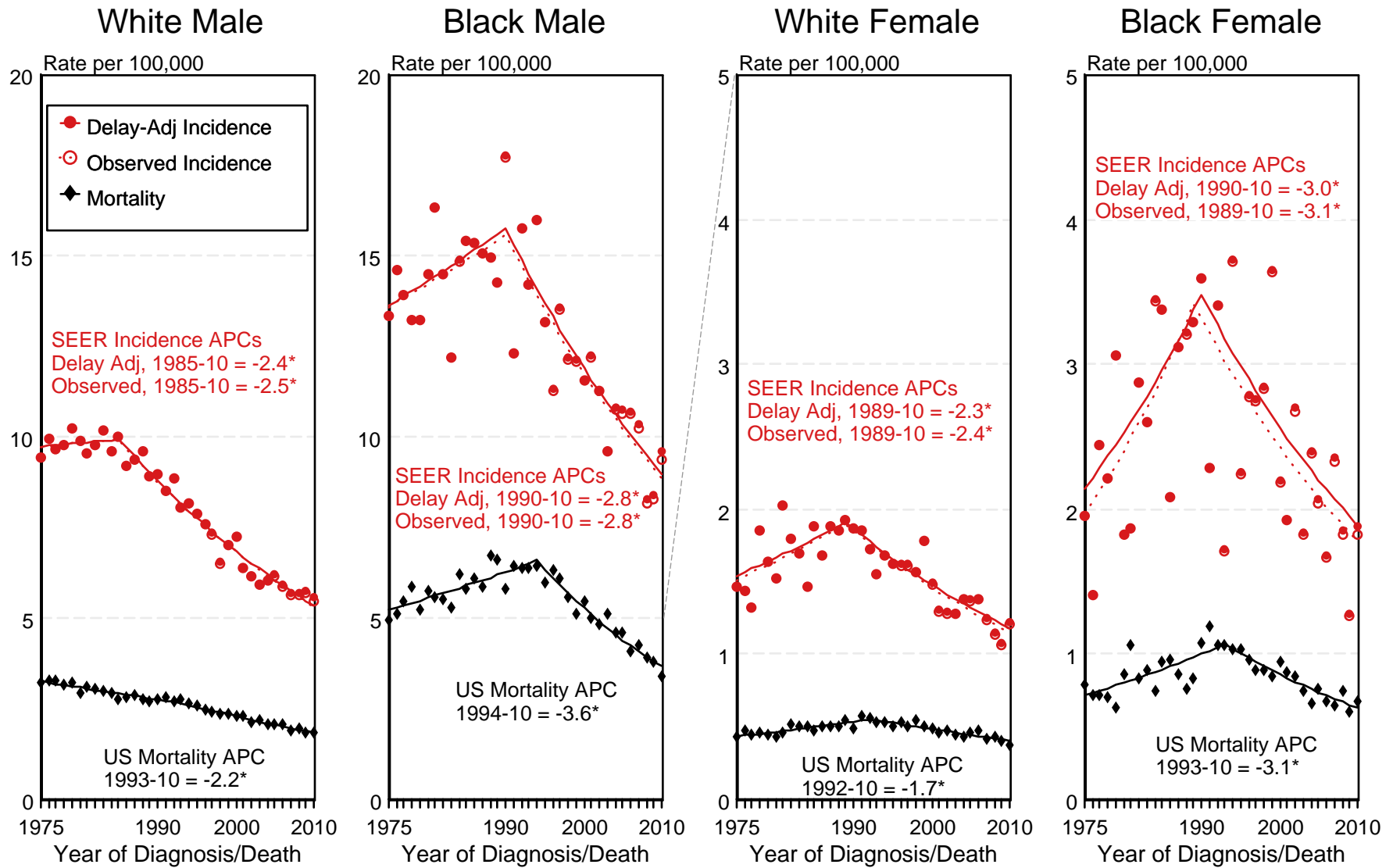

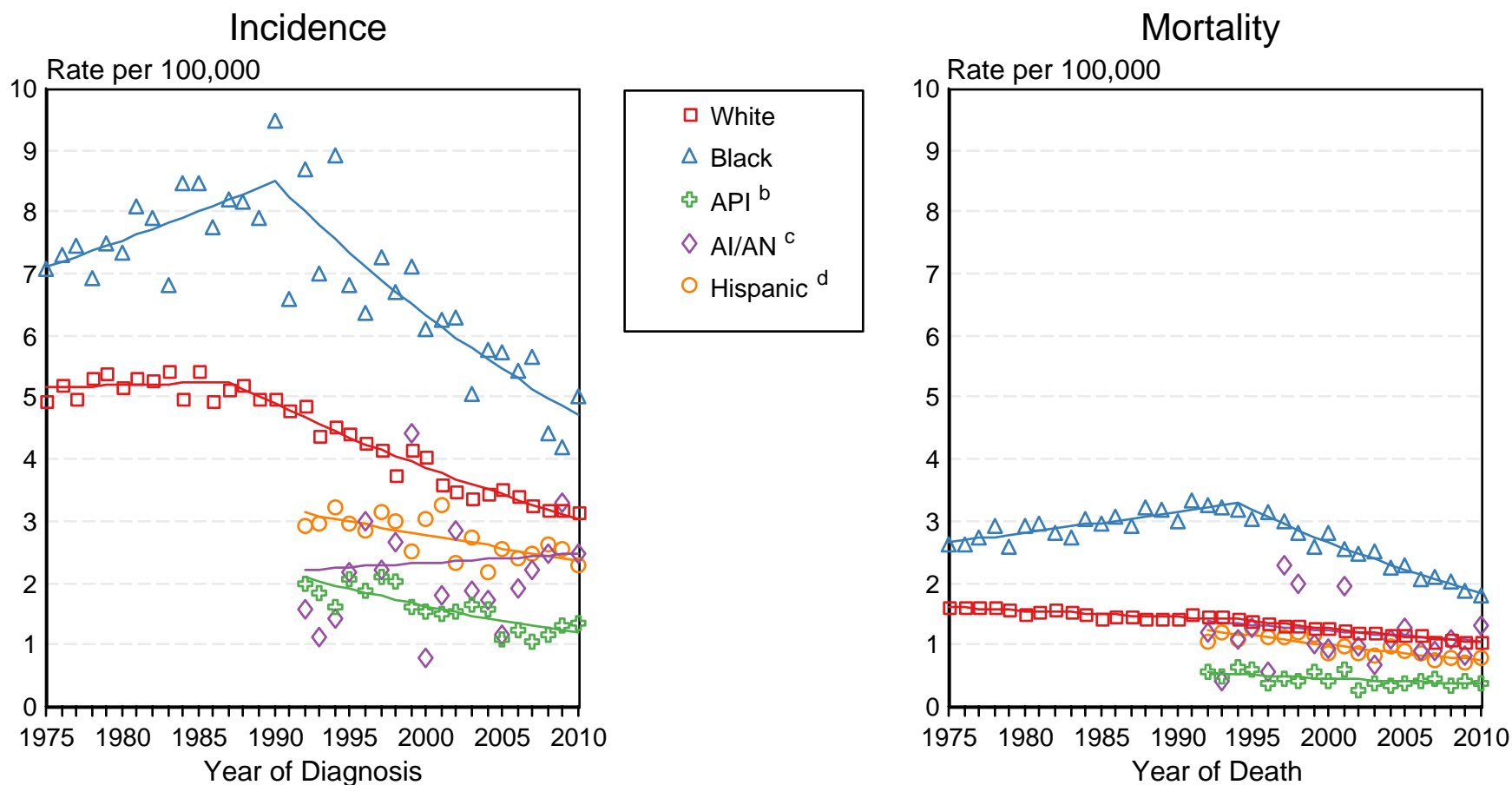

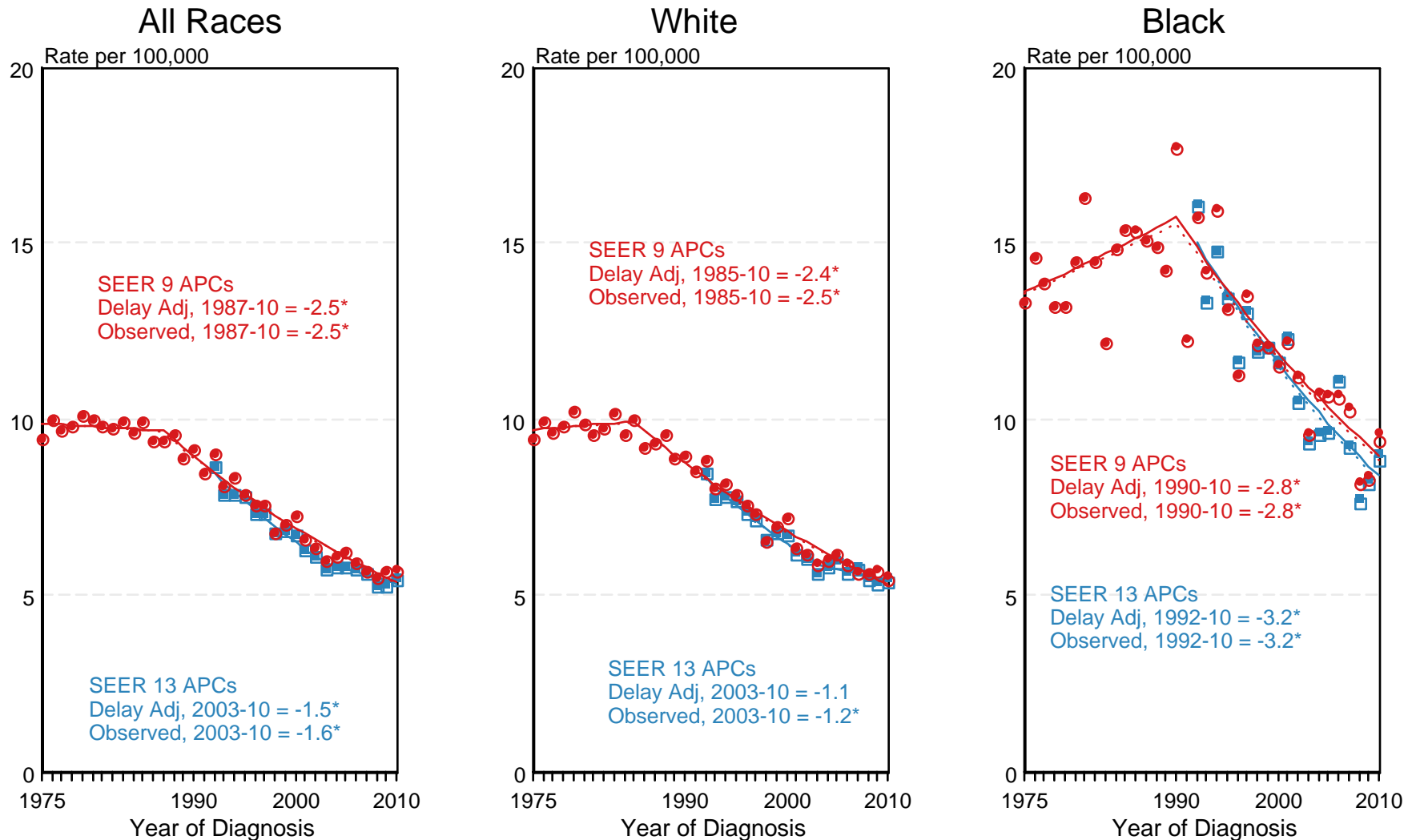

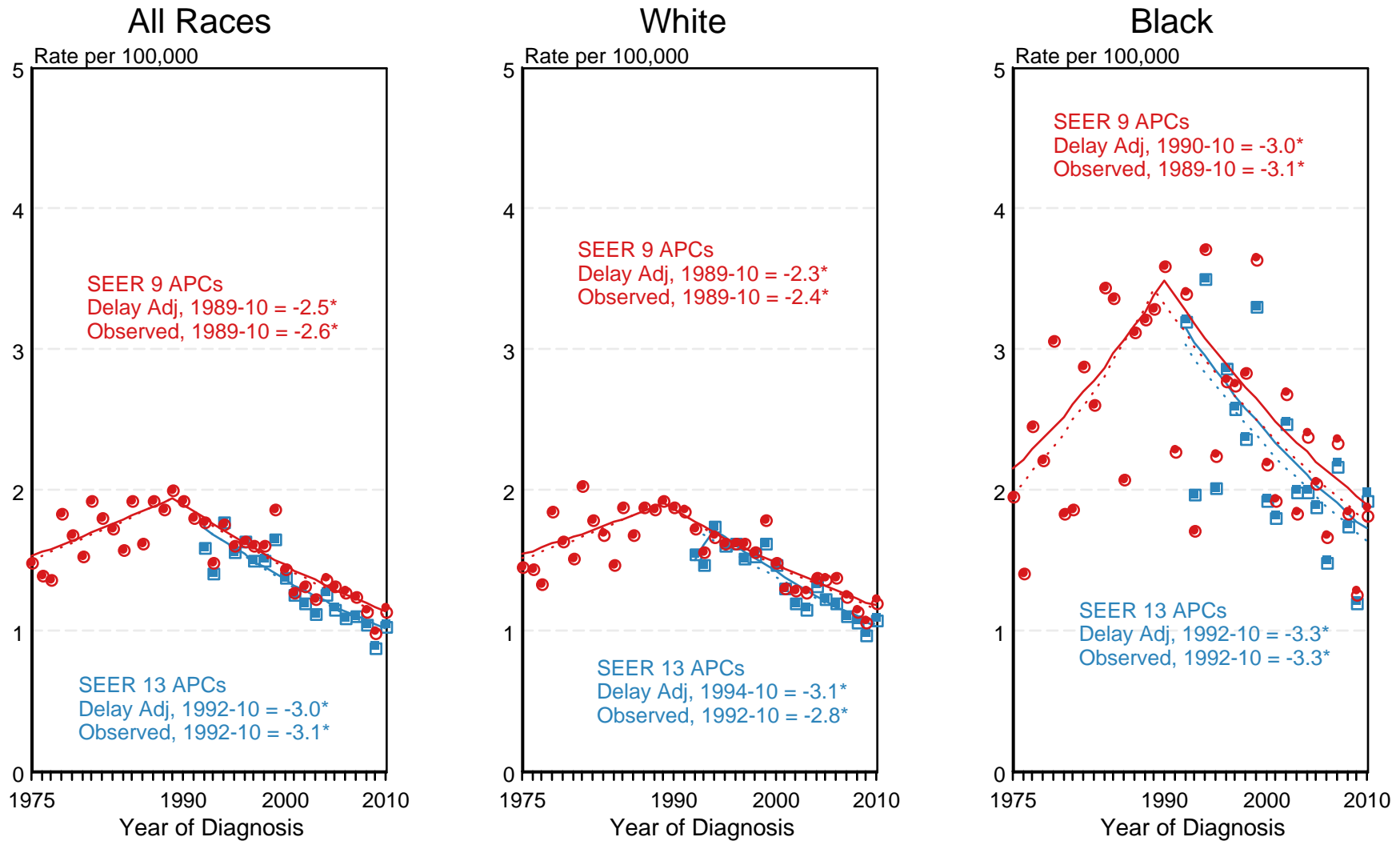
● SEER 9 Delay-Adj. Incidence

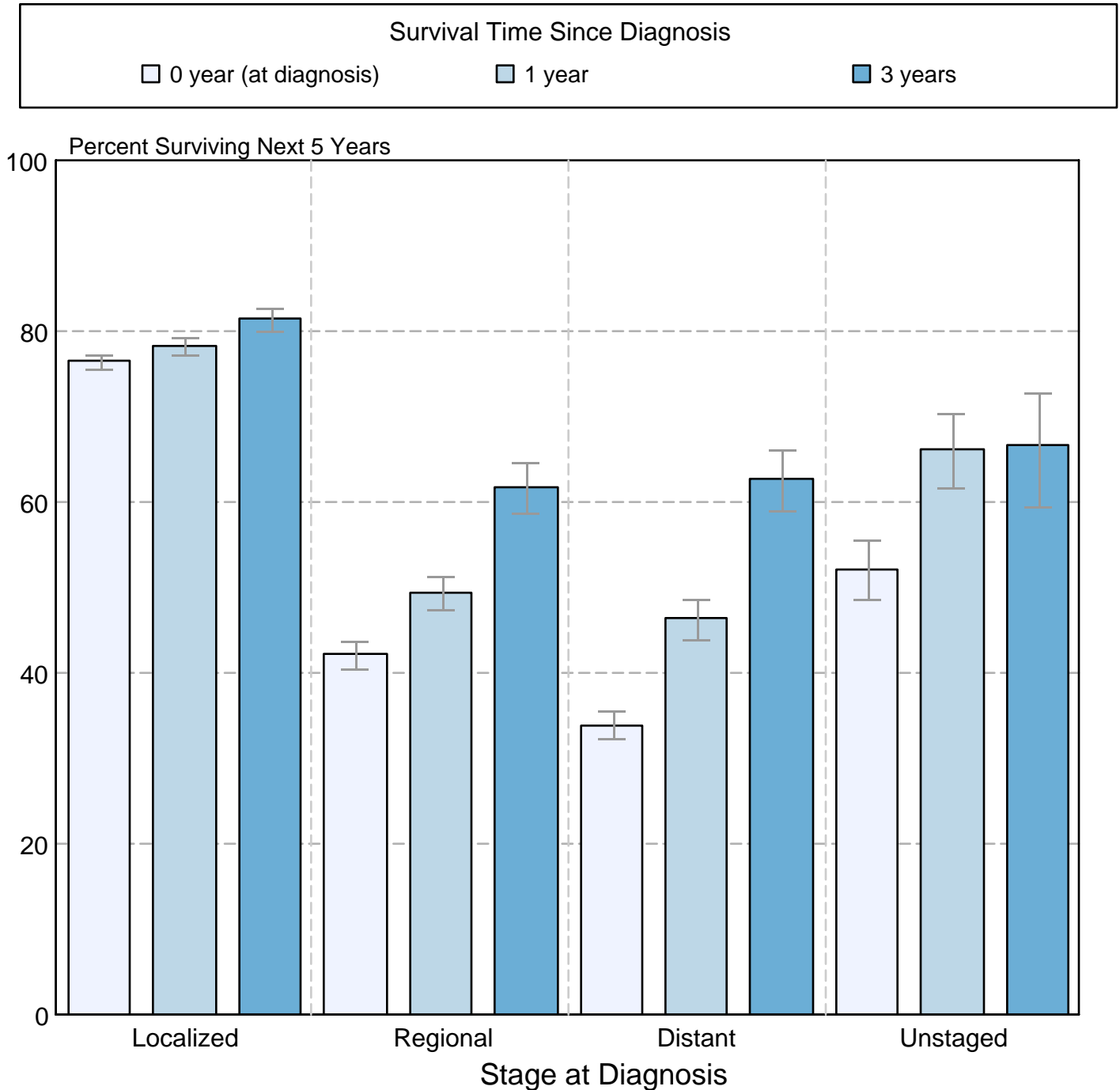
