WHO WE ARE

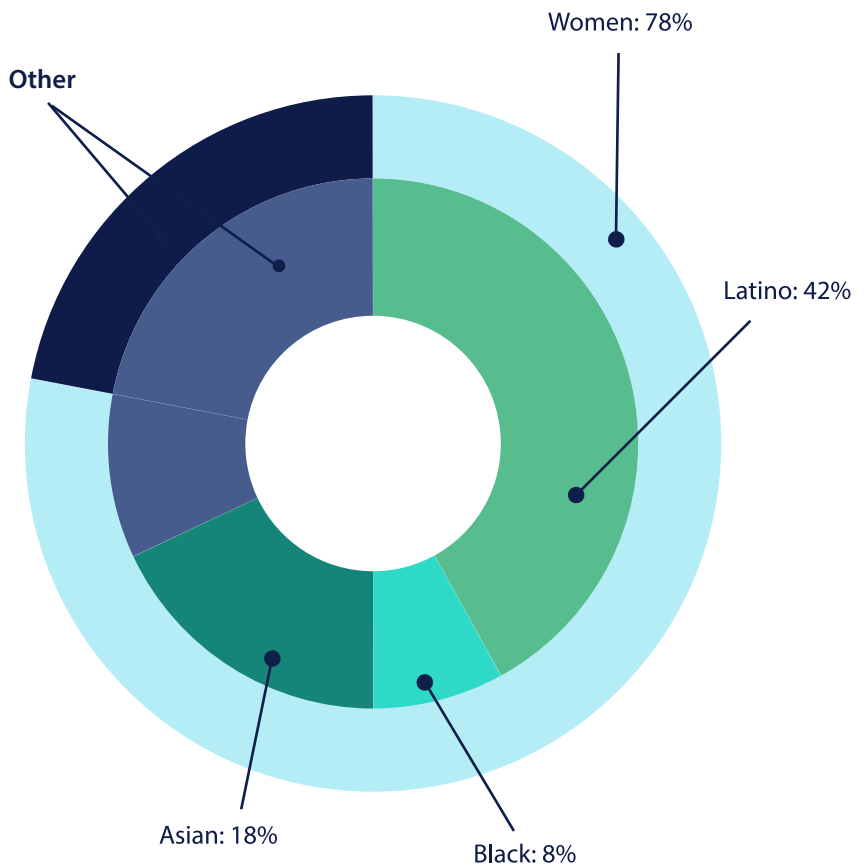
UDW represents over 160,000 home care workers who provide care to low-income seniors and people with disabilities in 21 counties through California's In-Home Supportive Services (IHSS) program. UDW also represents more than 25,000 family child care providers in 39 counties, as part of Child Care Providers United (CCPU).

WHO ARE UDW CAREGIVERS?

78% are women, 42% are Latinx, 8% are Black and 18% are Asian.

Family child care providers are the backbone of our economy—they make all other work possible and give our children the educational foundation for a successful future.



Priority Legislation

Extending State Supplemental Paid Sick Leave for COVID-19

AB 152

The COVID-19 pandemic led to the creation of many new policies such as the Supplemental Paid Sick Leave (SPSL) program. The program currently allows both public and private sector workers up to 80 hours of COVID-19 related sick leave from January 1, 2022, to September 30, 2022. AB 152 extends the end date of this policy to December 31, 2022.

STATUS: SIGNED INTO LAW BY GOVERNOR

Workers Tax Credit

AB 158

In 2017, the Trump Tax Cuts and Jobs Act suspended the tax deduction for union dues at the federal level. While union dues are still deductible as an itemized expense on state tax returns, many workers do not earn enough to itemize deductions and cannot access this benefit. AB 158 creates the framework for the historic Workers Tax Credit, a new refundable tax credit for paid union dues, to provide tax equality and level the playing field for all workers in California.

STATUS: SIGNED INTO LAW BY GOVERNOR

**Securing Healthcare Benefits Funding and Retirement
Benefits Trust for Child Care Providers**

AB 178

AB 178 makes statutory changes not included in the Budget Act of 2022. This bill reflects the historic agreement between Child Care Providers United (CCPU) and the Administration that provides funding for healthcare benefits and the establishment of a retirement benefits trust for family child care providers in our state.

STATUS: SIGNED INTO LAW BY GOVERNOR

Stabilization of Family Child Care

AB 179

AB 179 contains funding for COVID-19 child care stabilization stipends that may be used to support subsidized child care providers with pandemic relief, and, in the case of decreased enrollment or closures to help child care providers remain open or reopen.

STATUS: SIGNED INTO LAW BY GOVERNOR

**Paid Closure Days for Family Child Care Providers During
COVID-19 Pandemic**

AB 185

AB 185 is a budget trailer bill that provides additional pandemic relief to child care providers by way of 16 additional paid non-operational days when a provider must close due to COVID-19 related reasons.

STATUS: SIGNED INTO LAW BY GOVERNOR

Extension of COVID-19 Protections for Family Child Care

AB 210

AB 210 is the early childhood education trailer bill from June 2022, which extends two critical provisions created as a result of COVID-19. This bill extends the family fee waiver for child care services to June 30, 2023, a policy that has proven critical for our state's low-income families who continue to rely on state-subsidized child care. This bill also extends "hold harmless" provisions to June 30, 2023, which reimburses family child care providers for the maximum number of authorized hours of care, regardless of attendance.

STATUS: SIGNED INTO LAW BY GOVERNOR

Legislature Employer-Employee Relations Act

AB 1577

In 1977, the State Employer-Employee Relations Act (or Dills Act) was enacted to govern relationships between state government and executive branch employees. As a result, almost all public employees in California can exercise their collective voice over their compensation, benefits, and working conditions. However, the Dills Act excluded certain public employees, including those employed by the Legislature. AB 1577 would grant collective bargaining rights to employees of the Legislature, providing them with the same ability to join a union that is afforded to every other public employee in the state. This bill was ultimately held up in policy committee prior to passage to the Governor's Desk.

Return to In-Person Orientations for New IHSS Providers

SB 187

Prior to 2020, all new IHSS provider orientations were held in-person, the most engaging and effective way to onboard new caregivers into the IHSS program. During the pandemic, counties were granted the right to conduct these orientations remotely. Since then, the return to in-person provider orientations has been a challenge in many counties. SB 187, the human services trailer bill, requires counties to return to in-person orientations for new IHSS providers, a welcome change that reverts orientations to a more familiar and engaging environment for new providers entering the program.

STATUS: SIGNED INTO LAW BY GOVERNOR

**Improving Interactions between People with Intellectual
and Development Disabilities and Law Enforcement**

SB 882

SB 882, our co-sponsored legislation with the Arc of California and the Association of Regional Center Agencies, establishes the Advisory Council on Improving Interactions between People with Intellectual and Development Disabilities and Mental Health Conditions and Law Enforcement. This council would take a collaborative approach to evaluating existing law enforcement training related to interactions with individuals with intellectual and/or developmental disabilities, as well as individuals with mental health conditions, to identify any existing gaps and develop recommendations to improve these interactions.

STATUS: SIGNED INTO LAW BY GOVERNOR

Protecting Bargaining Rights for Public Sector Workers

SB 931

SB 866 (Budget, 2018) prohibited public employers from deterring union membership amongst their employees. As a result, public sector employee organizations are authorized to bring unfair labor practice charges to the Public Employee Relations Board (PERB) for such behavior. Unfortunately, many public employers continue to distribute anti-union communications to existing bargaining units or workers attempting to collectively bargain. SB 931 imposes a \$1,000 penalty per violation, per employee, not to exceed \$100,000, on public sectors employers if PERB finds they deterred or discouraged workers from exercising collective bargaining rights. This bill is a step forward to protecting an employee's ability to participate in a union without illegal interference by their employer.

STATUS: SIGNED INTO LAW BY GOVERNOR

LEGISLATOR SCORES

Which legislators supported the rights of caregivers, child care workers, children, seniors & people with disabilities?

This scorecard tallies votes by California state legislators on UDW priority legislation. Each Assemblymember or Senator has been scored using votes taken on the Assembly or Senate floor and votes taken in policy or fiscal committees. Abstentions and unexcused absences are scored as votes in opposition to UDW priorities.

The vote tallies produce a percentage that represents how often the member voted in favor of UDW priority legislation. Higher scores mean that the legislator voted more often in favor of UDW priority legislation and lower scores means that the legislator voted in opposition more often.

We list each vote made by an Assemblymember or Senator on UDW priority legislation. Because of different committee memberships, some legislators voted more or less times than others. These votes are the basis for generating a legislator's score. In addition, each legislator's career score is listed next to their 2022 score. Their career score indicates how often they voted in favor of UDW legislative priorities during their tenure in the legislature.

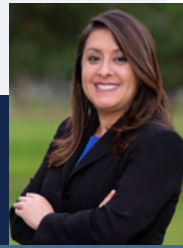
