Localization of the Sustainable Development Goals

The United Nations Habitat Assembly,

Recalling General Assembly resolution 70/1 of 25 September 2015, entitled "Transforming our world: the 2030 Agenda for Sustainable Development", and *reaffirming* our commitment to its full implementation as a plan of action for people, planet, prosperity, peace and partnership, and our pledge that no one will be left behind; [Ad ref 31.05.23 18:32](#)

Deeply concerned about the cumulative effects of multiple and interlinked global crises on the efforts to realize the Sustainable Development Goals, exacerbating poverty, food insecurity, malnutrition and economic and social inequalities, with severe ramifications on social protection, job markets and access to decent work, thus causing a reversal of years of development progress and slowing down future progress, with disproportionate impact on those living in vulnerable situations; [Ad ref 31.05.23 18:32](#)

Noting, in particular, the impacts on cities and human settlements and the risk posed to the achievement of Sustainable Development Goal 11, as highlighted by the [\[UN Secretary-General's Report entitled "Progress towards the Sustainable Development Goals: Towards a Rescue Plan for People and Planet"\]](#) [\[RUS-\]](#), including the rising number of people living in slums, the unequal access to public transport and services, the persistent challenges in municipal solid waste collection, the low proportion of urban areas dedicated to open public and green spaces and the slow progress in setting up financing mechanisms for local implementation of sustainable urban development;

Recalling General Assembly resolution 74/4 of 15 October 2019, *reaffirming* the pledge to make the present decade one of action and delivery and *further reaffirming* our commitment to bolster local action to accelerate implementation of the 2030 Agenda for Sustainable Development, including by empowering and supporting cities, local authorities and communities, as well as recognizing their role in the achievement of the Sustainable Development Goals; [ad ref 31 May 2023 18.49](#)

Guided by the New Urban Agenda and its vision of cities for all, seeking to promote inclusivity and ensure that all inhabitants of present and future generations, without discrimination of any kind, are able to inhabit and produce just, safe, healthy, accessible, affordable, resilient and sustainable cities and human settlements to foster prosperity and quality of life for all, and *emphasizing* its contribution to the implementation and localization of the 2030 Agenda for Sustainable Development in an integrated and coordinated manner; [ad ref 31 May 2023 18.52](#)

Mindful of the central role played by cities and human settlements in the design, implementation, monitoring, evaluation and reporting of national sustainable development strategies, and *welcoming* the elaboration of voluntary subnational and local reviews as an essential tool to show progress and foster exchange on local implementation of the Sustainable Development Goals; [ad ref 31 May 2023 18.53](#)

Underlining the role of the United Nations Human Settlements Programme, as facilitator of the United Nations system-wide strategy for sustainable urban development and focal point on sustainable urbanization and human settlements, in promoting the implementation of the New Urban Agenda and of the urban dimension of the Sustainable Development Goals; [ad ref 31 May 2023 18.54](#)

Recalling Executive Board decision 2021/7 that recommends the Executive Director to actively advance the localization of the Sustainable Development Goals in support of the Decade of Action for the Sustainable Development Goals through normative guidance, technical assistance, strategic partnerships, harmonized data collection based on the proposed United Nations system-wide urban monitoring framework, and implementing the Sustainable Development Goals Cities Flagship Programme; [ad ref 31 May 2023 18.56](#)

Welcoming decision 53/110 of the United Nations Statistical Commission, which endorsed the Global Urban Monitoring Framework and its further implementation as part of a harmonized global urban United Nations system-wide strategy, and requested for UN-Habitat to develop technical assistance programmes and instruments to build human settlements statistics capacities in Member States, with an emphasis on ascertaining consistency of data at the national, regional and city levels; [ad ref 31 May 2023 18.57](#)

Also welcoming UN-Habitat's comprehensive and integrated approach to the localization of the Sustainable Development Goals, including the roll-out of the Global Urban Monitoring Framework, the normative and operational work to advance the voluntary subnational and local reviews, the flagship initiative "SDG Cities", the normative and knowledge work on multilevel governance, the engagement with local and regional authorities or governments and multi-stakeholder collaboration; [ad ref 31 May 2023 18.59](#)

Welcoming the Local2030 Coalition, co-chaired by UN-Habitat as fixed co-chair and one other participating UN entity, as a United Nations-led platform and network designed to support and accelerate local-level delivery of the 2030 Agenda for Sustainable Development and its 17 Sustainable Development Goals (SDGs), seeking to leverage existing initiatives and alliances to strengthen advocacy for bottom-up action. 1. *[Calls upon]* *[Encourages]* Member States *[and members of the United Nations specialized agencies]* to promote the localization of the Sustainable Development Goals to accelerate action towards the fulfillment of the 2030 Agenda *[taking into account its principles for follow up and review]**[EUN+, CMR-, MYS-]* *[and its implementation principles]**[EUN+]*, by advancing local implementation *[in an integrated manner]**[EUN+, CMR+]*, progress monitoring and reporting, including by enhancing national frameworks for the coherent and multi-sectoral implementation of its goals and targets; *[and by strengthening the inclusion and participation of local communities, particularly of those living in vulnerable situations, in decision-making, planning and reporting processes;]**[RUS Reserve]*

2. *Requests* the Executive Director to promote the localization of the 2030 Agenda by:

a. Continuing advancing efforts in developing normative guidance and practical tools on all the dimensions of the localization of the Sustainable Development Goals, including by complementing and participating on the ongoing international initiatives on the basis of UN-Habitat specific experience and expertise. b. Building capacity as appropriate of local and regional authorities or governments, especially of smaller and intermediary cities, to report on the Sustainable Development Goals through voluntary local and subnational reviews, *including through the establishment of* *[stronger]**[CMR delete]* *[effective]**[CMR+]* *linkages between*

~~them, and complementing the capacity building work developed to support~~{EUN+, USA+, BRA+}~~and to contribute to~~{EUN-} national reporting on the New Urban Agenda, ensuring the dissemination and access to relevant tools as an integral part of their implementation and reporting efforts on the 2030 Agenda;

Developing [tools and] capacity as appropriate to improve national reporting on the urban dimension of the Sustainable Development Goals, including through the establishment of stronger linkages between voluntary national [, subnational] [reviews] and [voluntary] local reviews;]{EUN delete, BRA-, CMR-, ARG-, MYS-, USA-}

d. Strengthening engagement with and support to the work of local and regional authorities or governments and their associations, as well as other relevant stakeholders, through strategic partnerships with key local, national and international institutions; [Ad ref 30 May 2023](#)

e. Supporting, upon request, national governments to strengthen effective local and metropolitan multi-level governance to advance the Sustainable Development Goals through stronger policy coherence, cross-sectoral alignment, and multi-stakeholder engagement and participation; [Ad ref 30 May 2023](#).

Continuing efforts to mainstream the localization of the Sustainable Development Goals across the United Nations system including by working with [among other initiatives,]{DZA+, CMR+} the Local2030 Coalition [as well as other international initiatives]{DZA+, CMR+} [such as the G20 platform on Intermediary Cities and SDG Localization;]{CMR+,RUS+, EUN-, USA-}

3. Welcomes UN-Habitat's ongoing initiatives and capacity-building activities to close data gaps and address reporting challenges on human settlements statistics as an essential tool to improve local implementation, monitoring and reporting on the urban dimension of the Sustainable Development Goals, and *requests* the Executive Director to; [Ad ref 30 May 2023](#)

a. Further encourage and support the [adoption and]{KEN+, EUN-} use of the Global Urban Monitoring Framework, as the United Nations reference framework to monitor urban development, to improve reporting on the New Urban Agenda and the localisation of the 2030 Agenda;

b. Enhance and promote capacity-building activities on human settlements statistics through urban monitoring guidance and tools, such as the application of the degree of urbanisation, the national sample of cities approach, the earth observation toolkit for sustainable cities and human settlements, urban observatories and spatial analysis in collaboration with the United Nations Statistics Division and other relevant United Nations agencies; [Ad ref 30 May 2023](#)

c. Enhance initiatives and build capacity towards improving spatial and socioeconomic data on deprived and vulnerable urban and peri-urban areas, including slums, informal settlements and scale-up the analysis and production of accurate maps of these areas; [Ad Ref 31 May 2023 17.46](#)

4. *Invites* Member States and international financing institutions, multilateral development banks and private sector entities to support localization of the Sustainable Development Goals by increasing amounts of concessional financing and easing access of the financing available to local and regional authorities or governments to undertake projects that advance the implementation of the 2030 Agenda including by encouraging financial instruments and innovative programs to support the development of enabling environments at all levels; [Ad Ref 31 May 2023 18:06](#)
