Dear Fellow Conservative,

The American Conservative Union Foundation is proud to present our ratings of the 2018 meeting of the New Hampshire General Court. Like our *Ratings of Congress*, which date back 47 years, our state ratings are meant to reflect how elected officials view the role of government in an individual's life. We begin with our philosophy i.e., conservatism is the political philosophy that sovereignty resides in the person, and then apply our understanding of government (its essential role is to defend Life, Liberty and Property).

Because our ratings are designed to educate the public about how consistently elected officials adhere to conservatism, we carefully examine the entire docket of legislation introduced in each state every year. We select the most meaningful bills and publish the results after the dust has settled. ACUF state ratings—launched in 2011 with ratings for five states—have become a nationally recognized resource for evaluating over 8,000 elected officials comprising each of America's 99 state legislative chambers.

Each election cycle, citizens choose leaders whose vision for the state most closely matches their own, hoping that candidates' promises will be kept. ACUF's ratings measure whether those promises were fulfilled or forsaken. With nearly a decade of data on state legislators' voting records and average scores for every legislative chamber, citizens in every state can assess how effectively their lawmakers have applied conservative philosophy to the role of government.

We at ACUF believe, as Ronald Reagan once said, that freedom is never more than one generation away from extinction. We hope that by providing this unique tool, these ratings will empower Americans to exercise their right to protect our unique American democracy from tyranny.

SELECTING THE VOTES

ACU researched and selected a range of bills before the New Hampshire General Court that determine a member's adherence to conservative principles. We selected bills that focus on Ronald Reagan's philosophy of the "three-legged stool": 1) fiscal and economic: taxes, budgets, regulation, spending, healthcare, and property; 2) social and cultural: 2nd amendment, religion, life, welfare, and education; and 3) government integrity: voting, individual liberty, privacy, and transparency. This wide range of issues are designed to give citizens an accurate assessment that conveys which of New Hampshire's elected leaders best defend the principles of a free society: Life, Liberty and Property.



NEW HAMPSHIRE SENATE VOTE DESCRIPTIONS

- 1. HB 372 Enhancing Voter Integrity. This bill is meant to increase voter integrity by clearly defining a "resident" of the state. ACU supports efforts that protect the electoral process by ensuring only those residing in the state can vote and supported this bill. The Senate passed the bill on January 3, 2018 by a vote of 14-9.
- 2. SB 554 Raising the Minimum Wage and Penalizing Employers that Don't Offer Health Insurance. This bill increases the minimum wage in stages, ultimately hiking it to \$12 per hour by the year 2021. However, employers that do not provide health insurance are required to pay an even higher minimum wage, which will amount to \$15 per hour by 2021. An increase in the minimum wage results in higher unemployment. High rates of unemployment hinder family prosperity as illustrated by the ACU Foundation's Family Prosperity Index. ACU opposes these artificial wages that hurt those who need face barriers to employment, such as students and inexperienced workers, and opposes employer mandates that interfere with the ability of employees to negotiate their own benefits, and opposed this bill. The Senate passed a motion to defeat the bill on February 5, 2018 by a vote of 14-10. (A "Yes" vote supported the ACU position.)
- 3. SB 416 Protecting Ridesharing Drivers from Costly Regulation. This bill is designed to protect ridesharing drivers (such as Uber and Lyft) from costly and burdensome regulations by clarifying that these drivers are independent contractors and not employees of the ridesharing company. ACU supports expanding employment opportunities and protecting the right for employees and employers to negotiate their own benefits and supported this bill. The Senate passed the bill on February 15, 2018 by a vote of 14-10.
- 4. SB 546 Expanding Health Care Options by Easing Restrictions on Purchasing Alliances. This bill provides small businesses and their employees with more health care options by reducing the number of enrollees (from 3,000 to 250) required to form a "purchasing alliance" and be classified by the state as providing large group accident and health insurance coverage. ACU supports reducing regulatory burdens and expanding access to health care and supported this bill. The Senate passed the bill on March 14, 2018 by a vote of 14-10.

- 5. SB 342 Increasing Transparency within Local Operating Budgets. This bill is designed to end deceptive practices in local budgeting by establishing guidelines for the presentation of information. The bill will make it easier for taxpayers to view how a budget increased or decreased compared to the previous year. ACU supports increasing transparency over the expenditure of taxpayer funds and supported this bill. The Senate passed the bill on March 15, 2018 by a vote of 14-10.
- 6. SB 404 Eliminating the Interest and Dividend Tax. This bill completely phases out New Hampshire's 5 percent tax on interest and dividends over four years. Reducing tax burdens increases economic growth, which increases family prosperity, as illustrated by the ACU Foundation's Family Prosperity Index. ACU opposes the anti-growth interest and dividend tax, which is double taxation, and supported this bill. The Senate passed a motion to defeat the bill on March 15, 2018 by a vote of 12-11. (A "No" vote supported the ACU position.)
- 7. SB 420 Increasing Transparency in Collective Bargaining. This bill increases government transparency by requiring collective bargaining negotiations with public employee unions to take place in public meetings under the state's right to know law. ACU believes taxpayers have a right to witness contract negotiations and see how their tax dollars are spent and supported this bill. The Senate passed the bill on March 21, 2018 by a vote of 12-11.
- 8. SB 421 Mandating that Health Insurers Provide 12-Month Supplies of Contraceptives. This bill requires that all health insurance plans offered in the state provide coverage for a 12-month supplies of contraceptive drugs and devices. Additionally, the bill prevents plans from requiring any deductible or copayment to obtain contraceptives. ACU believes the use of contraceptives is a matter of individual liberty and something for which others should not be forced to pay through higher insurance premium and opposes this mandate that is designed to enrich contraceptive providers and opposed this bill. The Senate passed the bill on March 21, 2018 by a vote of 22-1.

9. HB 1685 Reviewing Unnecessary Occupational Licenses and Reducing Barriers for Those with Criminal Convictions. This bill attempts to

expand competition and reduce unnecessary government licensing by establishing an Occupational Regulation Review Commission to examine each of the state's occupational licenses and regulations and determine if they are imposed in the "least restrictive" manner possible. Furthermore, the bill prevents licensing boards from denying licenses to ex-offenders, unless granting the license would jeopardize public safety. ACU Foundation's Center for Criminal Justice Reform is a leading voice on this issue and works to reduce recidivism and barriers to re-entry to society. ACU opposes the proliferation of licensing requirements which are primarily designed to restrict competition and supported this bill as a step in the right direction. The House failed to pass a motion to defeat the bill on March 7, 2018 by a vote of 154-170. The Senate passed a motion to defeat the bill on April 5, 2018 by a vote of 15-8. (A "No" vote supported the ACU position.)

- 10. HB 559 Raising Utility Costs by Eliminating Ratepayer Rebates. This bill results in ratepayers being forced to provide more funding to energy efficiency programs. The bill reneges on a commitment to provide rebates to ratepayers from the Regional Greenhouse Gas Initiative (RGGI) and instead uses that money to subsidize energy efficiency programs. The RGGI fund is made up of fees assessed on power producers for every ton of carbon they emit. ACU opposes the RGGI which burdens ratepayers with higher utility costs and believes it is outrageous to deny them the relief provided through the rebates and opposed this bill. The Senate passed a motion to defeat the bill on April 26, 2018 by a vote of 13-11. (A "Yes" vote supported the ACU position.)
- 11. HB 628 Forcing Employers to Participate in a State-Run Family Leave Program. This bill establishes a state-run paid family and medical leave insurance program and forces employers to participate, unless they offer an equivalent benefit program or their employees opt-out. The program provides six weeks' paid leave at a rate of 60 percent of an employee's salary and is funded by withholding 0.67 percent of an employee's weekly income. ACU believes employers and employees should be free to negotiate their own benefits, opposes this government interference in the private sector, and opposed this bill. The Senate passed a motion to defeat the bill on April 26, 2018 by a vote of 14-10. (A "Yes" vote supported the ACU position.)

- 12. CACR 15 Ensuring Taxpayers Can Challenge Unlawful Spending. This resolution proposes an amendment to the Constitution of New Hampshire which declares all taxpayers eligible to vote in the state have a legal standing to sue the government for any expenditure of public funds that violates a law, ordinance or constitutional provision. ACU supports measures that hold government accountable to the law and protect taxpayer funds from unlawful uses and supported this resolution. The Senate passed the bill on May 2, 2018 by a vote of 22-2.
- 13. HB 1313 Expanding Second Amendment Rights on Snowmobiles and Off-Road Vehicles. This bill permits carrying a loaded firearm on a snowmobile or off-road vehicle. ACU supports the founders' belief in the Second Amendment and supported this bill. The Senate passed a motion to defeat the bill on May 3, 2018 by a vote of 14-10. (A "No" vote supported the ACU position.)
- 14. SB 334 Providing Reciprocity and Temporary Licensure for Certain Health Professions. This bill establishes reciprocity for certain health-related occupational licenses issued in six northeast states and provides applicants from those states with 120-day temporary licenses while the licensing board reviews their applications. ACU supports reforming the state's occupational licensure system to increase competition and expand employment and supported this bill as a step in the right direction. The Senate passed the bill on May 10, 2018 by a vote of 12-10.
- 15. SB 313 Extending Medicaid Expansion for Five Additional Years. This bill extends New Hampshire's expanded Medicaid program under Obamacare for an additional five years. However, the bill does contain some positive reforms including seeking a waiver from the federal government to impose work requirements and an "asset test." Increasing per capita Medicaid spending has a negative impact on the economy and family prosperity, which is illustrated by the ACU Foundation's Family Prosperity Index. ACU opposes the extension of a costly program rife with fraud and waste, and which leads to increased government dependency and intergenerational poverty and opposed this bill. The Senate passed the bill on May 10, 2018 by a vote of 16-6.
- 16. SB 318 Expanding Opportunities for Youth Seeking Work. This bill makes a few positive reforms to the state's labor law, including raising the weekly work cap from 48 hours to 56 hours for workers ages 16 and 17 (the increased hours are only allowed during weeks when school is out at least 4 of 5 schooldays). ACU supports reducing regulatory burdens and providing additional work opportunities to those seeking experience and income and supported this bill. The Senate passed the bill on May 23, 2018 by a vote of 12-11.

17. SB 365 Subsidizing the Biomass Industry at the Expense of Utility

Ratepayers. This bill mandates that utility companies purchase biomass from New Hampshire's six biomass power plants over the next three years. In total, this bill is estimated to cost ratepayers over \$75 million in higher electricity costs. ACU supports all sources of energy, does not believe government should favor one form of energy over another, opposes this government giveaway to the biomass industry at the expense of consumers and opposed this bill. The Senate overrode the governor's veto on September 13, 2018 by a vote of 21-3.

18. SB 446 Increasing Solar Energy Subsidies through the Expansion of

Net Metering. This bill expands the state's "net metering" law by increasing the number of solar-energy producers that are eligible for subsidies, which are funded by higher electricity rates imposed on other ratepayers. Under the bill, solar energy producers who produce fewer than 5 megawatts (previously 1 megawatt) are eligible for above-market rate payments for the excess power they return to the grid. ACU opposes this program that results in one set of ratepayers subsidizing others, opposes government favoring one source of energy over another and opposed this bill. The Senate overrode the governor's veto on September 13, 2018 by a vote of 21-3.



NEW HAMPSHIRE HOUSE VOTE DESCRIPTIONS

- HB 559 Raising Utility Costs by Eliminating Ratepayer Rebates. This bill results in ratepayers being forced to provide more funding to energy efficiency programs. The bill reneges on a commitment to provide rebates to ratepayers from the Regional Greenhouse Gas Initiative (RGGI) and instead uses that money to subsidize energy efficiency programs. The RGGI fund is made up of fees assessed on power producers for every ton of carbon they emit. ACU opposes the RGGI which burdens ratepayers with higher utility costs and believes it is outrageous to deny them the relief provided through the rebates and opposed this bill. The House failed to pass a motion to defeat the bill on January 9, 2018 by a vote of 153-189. (A "Yes" vote supported the ACU position.)
- 2. HB 1749 Protecting Second Amendment Rights by Stopping Unlawful Local Firearm Bans. This bill clarifies that local governments are prohibited from enacting any ordinance regulating firearms or knives and establishes penalties against towns or officials who violate the law. ACU supports the founders' belief in the Second Amendment and supported this bill. The House passed a motion to defeat the bill on February 8, 2018 by a vote of 239-71. (A "No" vote supported the ACU position.)
- 3. HB 1773 Socializing State Elections. This bill establishes taxpayer-funded campaigns and socializes the state electoral system. Under the bill, the amount of private contributions a candidate may receive is reduced, and instead, each registered voter in the state is award four \$25 certificates, known as "civic dollars," which they can donate to a candidate. ACU opposes restricting free speech and burdening taxpayers with an unnecessary expense and opposed this bill. The House passed a motion to defeat the bill on February 8, 2018 by a vote of 214-135. (A "Yes" vote supported the ACU position.)

- 4. SB 33 Limiting Free Speech by Subjecting Nonprofits to Campaign Finance Laws. This bill is another attack by the Left to force donor disclosure, which oftentimes subjects donors to harassment. The bill expands the definition of "political advocacy organization" to include nonprofit groups that do not advocate or oppose a political candidate but spend \$5,000 or more on communications within 60 days of an election. As a result, these groups will now be forced to comply with many of the same regulations as political parties, including expenditure and contribution reporting. ACU supports free political speech and opposes this effort to discourage issue advocacy and opposed this bill. The House passed a motion to defeat the bill on February 15, 2018 by a vote of 162-155. (A "Yes" vote supported the ACU position.)
- 5. HB 1542 Expanding Second Amendment Rights on Public University and College Campuses. This bill permits anyone who is lawfully able to possess a firearm to carry a pistol or revolver on the exterior grounds of public universities and colleges within the state. ACU supports the founders' belief in the Second Amendment and supported this bill. The House passed a motion to defeat the bill on February 22, 2018 by a vote of 231-110. (A "No" vote supported the ACU position.)
- 6. CACR 15 Ensuring Taxpayers Can Challenge Unlawful Spending. This resolution proposes an amendment to the Constitution of New Hampshire which declares all taxpayers eligible to vote in the state have a legal standing to sue the government for any expenditure of public funds that violates a law, ordinance or constitutional provision. ACU supports measures that hold government accountable to the law and protect taxpayer funds from unlawful uses and supported this resolution. The House passed the resolution on March 6, 2018 by a vote of 309-9.

- 7. HB 1685 Reviewing Unnecessary Occupational Licenses and Reducing Barriers for Those with Criminal Convictions. This bill attempts to expand competition and reduce unnecessary government licensing by establishing an Occupational Regulation Review Commission to examine each of the state's occupational licenses and regulations and determine if they are imposed in the "least restrictive" manner possible. Furthermore, the bill prevents licensing boards from denying licenses to ex-offenders, unless granting the license would jeopardize public safety. ACU Foundation's Center for Criminal Justice Reform is a leading voice on this issue and works to reduce recidivism and barriers to re-entry to society. ACU opposes the proliferation of licensing requirements which are primarily designed to restrict competition and supported this bill as a step in the right direction. The House failed to pass a motion to defeat the bill on March 7, 2018 by a vote of 154-170. (A "No" vote supported the ACU position.)
- 8. HB 1201 Mandating Employers Pay their Employees for Unused Vacation Time. This bill forces all employers who offer paid vacation time to provide an additional 90 days for their employees to use their excess hours. If an employee is unable to schedule time off during this time due to the needs of the business, then the employer is required to pay the employee for any unused hours. ACU believes employers and employees should be free to negotiate their own benefits, opposes this infringement on the right to contract and opposed this bill. The House passed the bill on March 15, 2018 by a vote of 192-139
- 9. HB 1680 Banning the Abortion of a Viable Fetus. This bill prevents all abortions after the fetus is viable, except in cases of medical emergency and those in which the life or health of the mother is at risk. ACU believes abortion is a human tragedy, supports restrictions on the practice and supported this bill as a step in the right direction. The House passed a motion to defeat the bill on March 21, 2018 by a vote of 170-163. (A "No" vote supported the ACU position.)
- 10. HB 628 Forcing Employers to Participate in a State-Run Family Leave Program. This bill establishes a state-run paid family and medical leave insurance program and forces employers to participate, unless they offer an equivalent benefit program or their employees opt-out. The program provides six weeks' paid leave at a rate of 60 percent of an employee's salary and is funded by withholding 0.67 percent of an employee's weekly income. ACU believes employers and employees should be free to negotiate their own benefits, opposes this government interference in the private sector, and opposed this bill. The House passed the bill on March 22, 2018 by a vote of 171-162.

- 11. HB 1313 Expanding Second Amendment Rights on Snowmobiles and Off-Road Vehicles. This bill permits carrying a loaded firearm on a snowmobile or off-road vehicle. ACU supports the founders' belief in the Second Amendment and supported this bill. The House passed the bill on March 22, 2018 by a vote of 181-148.
- 12. SB 313 Extending Medicaid Expansion for Five Additional Years. This bill extends New Hampshire's expanded Medicaid program under Obamacare for an additional five years. However, the bill does contain some positive reforms including seeking a waiver from the federal government to impose work requirements and an "asset test." Increasing per capita Medicaid spending has a negative impact on the economy and family prosperity, which is illustrated by the ACU Foundation's Family Prosperity Index. ACU opposes the extension of a costly program rife with fraud and waste, and which leads to increased government dependency and intergenerational poverty and opposed this bill. The House passed the bill on April 5, 2018 by a vote of 222-125.
- 13. SB 316 Exempting Online Auctions from Costly and Burdensome

Licensing. This bill exempts auctions conducted over the internet from the state's burdensome licensing law. To become a licensed auctioneer, one must post a \$25,000 bond, complete 80 hours of education, pass an examination, obtain recommendations and pay \$275 in fees. ACU opposes the proliferation of licensing requirements which are primarily designed to restrict competition and supported this bill as a step in the right direction. The House passed the bill on April 19, 2018 by a vote of 192-137.

14. SB 193 Expanding School Choice by Establishing Education Savings

Accounts. This bill establishes education freedom savings accounts (through 2023) for children ages five through 20 who meet certain standards of need, including those whose households earn less than 300 percent of the federal poverty, or those unable to transfer out of poorly performing schools. The accounts provide funding for eligible children to attend the public or private school of their choice. ACU supports school choice and supported this bill. The House passed a motion to defeat the bill on May 2, 2018 by a vote of 170-159. (A "No" vote supported the ACU position.)

15. SB 421 Mandating that Health Insurers Provide 12-Month Supplies of

Contraceptives. This bill requires that all health insurance plans offered in the state provide coverage for a 12-month supplies of contraceptive drugs and devices. Additionally, the bill prevents plans from requiring any deductible or copayment to obtain contraceptives. ACU believes the use of contraceptives is a matter of individual liberty and something for which others should not be forced to pay through higher insurance premium and opposes this mandate that is designed to enrich contraceptive providers and opposed this bill. The House passed the bill on May 2, 2018 by a vote of 219-111.

- 16. SB 420 Increasing Transparency in Collective Bargaining. This bill increases government transparency by requiring collective bargaining negotiations between the government and public employee unions take place in public meetings under the state's right to know law. ACU believes taxpayers have a right to witness contract negotiations and see how their tax dollars are spent and supported this bill. The House passed a motion to defeat the bill on May 3, 2018 by a vote of 234-95. (A "No" vote supported the ACU position.)
- 17. SB 564 Providing a Special Tax Break to Businesses that Cultivate Human Tissue. This bill provides a special exemption from the state's business enterprise and profits taxes to "active regenerative manufacturing businesses," which manufacture engineered blood, tissues and organs. ACU opposes providing select industries and businesses with special tax favors, which distorts the marketplace and imposes higher tax burdens on individuals and businesses and opposed this bill. The House passed the bill on May 23, 2018 by a vote of 259-79.

18. SB 318 Expanding Opportunities for Youth Seeking Work. This bill makes a few positive reforms to the state's labor law, including raising the weekly work cap from 48 hours to 56 hours for workers ages 16 and 17 (the increased hours are only allowed during weeks when school is out at least 4 of 5 schooldays). ACU supports reducing regulatory burdens and providing additional work opportunities to those seeking experience and income and supported this bill. The House passed the bill on May 23, 2018 by a vote of 182-156.

19. SB 365 Subsidizing the Biomass Industry at the Expense of Utility

Ratepayers. This bill mandates that utility companies purchase biomass from New Hampshire's six biomass power plants over the next three years. In total, this bill is estimated to cost ratepayers over \$75 million in higher electricity costs. ACU supports all sources of energy, does not believe government should favor one form of energy over another, opposes this government giveaway to the biomass industry at the expense of consumers and opposed this bill. The House voted to override the governor's veto on September 13, 2018 by a vote of 226-113.

20. SB 446 Increasing Solar Energy Subsidies through the Expansion of

Net Metering. This bill expands the state's "net metering" law by increasing the number of solar-energy producers that are eligible for subsidies, which are funded by higher electricity rates imposed on other ratepayers. Under the bill, solar energy producers who produce fewer than 5 megawatts (previously 1 megawatt) are eligible for above-market rate payments for the excess power they return to the grid. ACU opposes this program that results in one set of ratepayers subsidizing others, opposes government favoring one source of energy over another and opposed this bill. The House voted to override the governor's veto on September 13, 2018 by a vote of 213-128.
