RTE.ie (www.RTE.ie and/or, as the context admits or requires, any RTE branded platforms, accounts or pages) is part of Raidió Teilifís Éireann ("RTE") Ireland's National Public Service Broadcaster which operates and manages this website. By using this site you agree to be legally bound by these terms and conditions which set out how you may use RTE.ie, as well as our [Privacy Statement](#) and [User Comments: Terms of Use](#). Where you use RTE sign-in, RTE Terms & Conditions of Use and RTE Login Services Privacy Statement shall apply. If you do not agree to be legally bound by all these terms and conditions and the RTE Privacy Statement and User Comments: Terms of Use you should not access and/or use RTE.ie.
