

Anti-Slavery and Human Trafficking Statement - 2019/2020

This statement sets out the steps the University of Reading has undertaken, and is continuing to take to ensure that modern slavery or human trafficking is not taking place within our organisation or supply chain.

The University of Reading is committed to improving our practices to combat slavery and human trafficking.

Organisational structure

The University of Reading is an independent chartered corporation with charitable status. It is based in the United Kingdom. The objects of the University, as set out in its Charter of Incorporation, are for the public benefit to advance education, learning and research through the provision, support and maintenance of a University.

The University of Reading has a number of subsidiary companies, which constitute our Group. Our subsidiary companies are as set out in the University's Ordinances, and they operate in the United Kingdom, Malaysia, South Africa and Germany. The Group has over 4200 employees worldwide.

We have a global annual turnover of £313,452k

Our polices

We are committed to ensuring that there is no modern slavery or human trafficking in our supply chains or in any part of our business.

We have robust recruitment and employment practices in relation to both employees and workers including rigorous checking of immigration and right to work documents and ensuring that anyone undertaking work at the University is engaged correctly and in line with legislative requirements and University procedures.

Our Procurement Policy has been reviewed and continues to reflect our commitment to acting ethically and with integrity in all our business relationships and to implementing and enforcing effective systems and controls to ensure slavery and human trafficking is not taking place anywhere in our supply chains.

The University has a Supplier Code of Conduct that it promotes to all its suppliers. The code of conduct sets out the matching behaviours that we expect of suppliers who are delivering goods, services and works to the University. These behaviours include - social responsibility, environmental compliance, working conditions and diversity and inclusion.

Our supply chains

The University procures works, goods and services in excess of £100 million per year. We work with a number of suppliers based in the UK and globally.

The University has a zero-tolerance approach to modern slavery and human trafficking. It is committed to acting ethically and with integrity in all its business dealings and relationships. It seeks to ensure modern slavery and human trafficking are not taking place anywhere within the organisation or in any of its supply chains.

Due Diligence

As part of our initiative to identify and mitigate risk, we have the following systems in place:

- Strict procurement processes, requiring our suppliers to abide by all the required legislation and regulations that relate to the relevant jurisdiction in which the suppliers operate and/or supply.
- Our tender documents are based on the government standard selection questionnaire.
- Undertake a review of our suppliers including specific questions relating to the Modern Slavery Act on the agenda for contract review meetings.
- We have included appropriate terms in our contractual documentation with our suppliers and that these obligations are flowed down to the subcontractors of suppliers

We have a dedicated compliance team, which consists of involvement from the following departments:

- Legal Services;
- Internal Audit;
- Human Resources;
- Research and Development
- Procurement; and
- Governance.

Training and awareness

To ensure an appropriate level of understanding of the risks of modern slavery and human trafficking in our supply chains and our business, we are identifying suitable training and have provide applicable information to relevant staff.

All staff involved in procurement activity are asked to carry out the training provided by Higher Education Procurement Academy.

The Procurement Board review and approve the Procurement Policy.

2019/2020 Activity

During 2019/2020, we have carried out the following activity:

- Procurement Board reviewed and signed off a new Procurement Policy which was communicated to all staff
- The Supplier code of conduct was issued out to all suppliers and included in the tender documentation
- The University of Reading has committed to the ethical and sustainable sourcing of electronics products on campus by signing up to Electronics Watch.
- Procurement staff carried out training on Protecting Human Rights in the Supply chain
- University announced that it was divesting from fossil fuels, as well as the introduction of the sustainably sourced Fairphone and sustainably sourced stationary products.

2020/2021 Activity

During 2020/2021, the University intends to take the following further steps to combat slavery and human trafficking:

Set up a Responsible Procurement Group including developing the terms of reference and identifying membership of the group

- Work together with Electronics Watch and other organisation to monitor and protect rights of workers in the supply chain
- Review and develop terms and conditions, and supplier questions to help us tackle modern slavery in ICT hardware and electronics
- To review further options in other product and service categories for independent monitoring of our supply chain to ensure we are appropriately informed, have increased transparency and adopt improvement plans;
- Monitor ongoing training requirements and develop further awareness through events for staff and students;
- review options to monitor compliance of the University's supply chain following the assessment of the responses;

• undertake a thorough review of the University's due diligence processes, with a view to strengthening and standardizing them; and
