This notification must be made within 15 calendar days after receiving notification or obtaining knowledge of the arrest. Notification is not required in the case of traffic violations or misdemeanors not involving a minor.

Pursuant to [NRS 391.330](#), The State Board may suspend or revoke the license of any teacher, administrator, or other licensed employee for (1) immoral or unprofessional conduct; (2) evident unfitness for service; (3) physical or mental incapacity which renders the employee unfit for service; (4) conviction of a felony or crime involving moral turpitude; (5) conviction of a sex offense under [NRS 200.366](#), [NRS 200.368](#), [NRS 201.190](#), [NRS 201.220](#), [NRS 201.230](#), [NRS 201.540](#), or [NRS 201.560](#) in which a pupil enrolled in a school of a county school district was the victim; (6) knowingly advocating the overthrow of the Federal Government or the State of Nevada by force, violence or unlawful means; (7) Persistent defiance of or refusal to obey the regulations of the State Board, the Commission or the Superintendent of Public Instruction, defining and governing the duties of teachers, administrators, and other licensed employees; (8) Breaches in the security or confidentiality of the questions and answers of the examinations administered pursuant to [NRS 389.550](#) or [NRS 389.805](#) and the college and career readiness assessment administered pursuant to [NRS 389.807](#); (9) Intentional failure to observe and carry out the requirements of a plan to ensure the security of examinations and assessments adopted pursuant to [NRS 389.616](#) or [NRS 389.620](#); or (10) an intentional violation of [NRS 388.5265](#) or [NRS 388.527](#).
