Update: Keeping Connected with the Legislature

The West Virginia Department of Education (WVDE) collaborates with the West Virginia Legislature throughout the year. Through these interactions, WVDE staff members respond to legislators' requests by providing suggested language, fiscal notes, state- and county-level education data, research-based materials, code citations, comparative information from other states, and federal requirements.

To ensure that the most current information is provided to legislators in a consistent, time-sensitive manner, the WVDE employs a full-time Director of Governmental Relations, Director Drew McClanahan. Mr. McClanahan works closely with the Legislature, WVBE members, WVDE cabinet and staff, West Virginia governmental agencies, United States Department of Education, Council of Chief State School Officers, and Education Commission of the States, among others. In addition, Mr. McClanahan serves as a valuable resource to county superintendents, WVBE members, and others by providing bill tracking information and updated material on legislative actions.

These charts reflect WVDE collaboration with the Legislature, providing examples of the nature, frequency, and extent of these efforts during 2021.
