

Introduction

West Virginia Constitution, Article XII, §2, provides that the general supervision of the free schools of the State shall be vested in the West Virginia Board of Education (WVBE). The WVBE has the responsibility of policy development for West Virginia's educational system, and the West Virginia Department of Education (WVDE) manages the policy process for the WVBE. The Six-Year Policy Review Cycle ensures that policies are updated on a regular basis with input from a variety of stakeholders, placed on public comment, repealed when appropriate, and adopted upon WVBE approval. When new policies are required by legislation, the WVBE and the WVDE develop these policies incorporating state code language. The following information includes the policy update for 2021, policies targeted for 2022, and the year-to-year revision projection of all the current policies through 2026.
