# **Executive Summary**

The March meeting of the State Board of Education will focus on the Strategic Plan Update for *Goal 1: Lead a Thorough, Efficient and Effective Education System and Objective 3. Facilitate access to technology, connectivity and innovative practices.* This presentation will provide evidence of best practices from the Office of Data Management and Infrastructure Systems.

The Office of Data Management and Information Systems Office is organized around the following three service areas:

- 1. West Virginia Education Information System (WVEIS)
- 2. Data Analysis and Research
- 3. Infrastructure and Network Operations

Office staff collaborate across all offices at the West Virginia Department of Education (WVDE), other county/state agencies, local school districts, and the broader educational communities to provide technology and data management services. As a matter of fact, the West Virginia Office of Data Management and Information System has several nationally acclaimed services not necessarily implemented in all states, as indicated in this document. In addition, the WVEIS system is one of the few centralized data management and information systems in the nation. Many states do not provide for a centralized 1) data management system for their counties (Instead, the counties create and pay for their own systems), 2) programs/systems of Career and Technical Education (CTE) inclusion into their state centralized system, 3) online individualized education plan (IEP) for special needs students, and 4) form that requests a listing of all required accommodations for special needs students.

This Strategic Plan Update for *Goal 1: Lead a Thorough, Efficient and Effective Education System and Objective 3. Facilitate access to technology, connectivity and innovative practices will offer evidence on how each of these three service areas leverage best practices, as well as innovative practices, into the areas of technology and connectivity. The WVDE's efforts have yielded some of the most comprehensive and innovative technology solutions for West Virginia's evolving technology within our school system.* 



### Office of Data Management and Information Systems Organizational Structure

The chart below identifies the three service areas within the office. It also briefly defines the responsibilities of each service area. These three service areas work together very closely to assure the student educational data created by WVEIS can be securely stored in WVEIS through the data center infrastructure, which includes secure servers, routers, switches, filters, and firewalls.

### West Virginia Education Information System (WVEIS) Service Area

WVEIS is the WVDE's statewide longitudinal data system (also called an SLDS). The secure WVEIS servers store demographic information and education records for every student enrolled in public education. These education records, data, and other information are entered into WVEIS by the staff at the local school, district, or by WVDE staff. Other data and information may be imported from secure files into WVEIS.

WVEIS houses data for 252,357 students and is used by 38,399 professional and service personnel. The WVEIS staff is also responsible for creating applications to capture additional data elements necessary for state and federal reporting or to assist counties in making data-driven decisions for their students. Chart 2 outlines the technology applications and innovative practices implemented through WVEIS.

# Data Analysis and Research Service Area

The Data Analysis and Research (DAR) team within the WVDE Office of Data Management and Information Systems provides support for education stakeholders through rigorous and objective research, evaluation, and data analysis; data reporting and customized reports in response to requests; training and technical support in the use of data tools such as ZoomWV and ZoomWV-e; and data governance, including the establishment of data standards, data reviews and validation, and ongoing data privacy efforts.

The DAR team supports nearly 6,600 individual school, district, and state staff members who use ZoomWV-e to review and monitor aggregate and student-level data. In addition to supporting the data dashboards in ZoomWV and ZoomWV-e, staff also create custom data reports for policymakers, colleagues, and other stakeholders. In the 2020-2021 school year, staff responded to more than 120 requests from customized reports from various stakeholders. Members of the team also provide detailed research and evaluation reports and data analyses to answer specific questions of interest to leaders, policy makers, and educators.

The team further assists staff and stakeholders throughout the state—including parents and students—in understanding students' privacy rights and the responsibilities individuals and agencies have for ensuring those rights are maintained. Team members actively support WVEIS staff and other WVDE colleagues in ensuring that data are accurate and submitted in a timely manner. The Data Analysis and Research Service Area's technology and innovations are outlined below in Chart 3.

# Infrastructure and Network Operations Service Area

The Infrastructure and Network Operations team handles a variety of tasks, including (a) maintaining data center infrastructure including servers, routers, switches, filters, and firewalls; (b) maintaining statewide network and internet access to K-12 schools across the state; (c) maintaining WVDE phones and computer-related equipment; (d) providing digital forensic analysis; (e) Office 365 management; (f) providing web application development and web server support; and (g) refurbishing office computers for new use in K-12 classrooms (secondlaunchWV). This team also provides professional development specializing in Office 365 tools and onsite desktop support for the WVDE staff.

In support of infrastructure and network operations in schools and districts, staff members in the Office of Data Management and Information Systems provide consultation, guidance, and technical support for counties submitting e-Rate applications and applications for other technology programs (including Emergency Connectivity Fund [ECF] devices). These services ensure that districts have an instate expert to provide no-cost assistance and have helped districts secure nearly \$38 million dollars for technology resources and saved more than \$1.25 million dollars that might otherwise be spent on consulting fees for these programs. Chart 4 provides examples of the technology, connectivity and innovation that are available to support local school districts, schools and students.

### WVDE Data Collections Items and Respective Due Dates

Data collection is an integral part of each of the three service areas. Chart 5 provides a list of all ongoing data collections necessary for federal and state reporting - shown with the dates that these collections are completed by district stakeholders. Most of these data are entered and stored inside of WVEIS as student level data. From here, ZoomWV retrieves these data and makes it more accessible to end users by displaying it in secure and reliable aggregate public reports. These secure reports allow for better educational decision-making by West Virginia school administrators and educators. The data are kept secure by maintaining the data center infrastructure, which includes secure servers, routers, switches, filters, and firewalls.
