

Abandoning, dumping or depositing construction waste in public spaces (whose product of maximum length by maximum width and height is greater than 0.2 m³) may be sanctioned with a fine of 50,000 to 200,000 patacas.

Randomly disposal of construction waste at the Macao Refuse Incineration Plant or the Macao Special and Hazardous Waste Treatment Plant may be sanctioned with a fine of 1,000 patacas (in case the product of maximum length by maximum width and maximum height is equal or less than 0.2 m³) or from 50,000 to 200,000 patacas (in case the product of maximum length by maximum width and maximum height is greater than 0.2 m³).

The violation of the legal provisions regarding the prohibition and restriction of access to the ARMC (Construction Waste Landfill), the weighing and dumping of construction waste can be sanctioned with a fine of 1.000 patacas.
