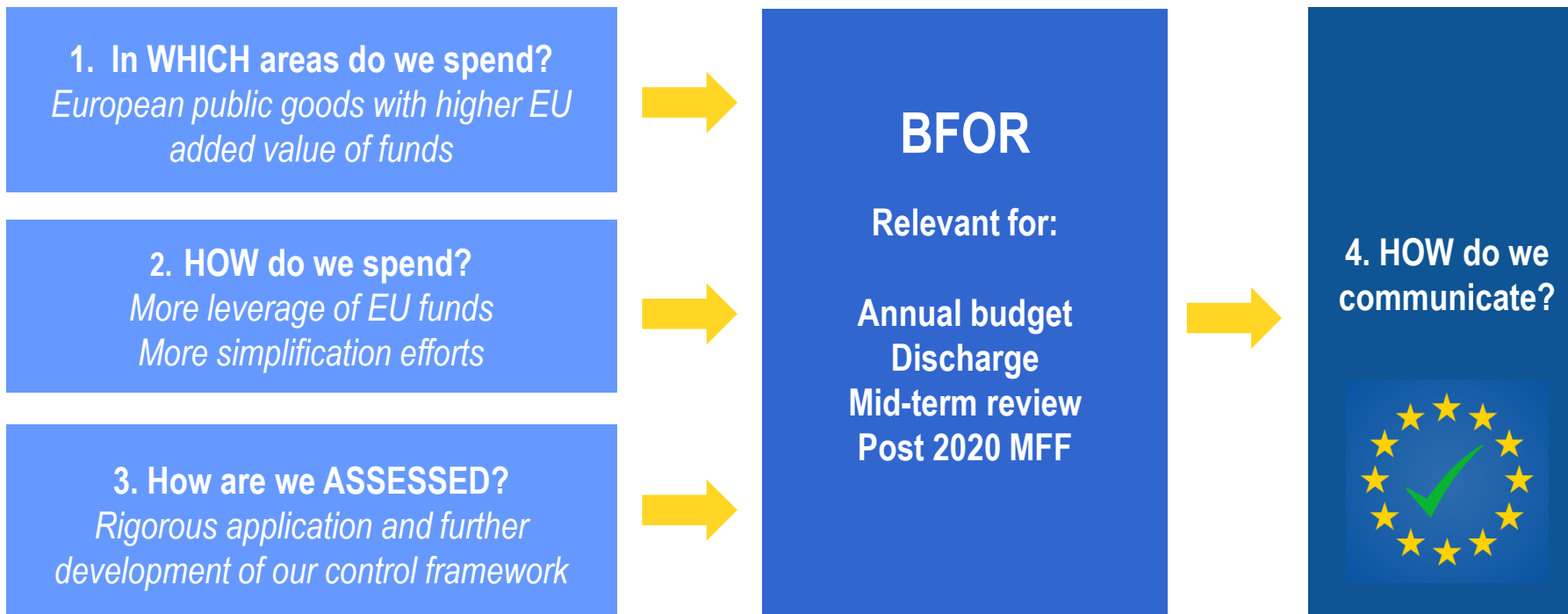

# 1. In WHICH areas do we spend?

European public goods with higher EU added value

- Higher amounts in key **growth and competitiveness** areas
- Multiple objectives: example **climate mainstreaming**
- **Flexibility** of the EU Budget to respond to the emergencies ( **i.e. migration**)



## 2. HOW do we spend?

More leverage of EU funds

More simplification efforts

- **A system to measure and communicate past performance**
- Higher **leverage** for EU money
- **Performance improvements in the new MFF 2014-2020:**
  - Reinforced link to **economic governance**
  - Programme **performance framework** + performance reserve
  - **Simplified** delivery system



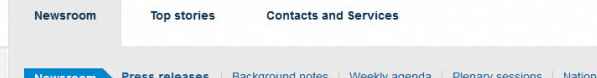
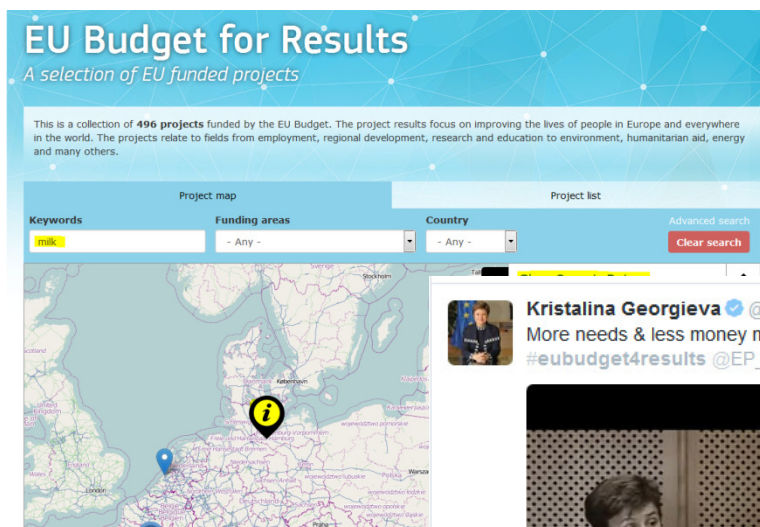
### 3. How are we ASSESSED?

#### Managing legality and risks

- The Commission has succeeded to stop the negative trend of rising error rates also thanks to the effective application of financial corrections.
- Possible action in case the level of error is still persistently high...
  - Further simplification
  - Additional cost-effective controls
  - Programme re-design
  - Deeper analysis of structural causes of errors in Member States

# Challenges

The Commission aims to improve budget management towards: a) focus on results, b) simplify the rules, c) correct & recover, d) good cooperation with Member States.

- How much can we expect from **indicators**?
- When does the **time factor** help or hinder performance management (e.g. long cohesion implementation times)?
- What is the **right trade-off between simplifying the rules and compliance**?
- To what extent **controls are effective in term of costs**?
- How can we improve the cooperation with the Member States?
