1. Draft Decision of the Government of the Republic of Armenia "On approving the Republic of Armenia Anti-Corruption Strategy and Implementation Action Plan for 2019-2022"

1. **Following the discussions, it was decided:** to assign Minister of Justice of the Republic of Armenia Rustam Badasyan:

- (1) to continue with interested state institutions and non-governmental organisations joint discussions on the draft Anti-Corruption Strategy, in accordance with the recommendations made during the sitting of the Council, and to refine it accordingly;
- (2) to submit the refined version of the draft Strategy during the next sitting of the Council.

- (2) to assign Minister of Justice of the Republic of Armenia Rustam Badasyan to continue with interested state institutions and non-governmental organisations joint discussions on the vision for and conceptual approaches to judicial and legal reforms, in accordance with the recommendations made during the sitting of the Council.
