Our students are able to investigate the similarities and differences among nations, cultures, and various social groups in order to understand how contemporary societies, and social issues around the globe evolve. Our programme provides in-depth insights into how society is built and maintained, using either quantitative methodology for investigating norms and values, or qualitative methodology for accessing the individuals' interpretations of their life-world.

Students get to engage into a sociological environment currently ranked among the Top-50 in the world (QS), with lecturers and fellow students from all over the world.

Our international faculty as well as Ronald F. Inglehart International Laboratory for Comparative Social Research at HSE offers our students the research environment for engaging into cross-cultural projects.

Beyond the classroom, our students conduct individually tailored research internships in either Russia or at one of our partner institutions aboard.

About the Programme

For many decades, the social sciences have rewarded narrow specializations in both topic and methodology, believing this to be the best way to achieve results. The established systems of higher education have also strongly supported this trend through the development of stand-alone departments and programmes. However, today, the task of addressing real-life economic, social, political and environmental issues and designing appropriate policy responses requires a combination of approaches and bodies of knowledge across different sciences and intellectual traditions. Problems like climate change, environmental degradation, crime, disease, policy failures, technologies running amok, loss of trust in institutions, etc. recognize no state borders, so the tradition of insulating disciplines, methodologies and geographic areas of expertise is harmful because it allows disciplinary biases and blind spots to obscure needed solutions.

The Master's Programme 'Politics, Economics, Philosophy' encourages students to do research into the political, economic, and moral dimensions of real-life social problems of various origins and to integrate tools and insights from the core disciplines in the Programme's name with an eye on changing the world for the better.

The Master's Programme 'Politics, Economics, Philosophy' offers two tracks.

The first – PEP – track reproduces the spirit and purpose of the Oxford-style 'Politics, Philosophy, and Economics' (PPE) programmes and offers a combination of classes in Political Science, Economics, and Philosophy.

'Russia in Comparative Perspective: Politics, Society, Cultures'. Previously track is designed by experienced Russian academics with an eye on the practical benefits of professional expertise in Russia coupled with a strong background in political science and other related scientific disciplines.

"Public Policy Analysis" track is focused on the sophisticated dimension of policymaking—an area where politics meets policy. Public policy is characterized by an ongoing search for the answers to the most burning

challenges in society, governance, and collective decision-making for the purpose of the public good. The goal of the track is to educate professional analysts capable of dealing with the complex public policy issues of the modern world. The track provides each student with a strong multi-disciplinary foundation of skills and knowledge and an opportunity to apply them to contemporary public policy issues.

The Programme offers bridging courses to help students fill in the gaps in their educational backgrounds.

Students are to write and defend term papers at the end of the first year of studies and Master theses at the end of the second year of studies.

Research and applied projects are an important part of the curriculum.
