## ORDER ON THE REGISTRAR'S APPLICATION PURSUANT TO RULE 45(E) OF THE RULES

On 21 March 2011, the Appeals Chamber ordered Haxhiu to reimburse the Tribunal the amount of 12,122.80 euros for the cost it sustained in providing him with legal counsel before the ICTY. This amount is to be paid within 30 days of the date of the notification of this order. Alternatively, he is allowed, if he so wishes, to pay such amount in two equal installments by, respectively, the 15<sup>th</sup> and 60<sup>th</sup> day following notification of the order.
