#### **DECISION ON ACCUSED'S THIRTY-SEVENTH TO FORTY-SECOND DISCLOSURE VIOLATION MOTIONS WITH PARTIALLY DISSENTING OPINION OF JUDGE KWON**

On 29 March 2011, the Chamber granted by majority the accused's motions (37<sup>th</sup>, 38<sup>th</sup>, 40<sup>th</sup>, 41<sup>st</sup> and 42<sup>nd</sup>) and found that the Prosecution had violated Rule 68 of the Rules with respect to those motions. Judge Kwon appended a dissenting opinion.
